 20 In accordance with Local Rule 144, Plaintiffs So Cal Top Guns, Inc., Safari Club  
 21 International, The United States Sportsmen’s Alliance Foundation, and Congressional  
 22 Sportsmen’s Foundation and Defendant Attorney General Rob Bonta, in his official capacity,  
 23 hereby stipulate to extend Defendant’s time to file a response to Plaintiffs’ Complaint for  
 24 Declaratory and Injunctive Relief, ECF No. 1 (Complaint), as follows:

- 25 1. Plaintiffs filed the Complaint in this action on August 5, 2022, and served Defendant  
 26 with the Summons and Complaint on August 22, 2022.  
 27 2. The Complaint challenges the constitutionality of California Business &  
 28 Professions Code section 22949.80 (“Section 22949.80”), added by Assembly Bill

1 2571, 2022 Cal. Stats., Ch. 77, § 2.

2 3. On August 31, 2022, the California Legislature passed Assembly Bill 160, a budget  
3 trailer bill that included amendments to Section 22949.80.

4 4. Defendant's response to the Complaint was initially due on September 12, 2022.  
5 Plaintiffs and Defendant stipulated to extend the time for Defendant file a response to the  
6 Complaint by 28 days, so that the response was due on October 10, 2022. The stipulation was  
7 filed in this action on August 29, 2022.

8 5. AB 160 was signed by Governor Newsom on September 29, 2022.

9 6. Due to the recent amendments to Section 22949.80, Defendant has requested, and  
10 Plaintiffs have agreed to, a ten (10) day further extension of time file a response to the Complaint,  
11 so that the response is due on October 20, 2022.
