I am writing this letter on behalf of Waiel ("Will") Anton who will soon be coming to your courtroom and before you for his sentencing.

My name is Mark Elvin and I was honored to have served on the San Diego County Sheriff's Department for 28.5 years from 1989 – 2017. My last assignment within the Sheriff's Department before retiring was as, the Undersheriff. I would like to take a moment to speak of the overall professional character and work-ethic of a person I met while I was working for the Sheriff's Department – his name is Will Anton. I understand that Will, within the past two to two-and-a-half years ago, may have made some poor decisions. I do not know all of the exact charges in which Will is facing in court – nor do I want to necessarily be informed of those charges. However, I would like to speak of the overall character, work-ethic, and man that I know Will Anton to be. I don't believe I've met a person as willing to give to others as Will Anton has. Will possesses an extreme work ethic in general, but especially when you focus on his work for the San Diego County Sheriff's Department, the Honorary Deputy Sheriff's Association (HDSA), and numerous public servants and other local community leaders.

I met Will Anton approximately 11 years ago and I was truly amazed at his willingness to help those in the community as well as those serving in local public servant roles. Will was always the first person to volunteer his personal time to help those within the Sheriff's Department, the HDSA, and as I mentioned public servants. Will was always available for others even when he had other responsibilities of his own. That is one of the things I admire the most about Will — Will owned two private businesses at the time (a to-go pizza business and a garage door company), yet he always seemed to have time to help others.

Dear Judge Curiel,

I am writing this letter on behalf of Waiel (Will) Anton who will come before you for sentencing.

My name is Amanda Anton. I am Waiel Anton's wife. We have been married for 6 years and we were friends for about 10 years prior to us getting married. Will truly has a heart of gold. He is funny and caring. He always has a smile on his face and is always making jokes to make everyone around him laugh. My husband and his family migrated to America 20 years ago. Since coming to America Will has always worked very hard to support his family. He worked at his uncles pizza shop and for a garage door company. It wasn't long until he took over the pizza shop and branched off to open his own garage door company. He also got into politics and quickly fell in love with it. He enjoyed all the people he met and represented. He was truly proud of all he did and accomplished in his career.

These past 3 & a half years have been a complete nightmare. Something I never thought not only I would have to go through, but something I never imagined my husband would go through. He always did everything right. He always wanted to be on the right side of everything he did. He proudly took care of our Church. He helped in any way our priest needed him and held many fundraisers for them. Every year he would go talk to the kids in catechism classes and guide them to make good choices and follow the path of God. He created sports for them to play. He has always had a passion and love to help others especially our youth. To know Will is to truly love him. He is a man of family and of God.

Not only was it a complete shock and a horrible experience getting raided the first time, but it was a nightmare going into labor and giving birth to my son in an ambulance alone. When he was born he was completely blue and not breathing. The paramedic worked on him what felt like forever to revive him. Our son Mason was on a ventilator for the first 2 days of his life. Aside from that I was in danger due to the placenta being in my body too long after delivery. When we arrived to the hospital a doctor and two nurses were waiting outside and quickly rushed my son to the nicu. I was rushed upstairs. I remember hearing nurses yelling to the doctor 'she's here, she's here!' I then saw a doctor running down the hall as they rushed me into the room to deliver the placenta as soon as possible. Will was completely distraught by all of this that occurred in one day. Our lives have been in turmoil since. I know his intentions were never to do anything wrong.

The agony of everything we have been put through has left us drained emotionally, physically, & mentally. Our children haven't had the opportunity to have the best of their parents. Our sons idol is their dad. They are truly obsessed and in love with Will. Especially our older son Luke. He is attached to his dad and hates going a minute

without him. After Will leaves for work everyday within a hour both boys say 'mommy it's taking forever for daddy to get home'. Since Will pleaded my heart has broken thinking what are they going to do and feel when their daddy is gone for a year? How am I going to make life normal for them without their dad when they can't go a day without him. Will has never left us for even one night. His whole world has always been revolved around me & our children.

In 2011 I got held up at gun point outside my home and suffered from anxiety and PTSD. In 2013 I lost my dad unexpectedly who was my best friend due to a massive heart attack. I suffered a deep depression. All of my anxiety and PTSD came back after this whole situation came about. The agony & anxiety I have felt since being raided has been unbearable. I couldn't sleep for days that turned into months because every time the cameras went off I feared it was the FBI coming again and I would have to grab my children to protect them from another nightmare. We have strong faith in God so I know whatever the outcome God will give me strength to take care of my kids, but being without my husband for a year seems unbearable with all I have endured.

My husband is truly a good person. Always wanting to help anyone and everyone he meets. He is full of laughter and love. He doesn't have a bad bone in his body. In all the years I have known him and been with him I have never seen him the way he is now. He is beyond exhausted and defeated. He has pleaded not because he knowingly or intentionally broke the law, but because he just wants to live his life normally again and give our kids a happy home again. We want to be able to take them on vacations and make beautiful memories to last a lifetime. We want their childhood to be filled with love and happiness not this pain and drainage that has taken over our lives.

Will's dream has always been to have kids and give them an amazing life. He grew up in Iraq with the war going on and still remembers the sounds of bombs going off and having to hide. All he has ever wanted was to give our children the best life and make memories with them he didn't get to have growing up. He is an amazing father who is fully involved in their lives and everything they do. He is supportive, caring, and actively engaged in all our children do. He is truly the best role model for our sons. He attends every sport game and every school event. He is their world.

I truly appreciate you taking the time to read my letter. I hope in your decision all of the good and amazing things about my loving husband come to your mind. I hope you feel the amazing dad he is and how much my children need their loving dad. God bless you and your family always.

Letter of Recommendation-Waiel Yousif Anton

Dear Judge Curiel:

My name is Schuyler Van Vechten Hoffman V, and I am a duly licensed attorney in good standing in the State of California since 2007. I write this letter today on behalf of my dear friend Waiel "Will" Anton with hopes that Your Honor will take into consideration the contents and honest sentiment herein at Mr. Anton's forthcoming sentencing hearing.

As background, I first had the pleasure and opportunity to meet Will through our interactions and collective efforts as members of the Honorary Deputy Sheriffs Association ("HDSA"). Founded in 1974, the Honorary Deputy Sheriff's Association is a prestigious organization of business, community leaders, and service-minded citizens dedicated to supporting law enforcement countywide. As a non-profit and non-political organization, the HDSA is unique as an ally of the Sheriff's Department and the County's nine police departments.

I first joined the HDSA in 2010, and over the past five years have served as "jurisprudence" for the HDSA Board. It was during that time, on or about 2016, with Will's appointment as the "law enforcement liaison" between the HDSA Board and SD Sheriff's Department, that I first had the opportunity to meet and begin work with Mr. Anton and suffice to say, we immediately became close friends. Will and I were (by a good margin) the youngest members of the HDSA Board. His tremendous energy and active involvement immediately injected a badly needed "shot in the arm" for the Association, and over the three following years, Will was awarded commendations for increasing HDSA membership and raising substantial capital. As a single of many possible examples I could provide, Will spent countless hours chairing the HDSA Annual Golf Tournaments that raised tens of thousands of dollars for the Association. And where did a good portion of those profits go?

In no small measure due to the efforts of Will, the HDSA was able to raise sufficient funds to donate several "TruNarc" devices (each at a cost of \$33,000.00) to assist and protect Sherriff Deputies in the field while performing searches of possible drug material containing the highly dangerous substance fentanyl. To give you an insight on just how dangerous this drug is, I would urge Your Honor to research online the recent incident that occurred in July of 2021 of fentanyl exposure involving San Diego County Sheriff's Deputy David Faiivae that nearly resulted in the death of the Deputy.

In my humble opinion, Will was one of the best and most valuable "Community Organizers" HDSA has ever had, and the Association has certainly suffered as a result of his loss. On many occasions, Will and I would meet during the day (or after hours) with other HDSA Board Members and active SD Sheriff Department staff to discuss the Department's financial needs and what the Association could do to better support and protect deputies in the field. And "yes" there were certainly occasions where Will and I would "argue" over who would pay the lunch or dinner check. But neither of us did so to "curry favor" with Department Staff, but rather offered (nay insisted) on doing so as an honest token of our appreciation for their service to our fine city. Will and I both share a deep admiration and appreciation for law enforcement and the tremendous sacrifices that are made by these dedicated deputies to ensure the protection and safety of our community and families.

I am unable to speak intelligently about the case before the court or the pending charges. The allegations set forth in the Department of Justice directly contradict in every sense of the word the "Will Anton" that I know. What I can say is that it breaks my heart and nearly brings me to tears to be writing this letter. The Will Anton that I KNOW is kind, generous, charismatic, hardworking, sincere, and civic-minded... A role model citizen who has dedicated his life not only to his family but also to giving back to our community. The HDSA is fortunate to have several older, wealthy donors who are in a financial position to write large checks. Others, like Will and I, who are much younger, own small companies, and are raising young families, don't have the luxury of offering sizable grant money, but what we can and did do was donate our time and energy to this important cause.

As a father of a seven-year-old daughter in my own right, I am still haunted with memories of the call I received on the day Will was arrested and placed in custody... the same (exact) day his second son, Mason was born prematurely, and rushed to the hospital in an ambulance when he stopped breathing for a period of over four minutes. Mason spent the next five days in intensive care, and I vividly recall the family's struggles that later ensued over the following months and years when Mason was unable to gain weight, and the anxiety that accompanied each and every trip to the pediatrician. The pain and agony that Will (and his family) suffered over that time (and throughout the course of this case) isn't something that I would wish upon my worst enemy.

The Government's charges and the subsequent, seemingly never-ending, pursuit by the FBI and DOJ into every aspect of his life, regardless of the relevance (including his mortgage loan applications of many years prior) have broken him. The Will Anton that I now see is only a shell of the person I once knew. His public reputation is ruined, and it is all he can do just to get out of bed in the morning, work a 12-hour day, six days a week, and put food on the table for his family. The "energy" and "spirit" he once exuded are gone. To sum it up: Will is a defeated man.

When sentencing Will, I would, humbly, ask the Court to strongly consider all the "good" that Mr. Anton has done for the San Diego community and the vital role he plays in supporting his family, as well as those of his employees. As human beings, we are all fallible and susceptible to making bad choices in the heat of the moment. And while I know that prior good deeds don't balance out the bad, please (please) take into consideration the man as a whole. The Government has gotten its "conviction" and has extracted its "pound of flesh." Will and his family have (already) paid a

truly terrible price and the impact of these events will forever leave an indelible scar on their lives. I, humbly, ask you to take mercy on my dear friend and grant him the opportunity to open a new chapter in his life.
