AMENDED ORDER OF
CRIMINAL FORFEITURE

16 On October 7, 2022, this Court entered its Order of Criminal Forfeiture, which
17 condemned and forfeited to the United States all right, title and interest of WAIEL
18 YOUSIF ANTON ("Defendant") in the following firearms and ammunition pursuant
19 to Title 18, United States Code, Section § 924(d) and Title 28, United States Code, §
20 2461(c):

- 21 a. One (1) Smith & Wesson 637 Revolver CAL:38 SN:CJA0175;
22 b. One (1) Smith & Wesson M&P Shield Pistol CAL:9
23 SN:HTM0972
24 c. One (1) Stag Arms Stag-15 Rifle CAL:556 SN:55483;
25 d. One (1) Century Arms International RAS47 Rifle CAL:762
26 SN:RAS47058200;
27 e. One (1) Beretta, Pietro S.P.A. APX Pistol CAL:9 SN:A000555X;

1 For thirty (30) consecutive days ending on November 13, 2022, the
 2 United States published on its forfeiture website, www.forfeiture.gov, notice of the
 3 Court's Order and the United States' intent to dispose of the firearms and ammunition
 4 in such manner as the Attorney General may direct, pursuant to 21 U.S.C. § 853(n)
 5 and Rule G(4) of the Supplemental Rules for Admiralty or Maritime Claims and
 6 Asset Forfeiture Actions, and further notifying all third parties of their right to
 7 petition the Court within thirty (30) days of the final publication for a hearing to
 8 adjudicate the validity of their alleged legal interest in the firearms and ammunition.

9 There were no potential third parties known to the United States to have
 10 alleged an interest in the forfeited firearms and ammunition. Therefore, no one was
 11 provided with direct notice of the forfeiture.

12 Thirty (30) days have passed following the final date of notice by publication
 13 and no third party has made a claim to or declared any interest in the forfeited
 14 firearm and ammunition described above.


15 Accordingly, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED
 16 that, as a result of the failure of any third party to come forward or file a petition for
 17 relief from forfeiture as provided by law, all right, title, and interest of WAIEL
 18 YOUSIF ANTON and any and all third parties in the following firearms and
 19 ammunition is hereby condemned, forfeited and vested in the United States of
 20 America:

- 21 a. One (1) Smith & Wesson 637 Revolver CAL:38 SN:CJA0175;
- 22 b. One (1) Smith & Wesson M&P Shield Pistol CAL:9
 23 SN:HTM0972
- 24 c. One (1) Stag Arms Stag-15 Rifle CAL:556 SN:55483;
- 25 d. One (1) Century Arms International RAS47 Rifle CAL:762
 26 SN:RAS47058200;
- 27 e. One (1) Beretta, Pietro S.P.A. APX Pistol CAL:9 SN:A000555X.

1 IT IS FURTHER ORDERED that the Bureau of Alcohol, Tobacco, Firearms,
2 and Explosives shall dispose of the forfeited firearms and ammunition according to
3 law.

4 IT IS SO ORDERED.
