**STIPULATION AND ~~PROPOSED~~
ORDER TO EXTEND TIME TO
FILE SUMMARY JUDGMENT
MOTIONS AND MOTIONS
DIRECTED AT EXPERTS**

WHEREAS, pursuant to the Fifth Revised Scheduling Order, the deadline for filing the Note of Issue was November 29, 2022, and the deadlines for filing dispositive motions and/or motions directed to experts is January 20, 2023;

WHEREAS, the Court thereafter extended the date for filing the Note of Issue until December 13, 2022 and the deadline for filing dispositive motions and/or motions directed to experts to February 3, 2023 (NYSCEF 900);

WHEREAS, the Court held a telephonic conference on December 13, 2022 at which, the Court (a) extended the date for filing the note of issue and certificate of readiness in this action from December 13, 2022 to December 23, 2022 (NYSCEF 997) and Plaintiff filed the same on December 22, 2022; (b) orally agreed that the date for filing motions for summary judgment should similarly be extended from February 3, 2023 to February 10, 2023; and (c) agreed that motions directed at experts should be extended so that they are not due on the same date as motions for summary judgment, but the scheduling determinations made at the conference were not reflected in an order;

WHEREAS the parties to this action, by and through their respective counsel, have agreed that the date for filing motions directed to experts, if any, should be extended to March 3, 2023;

IT IS HEREBY STIPULATED AND AGREED that the Fifth Revised Scheduling Order is amended to the extent that the (a) date for filing motions for summary judgment, if any, is extended from February 3, 2023 to February 10, 2023 and (b) the deadline for motions directed to experts is extended to March 3, 2023 or such other date as may be set by the Court; and

IT IS FURTHER STIPULATED AND AGREED that this stipulation can be executed in counterparts and by using electronic, scanned or telefaxed signatures, with the same effect as original signatures.
