had a hand in that destruction.

Freddy Magaña's 19-year law enforcement career with the San Diego Sheriff's Department (SDCSD) spanned from January 2002 until May 2019³. Yet, on November 22, 2019, as he endured that fateful day when he was arraigned on the Indictment, Freddy Magaña's disciplined dedication, hard work, and dreams came crushing down. Tragically, there was no other option for him at that time, other than to plead guilty to a felony offense. The case and the results would turn out to have a protracted history with proceedings lasting even up to today.

Exacerbating his agonizing pain and public shame, Freddy, and his law enforcement officer wife, had to endure even more pain that same day.

After Freddy Magaña went home from the shame of that public arraignment, the guilty plea process, the (to a cop) humiliating book-andrelease process, a representative from the SDCSD – at that time Lieutenant Michael Knobbe - was insistently telephoning him. Like a telemarketer would have called. Even as Freddy and his wife were emotionally crushed, desperately trying to recover from the deep psychological and emotional shock of having his career destroyed.

Lieutenant Knobbe was insisting that he needed to meet Freddy Magaña "immediately." And so, he demanded that Freddy meet him later that afternoon at the Chula Vista Police Department parking lot "to get equipment from him and accept process." By then, it was late in the day.

The undersigned immediately contacted the SDCSD's legal counsel to offer acceptance of service of process urging that the matter could wait until the following day. This was normally a routine matter among lawyers. Legal counsel for the SDCSD agreed with the undersigned. But that insensitive unmoved representative, pressing as infamous Inspector Javert, persisted.

The reason for this insistence was to unceremoniously hand Freddy Magaña the documents for his formal discharge from the SDCSD. That representative just could not wait to add to the shame already publicly displayed and endured by Freddy Magaña and his wife.

At that fateful point, in that Chula Vista parking lot, Freddy Magaña's exemplary law enforcement career with the SDCSD continued to be disproportionately destroyed then at the hand of that representative. No consideration was made by that representative to simply wait until the following day. No consideration was made to hand the termination notice to the undersigned. No considerations were made like those given before and <u>after to former SDCSD Captain Garmo – only written reprimands, even as *Fred Magaña's Sentencing Memorandum*, U.S. v. Magaña, Case No. 19CR4768-GPC</u> the San Diego District Attorney had investigated the same illicit conduct by him and for which Garmo was eventually indicted here. No, Freddy Magaña did not have any of those same considerations from the SDCSD.

The Court was able to witness firsthand former Lt. Magaña's honorable, disciplined character when he forthrightly testified at trial. As he testified, Lt. Magaña was unflappable; his testimony favored no side. He was candid; he was truthful. Even if the giving of that public testimony was personally painful to him. He did so with dignity.

But his decade-long law enforcement service was also destroyed. And the personal and professional price he and his family paid for his atypical, admittedly unlawful actions, can be sincerely said to have been disproportionate to his crimes. The disproportionality of his accountability, when contrasted with that of his Co-defendants, was too high a price to extract from him. Yet, he accepted that severe consequence honorably.

Now, returned from that agonizing personal Odyssey, former Lt. Magaña takes some solace in the unanimous sentencing recommendations from Probation Officer Jill Johnson-Pogue⁴ and from the Government. Each recommends no custody need be added to the heavy price former Lt. Magaña

has already paid. The stripping away of his 19-year law enforcement career with the SDCSD is more than enough. And, because Freddy has been in pretrial supervision for over three years now - since November 22, 2019 - the Government is also expected to recommend no further supervision.

Freddy Magaña respectfully asks the Court to accept the unanimous recommendation of the Government and Probation for no custody. He also asks for no additional time of supervision and no fine - this case has already cost Freddy Magaña substantial loss of income and savings.

T. What Destroyed Former Lieutenant Magaña's Exceptional Law Enforcement Career - The Sum and Substance of His Offense Conduct.⁵

The actions for which former Lieutenant Magaña's career was destroyed have already been accurately captured in the Presentence Report (PSR). This Court also directly witnessed his direct and cross-examination at trial wherein he forthrightly admitted all of his criminal acts.

The specific context for the unlawful actions attributed to Freddy Magaña in this case, very accurately captured in the PSR, is the following:

> After GARMO's formal reprimand in February⁶ 2017, GARMO supplied HAMEL with a new "straw"

purchaser, MAGANA, a Lieutenant with SDCSD, who was directly supervised by GARMO. The arrangement was documented through text messages obtained during a search warrant of GARMO's telephone. GARMO confirmed with HAMEL which guns HAMEL wanted to purchase and GARMO would text the requests to TILOTTA at Honey Badger Firearms. GARMO told TILOTTA that the guns were for MAGANA.

PSR, paragraph 47, page 11, emphasis added. And after almost two decades

of exemplary loyal service to the community with the SDCSD, former

Lieutenant Magaña atypically did the following for hen Captain Garmo:

During the investigation [of former SDCSD Captain Marco Garmo], it was determined that MAGANA assisted in GARMO's firearms trafficking by making a straw purchase *of two firearms for HAMEL*, at GARMO's direction.

Id., emphasis added. Freddy Magaña facilitated the straw purchase of two

firearms.

There was some additional conduct attributed to former Lt. Magaña:

Text messages were recovered between MAGANA and GARMO, which determined the two had a close relationship. GARMO told MAGANA that he owed him (MAGANA) and MAGANA suggested that GARMO provide him a list of stuff GARMO wanted to sell and MAGANA would "pimp it out to his homies and keep your name (GARMO) out of it until they were ready to pull the trigger." GARMO provided MAGANA with a list of firearms he (GARMO) was trying to sell, while GARMO and MAGANA discussed prices GARMO was willing to accept. Despite the

messages, MAGANA's actual efforts to advertise GARMO's firearms were minimal.

PSR, pages 11-12, paragraph 50, emphasis added. Yes, even according to Probation officer Johnson-Pogue, Freddy Magaña's efforts to help Garmo further "were minimal."

These acts constitute the sum and substance of the criminal actions in the case by Freddy Magaña. The actions that led to the destruction of his 19year career with the SDCSD and proud service to the San Diego community. Significantly, Probation Officer Johnson-Pogue recommends a minor role reduction to reflect Freddy Magaña's mitigated role in this case:

Adjustment for Role in the Offense: During this offense, MAGANA worked at the direction of GARMO and agreed to purchased two firearms in his name, which would later be transferred to HAMEL. MAGANA did not purchase these firearms for his personal use and knew that the firearms were for another individual. MAGANA agreed to provide this favor to his then direct supervisor, GARMO. There is no evidence the defendant was the leader or organizer in this offense but that *he had limited involvement* and participation in this scheme. Therefore, a minor role adjustment pursuant to USSG 3B1.2(b) would apply at this juncture.

PSR at page 15, paragraph 72, emphasis added. Freddy Magaña respectfully ask the Court to grant Probation Officer Johnson-Pogue's fact-based recommendation for minor role.

defendant received 98. Additionally, the two meritorious unit citations, exemplary performance accommodations, letters of commendation, 2009 Auto-theft Recovery Office of the Year at the Poway Station, and two arrests of the month at the Poway Station.

Officer Johnson-Pogue also notes:

The defendant provided copies of his performance evaluations, which indicated that MAGANA had strong connections to law enforcement and the *community*. He delegated work appropriately, mentored others, praised his staff, and was eager to learn new responsibilities. The defendant was involved in a variety of *community* programs and maintained a positive spirit, despite a difficult workload.

The first certificate, Exhibit A, from the County of San Diego Sheriff,

But Freddy Magaña blames no one for his deliberate actions. Conclussion

When Freddy Magaña tendered his guilty plea, and when he was discharged from the Sheriff's Department, San Diego County lost a great cop. Coordination had to be conducted for communications, off road enforcement teams, mobile field force (MFF) activation, mobile booking, and Sheriff's Special Enforcement Detail deployment. To ensure proper information sharing and task monitoring, operational briefings were conducted with MFF and Unified Command partners.

Due to the dedication and efforts of those involved, the visit was a success. It was managed well with no arrests, no uses of force, and no injuries to law enforcement or the public while ensuring the citizen's 1st amendment right to speech and the safety of the President of the United States.

Fred Magaña Exemplary Performance

On January 13, 2017 at approximately 1509 hours, Lieutenant Fred Magaña along with Team 4 Patrol Deputies responded to investigate a report of shots fired at a location in Spring Valley. When he arrived he contacted a witness, who stated the landlord to the building had been shot and was lying down in the open doorway of an apartment. Believing the victim may still be alive, Lieutenant Magaña formulated a rescue plan to retrieve the victim as quickly as possible. Believing an active threat was still at large inside the apartment, the plan was initiated. Lieutenant Magaña and deputies approached the open apartment with ballistic shields and lethal coverage. The victim was removed from inside the apartment and carried to waiting paramedics who began lifesaving measures.

As more information was forthcoming about the incident, it was believed one or two more victims were inside the apartment. A second rescue plan was formulated and enacted. A Deputy along with his K-9, off leash, cleared the apartment one room at a time which allowed Lieutenant Magaña and Team 4 to enter and secure the residence. A search was conducted and two additional lifeless subjects were located in a bedroom.

Lieutenant Magaña should be commended for his courage in initiating and conducting two separate rescue attempts, in order to preserve human life with the knowledge that an active shooter may be waiting in ambush.

Lieutenant Magaña continues to set the example for his subordinates while exemplifying the high values we continually strive to achieve. Therefore, it is with great pride; I hereby award Lieutenant Fred Magaña the Sheriff's Letter of Exemplary Performance.

LETTER OF COMMENDATION

FRED MAGANA

On September 25, 2012, deputies from the Santee Sheriff's Station conducted an investigation involving child molestation. The suspect was a resident of Lakeside living with his girlfriend and her two daughters. During the investigation, deputies developed strong evidence against the molestation suspect. Deputies from the Santee Sheriff's Station and a Detective from the Child Abuse Detail responded to the suspect's residence to arrest the subject. Sergeant Craig Johnson, Detective Ali Perez and Deputy Mike Spears attempted to contact the suspect at the front door to the residence.

Because of exigent circumstances, Detective Perez forced entry into the apartment and was met with a barrage of gunfire. Perez was shot by the suspect and fell to the ground in the apartment. During this time, Sergeant Johnson was shot through his ballistic vest in his upper body and left arm. Sergeant Johnson and Deputy Spears returned gunfire with the suspect and were trapped on the upstairs landing. Spears and Johnson were forced to withdraw from the area as they continued to engage the suspect with gunfire. During this time, they entered an adjacent apartment and withdrew to the back of the apartment for cover.

Numerous law enforcement officers throughout the county responded to the incident and assisted their comrades with an active shooter and deputies in need of rescue. Ultimately, Detective Perez, Sergeant Johnson and Deputy Spears were rescued from the area. Additionally, the suspect was taken into custody. Both Detective Ali Perez and Sergeant Johnson were transported to the hospital and survived their life threatening injuries.

Detectives and deputies from specialized units responded to help. They assisted in crime scene preservation and aided in organizing the investigation. They conducted critical interviews with key witnesses including law enforcement witnesses that were involved in the rescue of their fallen comrades. Every interview became extremely important to the success of the investigation and the future prosecution of the suspect. These experienced detectives demonstrated exceptional job performance, which materially contributed to the Department's mission.

It is with great pleasure that I present Detective Fred Magana with the Sheriff's Letter of Commendation for his outstanding performance displayed under such an emotional and trying event.
