9 **WHEREAS**, on October 3, 2023, this Court issued an order (Dkt. No. 16)  
10 coordinating this case and *Carralero, et al., v. Bonta*, Case No. 8:23-cv-01798-  
11 CJC-ADSx (the *Carralero* Action), in “the interests of judicial economy and  
12 efficiency”;

13 **WHEREAS**, the Parties in this Action (as well as those in the *Carralero*  
14 Action) believe that those interests would be best served by Defendant filing a  
15 single opposition brief of 17,500 words, and the same declarations in support  
16 thereof, in response to the motions for preliminary injunction filed in both cases;

17 **WHEREAS**, the Parties in this action further agree, in light of the pending  
18 Motion for Preliminary Injunction and the efforts needed from Defendant to oppose  
19 it, that, with the Court’s approval, Defendant’s deadline to answer or otherwise  
20 respond to Plaintiffs’ complaint should be continued until 21 days after a ruling  
21 from this Court on the Motion for Preliminary Injunction;

22 **NOW THEREFORE, IT IS HEREBY STIPULATED AND AGREED** by the  
23 Parties that, with the Court’s permission:

- 25 • Defendant shall file a single opposition brief, with a 17,500-word limit, in  
26 response to the motions for preliminary injunction filed in both cases;
