2 PLEASE TAKE NOTICE THAT Plaintiffs in this matter, in addition to their
3 own reply brief and supporting documents (ECF No. 29 through 29-16), hereby join
4 the reply brief filed by the plaintiffs in the matter of *Carralero et al. v. Bonta* (C.D.
5 Cal. Case No. 8:23-cv-01798, ECF No. 29).

6 Both the Plaintiffs in this matter as well as the *Carralero* Plaintiffs seek to
7 enjoin several portions of California Penal Code Section 26230(a) prior to its
8 operative date of January 1, 2024. While some of the challenged portions of Section
9 26230(a) differ from case to case, both sets of Plaintiffs challenge subs. (7), (8),
10 (9), (12), (13), (17), and (26). Moreover, the two cases have been coordinated, and
11 the respective motions for preliminary injunction are set for hearing on December
12 20, 2023. ECF No. 17. Finally, Defendant filed a unified opposition to both
13 motions. ECF No. 21. Joinder with the *Carralero* reply brief is thus appropriate
14 here.


