I am a current resident of Los Angeles County, California and reside within 5 the City of La Verne. 6 3. I am a law-abiding adult who is not prohibited from owning firearms under 7 the laws of the United States of America or the state of California. I am a member 8 of the California Rifle & Pistol Association, another plaintiff in this matter. 9 4. I have owned and trained with firearms for most of my life. 10 5. Encouraged by the Supreme Court's ruling in Bruen, I decided it was time to 11 obtain a CCW permit. Unfortunately, the exorbitant fees La Verne charges have 12 dissuaded me from applying. I am self-employed and have a son in college, so an 13 extra \$1,000 expense is too much for me at this time. I am thus priced out of a 14 constitutional right. 15 6. On principle, I also do not want to subject myself to the psychological 16 examination requirement, something that most issuing authorities in California 17 (including LASD) do not require. 18 7. I hope this Court will force La Verne to reduce its fees and drop its 19 psychological examination.
