Plaintiff Ana Patricia Fernandez, through her counsel, brings this action against Defendants Los Angeles County, the Los Angeles County Sheriff's Department, Deputy Wyatt Waldron, Detective John Roth, Susan O'Leary Brown, Richard Leon, Murray Jacob, David Roach, Salvador Moreno IV, Jason Ames, Kyle Dingman, Nicholas Saylor, and Sheriff Alex Villanueva, in his official capacity, and makes the following allegations:

#### **JURISDICTION AND VENUE**

- 1. The Court has original jurisdiction of this civil action under 28 U.S.C. § 1331, because the action arises under the Constitution and laws of the United States, thus raising federal questions. The Court also has jurisdiction under 28 U.S.C. § 1343(a)(3) and 42 U.S.C. § 1983 since this action seeks to redress the deprivation, under color of the laws, statutes, ordinances, regulations, customs and usages of the state of California and political subdivisions thereof, of rights, privileges or immunities secured by the United States Constitution and by Acts of Congress.
- 2. Plaintiff's claim for declaratory relief is authorized by 28 U.S.C. § 2201, and her claim for attorneys' fees is authorized by 42 U.S.C. § 1988.
- 3. Venue in this judicial district is proper under 28 U.S.C. § 1391(b)(2), because the entirety of the events or omissions giving rise to Plaintiff's claims occurred in this district.
- 4. Plaintiff submitted a Government Tort Claim form to the county of Los Angeles on February 24, 2020. The county served its rejection of Plaintiff's claim on April 28, 2020, giving Plaintiff until October 28, 2020 to bring this action under California Government Code § 945.6.

#### **PARTIES**

- 5. Plaintiff Ana Patricia Fernandez is a resident of Los Angeles County, California, and a law-abiding citizen of the United States who is not prohibited from owning firearms. She is the widow of Manuel Fernandez and the Trustee of the Fernandez Trust.
- 6. Defendant County of Los Angeles ("the County") is, and at time relevant hereto was, a political subdivision of the United States, organized and existing under the laws of

the state of California, with its principal place of business in this judicial district. The County legally responsible for the operation of the Los Angeles Sheriff's Department pursuant to official decision-making channels, in policy, practices, customs, or law.

- 7. Defendant Los Angeles County Sheriff's Department ("LASD") is a local government entity created under the laws of the state of California and an agency of defendant County of Los Angeles. LASD is a political subdivision of Defendant County. LASD oversees the storage of firearms recovered or seized by its personnel in Los Angeles County, and also enforces the administrative fee required by Defendant County for the return of recovered or seized firearms to their lawful owners.
- 8. Defendant Alex Villanueva is an employee of Defendant County of Los Angeles and currently holds the title of Sheriff of LASD. Defendant Villanueva is, and at all times relevant to this complaint was, one of the ultimate policy makers for Defendant LASD. He is directly responsible for promulgating, enforcing, and continuing the policies of the LASD, including the unlawful policies and procedures complained of herein. Villanueva is sued solely in his official capacity.
- 9. Defendant Wyatt Waldron is, and at all times relevant to this complaint was, employed by Defendant LASD. He currently holds the title of "Deputy." Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Waldron was acting in the course and scope of his employment with Defendant LASD. And he is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- 10. Defendant John M. Roth is, and at all times relevant to this complaint was, employed by Defendant LASD. He is, and all times relevant to this complaint was, employed as a "Detective." Plaintiff is informed and believes, and on that basis alleges that, in his role as detective, Defendant Roth investigated whether Plaintiff's seized firearms were lawful to possess, requiring that he handle and inspect the firearms, and at some point, damaged Plaintiff's property. Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Roth was acting in the

- 11. Defendant Susan O'Leary Brown is, and at all times relevant to this complaint was, employed by Defendant LASD. She is, and at all time relevant to this complaint was, employed as a Property Custodian at the Palmdale Sheriff Station, where Plaintiff's firearm property was stored for at least some of the time it was in the custody of Defendant LASD. Defendant O'Leary Brown informed Plaintiff of the LASD Palmdale Station's price list (\$54 per firearm) and LASD's general policy that the prices reflected on the price list must be paid before the firearms could be released to Plaintiff. Defendant O'Leary Brown also coordinated with Plaintiff regarding the release of her firearms, which eventually occurred at the Palmdale Sheriff Station. Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant O'Leary Brown was acting in the course and scope of her employment with Defendant LASD. And she is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- 12. Doe 1, who has now been identified as Defendant Richard Leon is, and at all times relevant to this complaint was, employed by Defendant LASD. Plaintiff is informed and believes, and on that basis alleges that, in his role as an employee of Defendant LASD, Defendant Leon handled and at some point damaged Plaintiff's property. Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Leon was acting in the course and scope of his employment with Defendant LASD. And he is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- 13. Doe 2, who has now been identified as Defendant Murray Jacob is, and at all times relevant to this complaint was, employed by Defendant LASD. Plaintiff is informed and believes, and on that basis alleges that, in his role as an employee of Defendant LASD, Defendant Jacob handled and at some point damaged Plaintiff's property.

- Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Jacob was acting in the course and scope of his employment with Defendant LASD. And he is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- Doe 3, who has now been identified as Defendant David Roach is, and at all times relevant to this complaint was, employed by Defendant LASD. Plaintiff is informed and believes, and on that basis alleges that, in his role as an employee of Defendant LASD, Defendant Roach handled and at some point damaged Plaintiff's property. Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Roach was acting in the course and scope of his employment with Defendant LASD. And he is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- 15. Doe 4, who has now been identified as Defendant Salvador Moreno IV is, and at all times relevant to this complaint was, employed by Defendant LASD. Plaintiff is informed and believes, and on that basis alleges that, in his role as an employee of Defendant LASD, Defendant Moreno handled and at some point damaged Plaintiff's property. Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Moreno was acting in the course and scope of his employment with Defendant LASD. And he is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- Doe 5, who has now been identified as Defendant Jason Ames is, and at all 16. times relevant to this complaint was, employed by Defendant LASD. Plaintiff is informed and believes, and on that basis alleges that, in his role as an employee of Defendant LASD, Defendant Ames handled and at some point damaged Plaintiff's property. Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Ames was acting in the course and scope of his employment with Defendant LASD. And he is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.

- 17. Doe 6, who has now been identified as Defendant Kyle Dingman is, and at all times relevant to this complaint was, employed by Defendant LASD. Plaintiff is informed and believes, and on that basis alleges that, in his role as an employee of Defendant LASD, Defendant Dingman handled and at some point damaged Plaintiff's property. Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Dingman was acting in the course and scope of his employment with Defendant LASD. And he is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- 18. Doe 7, who has now been identified as Defendant Nicholas Saylor is, and at all times relevant to this complaint was, employed by Defendant LASD. Plaintiff is informed and believes, and on that basis alleges that, in his role as an employee of Defendant LASD, Defendant Dingman handled and at some point damaged Plaintiff's property. Plaintiff is informed and believes, and on that basis alleges that, at all times relevant to this complaint, Defendant Dingman was acting in the course and scope of his employment with Defendant LASD. And he is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- 19. Doe 8, whose identity is not yet known to Plaintiff, is, and at all times relevant to this complaint was, employed by Defendant LASD. Plaintiff is informed and believes, and on that basis alleges, that Doe 7 was employed as a property custodian at LASD's Whittier warehouse, or was employed in another similar role that involves overseeing property at that warehouse, where Plaintiff's firearms were stored. Plaintiff is informed and believes, and on that basis alleges, at all times relevant to this complaint, Doe 7 was acting in the course and scope of their employment with Defendant LASD. And he or she is, and was at certain times identified below, acting under color of state law within the meaning of 42 U.S.C. § 1983.
- 20. The true names or capacities—whether individual, corporate, associate, or otherwise—of the Defendants named herein as Does 9-20, are presently unknown to Plaintiff, and are therefore sued by these fictitious names. Plaintiff prays for leave to

amend this Complaint to show the true names or capacities of these Defendants if and when they have been determined. Such additional Defendants could include individuals who were responsible for the damage caused to the firearms, or officials responsible for imposing the excessive fine on Plaintiff.

#### **FACTUAL ALLEGATIONS**

#### [Right to Be Free from Unreasonable Seizures]

- 21. The Fourth Amendment to the United States Constitution provides in part that "[t]he right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated."
- 22. "A 'seizure' of property . . . occurs when 'there is some meaningful interference with an individual's possessory interests in that property.' "Soldal v. Cook County, 506 U.S. 56, 61 (1992) (quoting *United States v. Jacobsen*, 466 U.S. 109, 113 (1984)).
- 23. "The destruction of property is 'meaningful interference' constituting a seizure under the Fourth Amendment, *Jacobsen*, 466 U.S. at 124-25; *Bonds v. Cox*, 20 F.3d 697, 701-02 (6th Cir. 1994), because the destruction of property by state officials poses as much of a threat, if not more, to people's right to be "secure . . . in their effects" as does the physical taking of them." Indeed, "[1]aw enforcement activities that unreasonably damage or destroy personal property, thereby 'seizing' it within the meaning of the Fourth Amendment, may give rise to liability under § 1983." "*Newsome v. Erwin*, 137 F. Supp. 2d 934, 941 (S. D. Ohio 2000).
- 24. Further, it is well established that "[a] seizure lawful at its inception can nevertheless violate the Fourth Amendment because the manner of execution unreasonably infringes possessory interests protected by the Fourth Amendment[.]" *United States v. Jacobsen*, 466 U.S. 109, 124 (1984) (citing *United States v. Place*, 462 U.S. 696, 707-10 (1983)). Indeed, "[a] seizure is justified under the Fourth Amendment only to the extent that the government's justification holds force. Thereafter, the government must cease the seizure or secure a new justification." *Brewster v. Beck*, 859 F.3d 1194, 1197 (9th Cir. 2017). If it cannot, a seizure reasonable at its inception becomes

an unreasonable one. Id. at 1196-97.

#### [Right to Be Free from Excessive Fines]

- 25. The Eighth Amendment to the United States Constitution states: "Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted." U.S. Const., amend. VIII. This amendment prohibits the federal government from imposing unduly harsh penalties on criminal defendants.
- 26. The Supreme Court of the United States recently ruled that the Eighth Amendment right to be free from excessive fines is incorporated against the states through the Fourteenth Amendment. *Timbs v. Indiana*, -- U.S. --, 139 S. Ct. 683 (2019).
- 27. "A forfeiture is unconstitutionally excessive 'if it is grossly disproportional to the gravity of a defendant's offense.' "*United States v. Viloski*, 814 F.3d 104, 110 (2d Cir. 2016) (quoting *United States v. Bajakajian*, 524 U.S. 321, 334 (1998)).
- 28. As the Supreme Court held in *Austin v. United States*, 509 U.S. 602, 610 (1993), "a civil sanction that cannot fairly be said *solely* to serve a remedial purpose, but rather can only be explained as also serving either retributive or deterrent purposes, is punishment, as we have come to understand the term." (emphasis added.)

### [State Law and the County's \$54 Firearm Storage Fee]

- 29. Under California law, cities, counties, and state agencies "may adopt regulation[s], ordinance[s], or resolution[s] imposing a charge equal to its administrative costs relating to the seizure, impounding, storage, or release of any firearm, ammunition feeding device, or ammunition." Cal. Penal Code § 33880(a).
- 30. Any fee set by local authorities to recover these costs, however, "shall not exceed the actual costs incurred for the expenses directly related to taking possession of a firearm, storing the firearm, and surrendering possession of the firearm to a licensed firearms dealer or to the owner." Cal. Penal Code § 12021.3 (repealed and superseded by

the similarly phrased Cal. Penal Code § 33880 in 2012).<sup>1</sup>

- 31. On November 22, 2005, relying on then-section 12021.3, the Los Angeles County Board of Supervisors adopted a \$54 per-firearm "administrative fee" to "recover the costs of the seizure, storage and return of a firearm."
  - 32. The County does not charge a storage fee for non-firearm items to be returned.
- 33. In a letter to the Board in support of the fee's enactment, then-Sheriff Leroy D. Baca stated that several different classifications of LASD personnel are involved in the processing of firearms, from the initial booking to the storage and release.
- 34. A cost breakdown attached to Sheriff Baca's letter alleged that, for each firearm seized, a deputy spends about 20 minutes "booking" the firearm, a station clerk spends about 5 minutes entering information to DOJ/AFS databases, an evidence custodian then spends about 5 minutes verifying that the information was correct, about 20 minutes updating records and preparing the firearm for release from the station, and then 5 more minutes preparing to transfer the property to Central Property and Evidence.
- 35. According to then-Sheriff Baca's cost breakdown, at the Central Property and Evidence Unit, another evidence custodian spends about 10 minutes verifying information and storing each firearm and a typist clerk spends about 5 minutes entering information into an unspecified "database."
- 36. According to then-Sheriff Baca's cost breakdown, to prepare a gun for release from Central Property, an evidence custodian spends approximately 10 minutes verifying and updating records and a typist clerk spends another approximately 10 minutes updating "databases."
  - 37. According to then-Sheriff Baca's cost breakdown, all this work adds up to a

- 38. Then-Sheriff Baca also wrote that "an analysis of firearms evidence processing over a four-year period revealed that potentially 500 guns per year would be eligible for the administrative fee" and that "[a] \$54 fee would yield additional revenue of approximately \$27,000 each year."
- 39. Per California Penal Code section12021.3, a fee cannot exceed the *actual* costs an agency *directly* incurs related to the firearm seizure, storage, and return. In passing the fee, the Board of Supervisors expected that about 500 firearms *in total* would be subject to the fee annually. It is thus clear that the County's administrative fee, as calculated, was never intended to apply to a firearm collection of hundreds of firearms seized from a single firearm owner. It was mainly contemplating the seizure of either individual firearms or small collections from many different sources.
- 40. Under both the original California Penal Code section 12021.3, and the newer section 33880, enactment and enforcement of the administrative fee is discretionary. Localities do not have to impose a fee, and if they do, they may waive it for those claiming recovered firearms that were reported stolen, illustrating that the statute recognizes that the fee may be inappropriate when levied against blameless victims of firearm theft.
- 41. Other localities have imposed only the DOJ fee that lessens for each additional firearm.
- 42. For example, according to their website, the city of Redondo Beach charges only the California DOJ fee under the Law Enforcement Gun Release (LEGR) Program of \$20 per firearm, with the fee for the release of each subsequent firearm being just an additional \$3. It charges no fee beyond that, and if the firearms are released directly to an FFL, then even that fee is not charged. *See* City of Redondo Beach, Recover Firearms,

### [Defendants' Handling of Plaintiffs' Firearms & Resulting Damage]

- 43. Plaintiff's deceased husband, Manuel Fernandez, was prohibited from owning firearms, ammunition, magazines, and speed loaders due to prior felony convictions stemming from 2009.
- 44. According to an investigation report by Special Agent Alvaro Arreola, the California Department of Justice Bureau of Firearms' database Armed Prohibited Persons (APPS) identified Mr. Fernandez as a prohibited person potentially in possession of firearms.
- 45. The APPS database indicated that Mr. Fernandez had purchased 41 firearms before becoming prohibited, and that there was no record existed that any of them had been transferred from his possession after his felony conviction.
- 46. According Mr. Arreola's report, the Federal Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) received an anonymous tip on May 30, 2018, indicating that Mr. Fernandez was in possession of a large collection of firearms. The same tip was also received by Defendant LASD on or around June 10, 2018.
- 47. On June 11, 2018, Defendant Deputy Wyatt Waldron presented a statement of probable cause to the Los Angeles Superior Court, and the Honorable Judge Lisa Chung issued a warrant for the search of Mr. Fernandez's residence.
- 48. On June 14, 2018, Defendants Waldron, Roth, and Does 8-20 executed the search warrant at Mr. Fernandez's residence.
- 49. During the course of the June 14, 2018 search, Defendants Waldron, Roth, and Does 9-20 discovered Mr. Fernandez's firearm collection. They arrested Mr. Fernandez and seized more than 400 firearms.
- 50. On information and belief, Plaintiff alleges that Defendants Waldron, Roth, and Does 8-20 damaged Plaintiffs' firearms either during the execution of the warrant and

- 51. Under separate warrants, Defendants Waldron, Roth, and Does 8-20 executed three later searches of the Fernandez property on June 15, 2018, June 21, 2018, and June 29, 2018. These later searches resulted in the seizure of dozens more firearms, as well as ammunition magazines and speed loaders.
- 52. On information and belief, Plaintiff alleges that Defendants Waldron, Roth, and Does 8-20 damaged the later-seized firearms either during the execution of the warrant and seizure of the firearms or when transporting the firearms to the first station where they stored, which Plaintiff believes to be the Palmdale Sheriff's Station, but could also have been another station.
- 53. Between June 14, 2018, and June 28, 2014, Plaintiffs' firearms arrived at the Palmdale Sheriff's Station, where Defendants Ames, Dingman, Jacob, Leon, Moreno, O'Leary Brown, Roach, Roth, and Saylor booked them into LASD custody. *See* County of Los Angeles Sheriff's Department Evidence and Property Page, Palmdale Station.
- 54. Plaintiff is informed and believes, and on that basis alleges that Defendants Ames, Dingman, Jacob, Leon, Moreno, O'Leary Brown, Roach, Roth, Saylor, and Does 8-20 each handled the firearms during their processing.
- 55. On information and belief, Plaintiff alleges that Defendants Ames, Dingman, Jacob, Leon, Moreno, O'Leary Brown, Roach, Roth, Saylor, and Does 8-20 were each responsible for seeing to it that each firearm they handled was stored properly and safely but did not do so despite written department policies regarding the proper storage of firearms in LASD custody
- 56. Based on an email sent to Plaintiff's counsel by Defendant O'Leary Brown in March 2019, Plaintiff is informed and believes, and on that basis alleges, that all the seized firearms were at some point transferred to LASD's warehouse in Whittier for

- 57. Defendants Ames, Dingman, Jacob, Leon, Moreno, O'Leary Brown, Roach, Roth, Saylor, and Does 8-20 were property custodians with LASD, either at the Palmdale Station or the Whittier Warehouse, during the time that Plaintiff's firearms were in LASD custody or were otherwise responsible for properly storing, handling, and safeguarding the firearms, but failed to do so.
- 58. Plaintiff is informed and believes, and on that basis alleges that, in his role as detective, Defendant Roth and Doe 9 investigated whether Plaintiff's seized firearms were lawful to possess and thus not contraband, if possessed by a person not otherwise prohibited from possessing firearms.
- 59. Having investigated the legality of the seized firearms, Defendant Roth and Doe 9 prepared a "supplemental report," where he reported his findings that 458 of the seized firearms were legal to possess, and thus not contraband.
- 60. On information and belief, Defendants Roth and Doe 9 handled the firearms in the course of examining them to determine if they were legal to own in California and, at some point during the examination and/or handling, damaged Plaintiffs' firearms.
- 61. After Plaintiffs paid Defendant County's required \$54-per-firearm fee (as alleged further below), Plaintiff requested that all the lawful firearms (i.e., those firearms not determined to be unlawful to possess under state law) be transferred to Carol Watson's Orange Coast Auctions, a properly licensed firearm dealer, to be sold at auction.
- 62. To effectuate the transfer to Orange Coast Auctions, Defendants transferred the firearms from the Whittier warehouse to the Palmdale Sheriff Station, and they were then released to Orange Coast Auctions.
- 63. Upon release of the firearms to Carol Watson's Orange Coast Auctions, Plaintiff discovered the extent of the damage to her firearms that resulted from being in LASD custody through photographs taken by auction house personnel at the police station showing how poorly the firearms were transported and stored by Defendants LASD,

- 64. For instance, photographs show dozens of long guns were packed together tightly in plastic bins. Photographs also revealed that handguns were thrown haphazardly on top of each other; they were not stored in separate envelopes that would have protected them from damage.
- 65. Orange Coast Auctions estimated that the damage to the firearms caused by Defendants' poor storage, handling, and transport of them while in LASD custody resulted in them selling for approximately \$96,000 less than they would have had they not been damaged.
- 66. Defendants' storage of the firearms was in violation of LASD's written policies described in the Department's "Manual of Policy and Procedures" ("the Manual"). Volume 5, Chapter 4 of the Manual describes the LASD's policies for storage of property and evidence.
- 67. Volume 5, Chapter 4, Subtopic 070.00 of the Manual states that "all property/evidence items shall be stored in a secure manner in a secure facility." It goes on to state that "high value items" must be stored in a safe.
- 68. To the extent the firearm collection was damaged because it was so large, Subtopic 070.30 would also apply, which explains that when property and evidence involved in a case is of such a large bulk or quantity that it is not feasible to store at a station or unit, the watch commanders "shall contact Central Property and Evidence (CPE) and arrange for immediate transfer."
- 69. Defendants' storage of the firearms also conflicted with guidelines for evidence and property handling from the California Commission on Peace Officer Standards and Training ("the Commission").
- 70. The Commission advises that "[a]gencies must develop specific guidelines detailing the acceptable methods for the receipt, packaging and storing of evidence and property that meet both agency needs and judicial standards." Cal. Comm'n on Peace

- 71. The Commission's guideline entitled Guideline 4.3: Firearms Handling Procedures, directs agencies to package firearms into appropriate gun boxes. *Id.* at 4-4. "[A] firearm must be rendered unloaded and safe with the action open and placed in a specifically designed firearms storage container (e.g., cardboard gun box or similar container), and secured to the container using nylon ties." *Id.* at 4-5.
- 72. Plaintiff is informed and believes, and on that basis alleges, that Defendant LASD has neither investigated nor disciplined any of it employees who handled the firearms for violating any of its written storage policies or other guidance regarding the proper storage of property in LASD custody, including firearms and property of significant value.
- 73. Given the disregard for their own written policies and guidelines and that, to Plaintiffs' knowledge, Defendant LASD has neither investigated nor disciplined its employees who handled the firearms for violating its written storage policies, Plaintiff alleges that it is Defendants' longstanding (though unwritten) policy or custom to store firearms haphazardly without care for any damage that may result notwithstanding any written policy or guidance on the subject.

# [Plaintiff's Payment of the County's \$54-Per-Firearm Fee]

- 74. On September 27, 2018, after Mr. Fernandez was charged for his unlawful possession of firearms, but before any trial could begin, he passed away.
  - 75. The charges against Mr. Fernandez were dismissed due to his death.
- 76. Upon Mr. Fernandez's death, any interest in the seized firearms passed to Plaintiff, as she was the trustee of the Fernandez Trust.
- 77. In order for Plaintiff to retrieve the seized firearms that were not contraband, 451 in total, Defendants demanded that Plaintiff pay Defendant County's "fee" of \$54 per firearm—or \$24,354.

79. There are myriad problems with how the County's "administrative fee" was applied to Plaintiffs' firearms.

- 80. First, the work performed for each firearm appears to have been duplicative, with various employees seemingly entering the same information and updating the same databases.
- 81. Second, no reasonable reduction was given in consideration of the fact that hundreds of firearms were all taken from the same individual. Unlike a situation where a single stray firearm is recovered and has to be processed, much of the work here was the same for each firearm, which would cut down on the amount of time necessary to process each firearm.
- 82. For the per-firearm fee to not be in violation of state law, it must not exceed the actual administrative costs incurred by LASD. Yet LASD per-firearm fee rests on the assumption that the processing the 451 firearms that were returned to Plaintiff took them *more than 675 employee hours*, despite the fact that all the firearms came from the same source.
- 83. What's more, the Board of Supervisors plainly never contemplated a situation such as this where hundreds of firearms all came from one source. As then-Sheriff Baca wrote, "an analysis of firearms evidence processing over a four-year period revealed that potentially 500 guns per year would be eligible for the administrative fee. A \$54 fee would yield additional revenue of approximately \$27,000 each year." Here, Plaintiff has paid almost that entire amount on her own, just to retrieve her own property.
- 84. In refusing to reduce the fee to reflect that all of the firearms came from the same person and required less work to process, the LASD fee as applied to Plaintiff

- 85. Insofar as the so-called "fee" exceeded the actual administrative costs borne by LASD, its existence can only be punitive in nature. *See Austin*, 509 U.S. at 610 ("[A] civil sanction that cannot fairly be said solely to serve a remedial purpose, but rather can only be explained as also serving either retributive or deterrent purposes, is punishment, as we have come to understand the term.").
- 86. Plaintiff, through her counsel, thus expressed to Defendants that Plaintiff was willing to pay a reduced fee that more reasonably reflected the actual administrative costs of Defendants' processing and storing the firearm collection.
- 87. Defendants refused to negotiate a lower fee amount, stating that there was no discretion to lower the per-firearm fee regardless of the circumstances because it was set by county ordinance, leaving Plaintiff no other option to take possession of her property but to pay the full amount of \$24,354.
- 88. On December 9, 2019, Plaintiff's counsel sent a letter to Deputy County Counsel Lana Choi of the Sheriff's Legal Advisory Unit, informing Defendants that Plaintiff would pay the full amount of the demanded "administrative fees" "under protest in order to get the firearms out of the possession of the county" and "to stop any claim that the continued storage of the firearms justifie[d] the current or any additional storage fees." But Plaintiff's counsel repeated that Plaintiff remained open to negotiating a lower fee with the County.
- 89. In summary, Plaintiff had to pay over \$24,000 for the "service" of Defendants storing her firearms so poorly that nearly \$100,000 in damage was done to them.

#### **DECLARATORY JUDGMENT ALLEGATIONS**

90. There is an actual and present controversy between the parties. Plaintiff contends that Defendant LASD'S per-firearm fee of \$54, imposed under Penal Code section 33880, constitutes an excessive and punitive fine as applied to a large collection of firearms all seized from a single owner who was never convicted of any charges. Plaintiff thus desires

Plaintiff also contends that Defendants' refusal to release the firearms to Plaintiff 91. upon her husband's death and the dismissal of all charges violated the Fourth Amendment prohibition on unreasonable seizures. Regardless of the legality of the original search and seizure, Defendants had no probable cause to continue the seizure of Plaintiffs' property after Mr. Fernandez's death because the fee they sought to extract from Plaintiffs was unreasonably excessive under all the circumstances—including Defendants' extraordinarily poor storage and handling of Plaintiffs' firearm collection that resulted in about \$96,000 of damage to the property. Plaintiff thus desires a judicial declaration that Defendants violated Plaintiff's rights under the Fourth Amendment.

# FIRST CLAIM FOR RELIEF **Violation of Eighth Amendment Right to Be Free from Excessive Fines** 42 U.S.C. § 1983, U.S. Const. (Against Defendants Los Angeles County, LASD, and Villanueva)

- 92. Plaintiff realleges and incorporates by reference the allegations contained in Paragraphs 1 through 91, inclusive, as though fully set forth below.
- 93. The Eighth Amendment states: "Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted." U.S. Const., amend. VIII. This amendment prohibits the federal government from imposing unduly harsh penalties on criminal defendants. It has been incorporated against state and local governments via the Fourteenth Amendment. *Timbs*, 139 S. Ct. 683.
- 94. California Penal Code section 33880, which authorizes Defendants to charge a fee for seizing, storing, and returning firearms, prohibits localities from charging more than their actual administrative costs for doing so.
  - 95. Plaintiff's late husband, Manuel Fernandez, had his collection of hundreds of

- 96. Before any conviction, however, Mr. Fernandez passed away, Defendants dismissed the charges against him, and full ownership of the seized firearm collection passed on to Plaintiff. In order to secure the release of her firearms, however, Plaintiff had to pay LASD an "administrative fee" \$54 per firearm for each of 451 firearms—for a total fee of \$24,354.
- 97. Plaintiff is informed and believes, and on that basis alleges that the costs for processing and storage Plaintiffs' firearms were substantially lower than the actual processing costs associated with the typical seizure of hundreds of firearms coming from hundreds of different individuals—the type of situation Defendant Los Angeles County had in mind when it adopted the fee. Moreover, according to a conversation with Defendant O'Leary Brown, Defendants do not charge a storage fee for property other than firearms, conflicting with the contention that the fee is meant simply to reimburse Defendants for their storage costs.
- 98. Defendants refused to reduce the fee or even negotiate in good faith to come to a reasonable arrangement, citing that the fee was set by Defendant County's duly adopted ordinance—an official policy—and they had no discretion to reduce it.
- 99. In charging substantially more for the return of the firearms than the costs Defendants had borne to seize, process, and store them, the "administrative fee" became unconstitutionally excessive and punitive in violation of the Eighth Amendment under the standard set by *Austin v. United States*, 509 U.S. 602, 610 (1993).
- 100. It is the official policy of Defendants County, LASD, and Sheriff Villanueva to charge a fee of \$54 per firearm for the release of seized firearms, and County and LASD personnel have no discretion to reduce the fee to reflect the Defendants' actual costs. In levying the entire \$54 per-firearm fee and refusing to lower it even though it was excessive and punitive as applied to Plaintiff, Defendants Ames, Dingman, Jacob, Leon, Moreno, O'Leary Brown, Roach, Roth, Saylor, Waldron, and Does 8-20 were thus

- 107. During the execution of various valid search warrants, Defendants seized firearms from Plaintiff's now-deceased husband, and proceeded to transport, handle, and store them with extreme negligence or reckless disregard for their condition.
- 108. Defendants' disregard for their own written policies on storage of firearms and failure to discipline any employee for such disregard indicates that the custom and longstanding practice of Defendants LASD and Sheriff Villaneuva is to haphazardly store seized firearms, regardless of what their written policies or guidelines state. The Supreme Court in *Monell* held that municipalities may be held liable under section 1983 for constitutional violations resulting from not just official county policy, but also customs. (*Benavidez v. Cty. of San Diego* (9th Cir. 2021) 993 F.3d 1134, 1153.)
- 109. Defendants lacked probable cause to continue to withhold the firearms after the death of Mr. Fernandez, the dismissal of the charges against him, and the transfer of the firearms' ownership to Plaintiff because the levying of the County's \$54 per-firearm fee was unconstitutional as applied to Plaintiff. The once lawful seizure became an unconstitutional one. The failure to return Plaintiffs' firearms once probable cause evaporated and Plaintiff demanded their return violates the Fourth Amendment.
- 110. Further, when Defendants released the firearms to Plaintiff, they had lost about \$96,000 in value due to the damage done to them during their storage and/or during their transport to and from Defendants' storage facilities. The damage to Plaintiffs' seized property by Defendants violates the Fourth Amendment.
- 111. At all times herein mentioned, Defendants County, LASD, and Villaneuva authorized and ratified the wrongful acts of the individual defendants and Does 8-20. The individual Defendants' wrongful conduct was the result of policies, practices, and customs of Defendants County, LASD, and Villanueva—notwithstanding the official Defendants' written policies.
- 112. Defendants County, LASD, and Sheriff Villanueva failed to properly screen, train and/or supervise their officers and personnel, including Defendants Ames, Dingman,

- 113. As a result of such failures to train, Defendants Ames, Dingman, Jacob, Leon, Moreno, O'Leary Brown, Roach, Roth, Saylor, Waldron, and Does 8-20 failed to apply the official Defendants' written policies, guidelines, and laws, leading to Plaintiff's harm—*i.e.*, the violations of her constitutional rights described herein including, inter alia, the violation of her constitutional rights including, inter alia, the Fourth Amendment right to be free from unreasonable searches and seizures.
- 114. Plaintiff's constitutional rights were violated as a proximate result of the deliberate indifference of Defendants County, LASD, and Villaneuva in the training and supervision of its officers, detectives, and employees as regards the handling and storage of seized firearms in LASD custody per LASD policy and state guidelines
- 115. As a direct and proximate consequence of the acts of Defendants' agents and employees, Plaintiff suffered a severe financial loss and is entitled to compensation for that loss.

# THIRD CLAIM FOR RELIEF Negligence California Civil Code § 1714 (Against All Defendants)

- 116. Plaintiff realleges and incorporates by reference the allegations contained in Paragraphs 1 through 115, inclusive, as though fully set forth below.
- 117. Upon the seizure of Plaintiff's property, Defendants had a legal duty to use due care in transporting and storing that property, including the 451 firearms that Plaintiff eventually had to pay over twenty thousand dollars to retrieve.
- 118. Defendants breached that duty by failing to properly store the firearms while they were in their care and during their transport, as they packed the long guns all together in bins and stacked pistols on top of each other. This was done with disregard to

1 Defendant LASD'S policy manual, the California Commission on Peace Officer Standards and Training's guidelines for handling seized property, and constitutional 2 3 protections against unlawful seizures. 4 119. Defendants' breach was the direct and proximate cause of Plaintiff's resulting harm of \$96,000 in lost value when the firearms were sold at auction. 5 120. Defendants County of Los Angeles, LASD, and Sheriff Villanueva are liable for 6 7 the actions or omissions of their employees under California Government Code section 8 815.2, which states that "[a] public entity is liable for injury proximately caused by an act 9 or omission of an employee of the public entity within the scope of his employment if the 10 act or omission would, apart from this section, have given rise to a cause of action against 11 that employee or his personal representative." 12

121. Defendants' negligence or reckless disregard of their duty of care was the main factor in causing Plaintiff's harm, and Plaintiff is entitled to compensation for the resulting financial loss.

#### FOURTH CLAIM FOR RELIEF **Breach of Bailment** California Civil Code § 1813, et seq. (Against All Defendants)

- 122. Plaintiff realleges and incorporates by reference the allegations contained in Paragraphs 1 through 121, inclusive, as though fully set forth below.
- 123. By seizing her late husband's firearms, Defendants created an involuntary bailment of that property.
- 124. Defendants, as bailees, had sole actual and physical possession and custody of the firearms.
- 125. Defendants, as bailees, failed to adequately care for the firearms, transporting and storing them in such a way that tremendous damage resulted to them.
- 126. Defendants breached the bailment because they returned the firearms to Plaintiff in damaged condition that they had caused.
  - 127. Defendants County of Los Angeles, LASD, and Sheriff Villanueva are liable for

27 28 the actions or omissions of their employees under California Government Code section 815.2, which states that "[a] public entity is liable for injury proximately caused by an act or omission of an employee of the public entity within the scope of his employment if the act or omission would, apart from this section, have given rise to a cause of action against that employee or his personal representative."

128. Defendants' breach of bailment caused Plaintiff's harm in the form of damage to her property, and Plaintiff is entitled to compensation for the resulting financial loss.

# FIFTH CLAIM FOR RELIEF

(Against All Defendants)

- 129. Plaintiff realleges and incorporates by reference the allegations contained in Paragraphs 1 through 128, inclusive, as though fully set forth below.
- 130. Except for a few firearms that are not at issue here, Plaintiff lawfully owned the firearms seized following the death of her husband. A seizure of property is an interference to possessory interests only, and not ownership rights, such that Defendants, or any of them, never had an ownership interest in Plaintiff's firearms. Defendants only had a possessory interest in the firearms from the time they were seized up through the time Plaintiff's husband passed away, which made her eligible as a matter of law to receive the firearms.
- 131. Any damage that resulted to the firearms while they were in Defendants' possession was an intentional and substantial interference with Plaintiff's enjoyment of her property and constituted a trespass to chattels.
- 132. Plaintiff did not consent to Defendants' interference with her ownership rights to her property.
- 133. Plaintiff seeks a remedy against Defendants for their wrongful exercise of control over Plaintiff's personal property by demanding an excessive fine be paid prior to its return, and the resulting damage to that property.
- 134. Defendants County of Los Angeles, LASD, and Sheriff Villanueva are liable for the actions or omissions of their employees under California Government Code section

815.2, which states that "[a] public entity is liable for injury proximately caused by an act or omission of an employee of the public entity within the scope of his employment if the act or omission would, apart from this section, have given rise to a cause of action against that employee or his personal representative."

135. Plaintiff was harmed in the form of lost value to the firearms due to the damage done to them while they were in the possession of Defendants. Plaintiff is entitled to compensation for her loss.

#### SIXTH CLAIM FOR RELIEF Failure to Train

(Against Defendants Los Angeles County, LASD, and Alex Villanueva)

- 136. Plaintiff realleges and incorporates by reference the allegations contained in Paragraphs 1 through 136, inclusive, as though fully set forth below.
- 137. Defendants County, LASD, and Villanueva are responsible for the operations, practices, and customs of the Los Angeles Sheriff's Department.
- 138. Defendants LASD and Villanueva are also responsible for the hiring, screening, training, retention, supervision, discipline, counseling, and control of the personnel and officers under their supervision and command, including the personnel who forced Plaintiff to pay an excessive fine to retrieve her firearms, and the personnel who poorly stored and transported her firearms, resulting in damage to them.
- 139. On information and belief, Defendants, and each of them, will deny that in committing the acts and omissions against Plaintiff described herein, including the violations of the Fourth and Eighth Amendments described above.
- 140. Defendants County, LASD, and Villanueva, and each of them, had notice of the applicable state law regarding the imposition of administrative fees under Penal Code section 33880, as the \$54 fee that is one of the subjects of this litigation exists based on the authority granted by that section.
- 141. Defendants Los Angeles County, LASD, and Villanueva, and each of them, also had notice of LASD policies described in the Department's "Manual of Policy and Procedures", specifically, the sections pertaining to the policies for storage of property

- 142. Notwithstanding such notice, Defendants failed to properly screen, train and/or supervise their officers and personnel, including Defendants Ames, Dingman, Jacob, Leon, Moreno, O'Leary Brown, Roach, Roth, Saylor, Waldron, and Does 8-20, with regard to such written policies, guidelines, and laws. Their officers and personnel thus wrongly applied an excessive fine on the Fernandez firearms, and also stored them poorly resulting in extensive damage. Failure to train constitutes a basis for *Monell* liability where the failure amounts to deliberate indifference to the rights of those who deal with municipal employees. (*Benavidez v. Cty. of San Diego* (9th Cir. 2021) 993 F.3d 1134, 1153-1154.)
- 143. As a result of such failures to train, Defendants Ames, Dingman, Jacob, Leon, Moreno, O'Leary Brown, Roach, Roth, Saylor, Waldron, and Does 8-20 failed to properly apply the written policies, guidelines, and laws of Defendants County, LASD, and Villanueva, leading to Plaintiff's harm. Plaintiff resultantly suffered violations of her constitutional rights including, inter alia, the Eight Amendment right to be free from excessive fines and the Fourth Amendment right to be free from unreasonable searches and seizures.

#### PRAYER FOR RELIEF

# WHEREFORE, Plaintiffs pray that this Court:

- 1. Enter a declaratory judgment that California Penal Code section 33880(a), as applied to Plaintiff Fernandez by way of Defendants' \$54 per-firearm "administrative fee," was punitive and constituted an excessive fine in violation of Plaintiffs' rights under the Eighth Amendment to the United States Constitution;
- 2. Enter a declaratory judgment that Defendants' \$54 per-firearm "administrative fee," as applied to Plaintiff, violates California Penal Code section 33880(a) and its

express mandate that such fees do not exceed the actual costs incurred for the seizure, impounding, storage, or release of any firearm, ammunition feeding device, or ammunition: 3. Enter a declaratory judgment that Defendants' conduct as complained of in this complaint violates Plaintiffs' rights under the Fourth Amendment to the United States Constitution; 4. Award compensatory and general damages, in an amount to be proven at trial, against Defendants Los Angeles County and LASD and against each Defendant sued in his or her personal capacity; 5. Award exemplary and punitive damages, in an amount to be proven at trial, against Defendants Los Angeles County and LASD and against each of the individual Defendants sued in his or her personal capacity; Award reasonable attorneys' fees and costs of suit, according to proof; 6. 7. Award interest; and Grant any such other and further relief as the Court may deem proper. 8. **DEMAND FOR JURY TRIAL** Pursuant to Federal Rule of Civil Procedure 38 and Central District Local Rule 38-1, Plaintiff hereby demands a trial by jury in the above-captioned action of all issues triable by jury. So surveillance would be done, documented, and then information would start to get gathered on the house as far as pulling records, who is on title for the house, vehicles that are there, running the vehicles, figuring out who the registered owners are, and then piecing that together for your statement of probable cause linking the person to the firearms and then why we believe that the crime of whatever crime we're investigating is being committed at that house and why we believe evidence is located within the house that we need to seize.

Okay. Jumping back to the start of the process real quick, where did these leads come from? So where do you first find out -- and I'm sure there's multiple answers to this, but where do you typically come to know that someone is in possession of illegal firearms? Is it the DOJ? Is it tips from informants? Where do these usually come from?

So we started trying to get the best game plan that we could 18 to start cataloging and processing these firearms, 19 20 because even though, you know, there may be 4- or 500 21 firearms, we're still initially looking for the 42 that are registered. So that is something that we 22 have to now start going through. 23

24 So I remember passing firearms back to other deputies who were starting to write down serial 25

were with the -- the evidence custodian trying to help her go through all these. The initial night of the 3 search after the search warrant, there was probably 10 or 15 deputies that were trying to help organize and catalog all the firearms to make it a little bit -- to 5 try to make it faster going into the evidence process.

But over the course of those couple weeks, there was probably three or four different deputies helping out the evidence custodian with whatever she needed as far as fixing everything and getting it properly booked.

Q And you said the firearms were all taken to the same location initially?

14 They were.

It's the Palmdale Sheriff's Station.

I transported some of them, but I was in the convoy -- when I say convoy, there was multiple vehicles including a sheriff's department truck, a green truck, that was transporting hundreds of firearms.

1 that you walk into is probably 10 feet deep and maybe 20 to 25 feet wide. And it's got two computers inside of there where you process the evidence. When I say "process," I mean put it into PRELIMS. There's -- I don't want to call them a tote but like a 21 Rubbermaid or rubber plastic bins that firearms --22

that they're set on. In this case I do remember,

to explain without seeing it, but that was like an empty room, and I know a lot of the guns were stacked 3 against the wall inside that room and secured that 4 way.

5 Okay. Now let's talk a little bit about Q 6 booking firearms or booking property in general, I 7 suppose.

During your employment with the sheriff's department, have you ever booked seized firearms or other property?

Q Okay. And does it normally fall to the person who conducts the search to book the firearms or other property?

It falls on them to ensure it's booked. Sometimes in certain cases, they're not the actual one who books the piece of property. 4 Q I guess I need to know start to finish what goes into that. 5

So with one gun, you take it into the evidence room where I said those two computers are at. Typically you'd sit in front of that computer. You'd log in to a system called PRELIMS. That PRELIMS system is essentially like the tracking system of where that evidence is now going.

And you input -- you log in to the system, and you start to input case-specific information, file numbers, suspect information, victim information, stuff like that. And then you'd go to the actual firearm portion where, depending on what the firearm is -- really with handguns we do it, too, but specifically long guns. So the firearms, we'd measure the lengths of the barrels, and then we start trying to identify what the make and model of that actual firearm is.

Once we identify make, model, serial number, length of the barrel, type of material that the stock is, wood grain stock, composite, stuff like that, we start inputting the information into the PRELIMS Page 95

to who that is associated to.

And then there's an AFS form that also gets filled out on the booking in the PRELIMS system that documents -- you put in the information, was this a crime gun? And that's for tracking purposes as well.

Once that's done and the system is -- or the information is input into PRELIMS, you print what's called an evidence label. So you print two evidence labels for each firearm. One of them will go on a firearm tag. So you take that label, you put it on, like, a little tag that has string on the end of it, and then you tie that string. If it's a long rifle, you typically tie it on the trigger quard area, and then you attach that label onto it. So that way when the firearm is placed into the secured locker, when the evidence custodian gets it, she can pull it out, and now she has the sticker information that can be scanned and say, okay, this firearm was booked by, you know, Wyatt Waldron and this is all the information of that firearm.

The other label can be used for reports or it can be used on the evidence page of the actual first report that's being done to say, hey, this is evidence 1 and this is the sticker that's associated to that firearm.

> So each one of the firearms is then entered manually into the computer, the information that you gather, the serial number. There's drop-downs, little drop-down tabs in the system, that you have to select certain things. So the makes are abbreviated for the most part. So if it's a Mauser, it may be abbreviated MAS. And this is just for example purposes, but it may be abbreviated MAS.

> So there's another booklet that's in the evidence room that once you identify, okay, this is a Mauser firearm, you go through the booklet and find Mauser and then find the abbreviation code. Is that the owner, or is that just who it's recovered from?

No -- yeah, that's just in that specific case where that firearm is coming from. So if there is a suspect arrested in the case and that suspect had three firearms on him that are in his car, all three of those firearms would be associated to that suspect.

Got it.

If they were just found or something like that, you can associate it to the investigating officer. And so if there's questions on that later, they can say, Hey, where did this firearm come from? And you can explain, you know, it was found in a park or somewhere like that.

O Understood. And as part of this process, do you check who actually does own the firearm according to the records, the registration records from California?

single firearm and there's no defaced serial number, nothing weird about it, just a standard shotgun or 2 something. 3

How long would it take you from start to finish to book it?

I would say start to finish, maybe 15 to 20 minutes.

Q Okay. So does it take that -- so it takes 15 to 20 minutes to book a single firearm.

When they all come from the same source -and I know it's a little unusual in Mr. Fernandez's case. But in any case where you have multiple firearms coming from a single person, especially if that person is the actual owner, does that speed up the process at all, or does each firearm still take 15 to 20 minutes?

16 17 A I would say each firearm still takes 15 to 20 minutes only because they each have to be singularly 18 inputted. Or is there something I'm not understanding about why that's not possible?

Yes. So it's not necessarily copy-and-pasted. But some of the -- some of the root information for that case is carried over. So when you input the case into PRELIMS and you go to select "evidence," you can essentially -- once you get done with that first piece of evidence -- let's just say it's one firearm -- that one firearm is done.

Now you can go and say, I need to add another piece of evidence. So that second piece of evidence that you're going to add, you'll start over with -now with all the characteristics, and it will be more on the firearm side of it. There will be some things

A I would say if I'm adding a second piece of evidence to the same case, it would probably take me maybe ten minutes now to do that one gun. Just based on the measurements, manufacturer, and, you know, finding the abbreviation codes and going through that stuff and then now clicking the associated drop boxes to the case, I would say probably ten minutes per firearm afterwards.

Understood. And so just to recap, roughly 20 minutes for the first firearm to book it, complete the booking process, about 10 minutes for subsequent firearms.

And is this, would you say, a normal amount of time, or are you unusually fast at booking?

1 No, I would say that that's a normal amount of time. In this case it's a little bit different 2 only because if you book one or two firearms and let's 4 say you get the model incorrect, the evidence custodian can go in there and put the correct model in 5 there. And so you're not really having to do a whole lot of follow-up as the investigating officer.

Whereas in this case, it's a little bit different only because there were a lot of firearms we couldn't identify and that we did the best that we could. And so we had to go back and probably over the course of weeks to keep correcting and figuring out and inputting information to update it. This couldn't be left to just one evidence custodian, so a lot of the guys, including myself, on the team were responsible for going back there and sitting with the evidence custodian now and fixing the different things because there was a handful that we just had to put "unknown." We couldn't figure it out.

Well, then upon further review, the evidence custodian said, Hey, a lot of these we can figure out. We have to look through a different system or whatever, but we can figure it out. So we had to go back and redo it.

Q So there was reasons why this seizure you'd

1 No. No. I apologize. Let me correct 2 myself. Just the booking.

So let's say you have the firearms in the room, you're handling all the booking procedure for them. What would that take you?

So if I had somebody standing there handing me each gun, and I have to measure them; I have to input each one, whatever 500 guns times ten minutes would be. But that's on the assumption that I did it right, you know. A lot of these firearms, like I said, were not easily identifiable, and it took a lot of resources and time to identify, hey, where did these things originate from, who's the manufacturer. It wasn't like, you know, being able to find one rifle and get the information.

So there was -- I don't think I could quantify and put a number on how long it would take me because it took teams of people weeks, if not months, to figure it out. You know, it would take -- I don't think I could put a fair assessment on how long it would take me.

Understood. So the 20 minutes and 10 minutes more applies to the standard firearms that are clearly like this is a Browning shotgun with a serial number.

But was the difficulty that these firearms

Six months? And the reason I'm a little surprised by that answer is earlier you testified that it takes 20 minutes for the first, 10 for subsequent. I understand that you went through corrections after that. But six months of man-hours sounds quite excessive if it originally takes 20 minutes per firearm or 10 minutes per firearm. So if you can elaborate, I guess I'm asking, on that.

22 A So are you asking me how long it would take 23 me to process the 500 firearms as far as picking them up from the patio, walking them into the evidence 24 25 room, sitting down --

Today, during the execution of a search warrant at 34710 Caprock Road Agua Dulce, County of Los Angeles, we arrested Manuel Fernandez for being an ex-felon in possession of a firearm (Violation of 29800(a)(1) PC). Through the Automated Firearm System, Manuel Fernandez had 42 handguns registered to his name. At the conclusion of the search warrant, we recovered over 400 firearms at his residence. However, we only recovered 2 out of the 42 registered firearms. During a conversation with Manuel's wife (Ana Patricia Fernandez FH/02-29-60), she told me she personally delivered an unknown amount of firearms including handguns and rifles to Manuel's business partner. Ana identified the business partner by the name of "Carey Lee Moisan" (FW/approximately 65 years old) who resides at 34965 Sweetwater Drive. Ana does not know how many firearms she delivered to Carey, because she did not inventory the firearms. In addition, Ana stated she was instructed by Manuel to deliver the firearms to his business partner, Carey, in June of 2017.

During that time, Manuel was incarcerated in the Los Angeles County Jail. While visiting him in jail, Manuel told her to take several boxes containing firearms to Carey for safekeeping. Once, released from jail, Manuel did not retrieve the firearms from Carey nor did he arrange for disposal of the firearms. Ana stated the firearms should be at Carey's house, inside of a safe. Due to Manuel's health condition, neither Ana nor Manuel have had time to retrieve the firearms from Carey. Manuel has been in and out of the hospital, and Ana did not deem the retrieval of the firearms to be a priority.

Through Departmental resources, I confirmed Carey Lee Moisan (FW/ 04-07-53) does in fact have a listed address of 34965 Sweetwater Drive in Agua Dulce, CA. In fact, Carey was a co-defendant on two cases with Manuel Fernandez, and as a result was convicted of felony grand theft (Violation of 487(a) PC). Furthermore, Carey is a convicted felon as of 2009 and therefore was in violation of 29800(a)(1) PC at the time the firearms were given to her in 2017.

In addition, the vehicles parked on her property (CA License plates of: 6RJM906, 7XAV612, 5MXF441, 8APC831, 4MMU959, 8AYG291, and 7E39544) are registered to Manuel Fernandez or Rancho Agua Dulce LLC. A search of "Rancho Agua Dulce LLC" listed Carey Moisan and Manuel Fernandez as managing members of the domestic limited-liability company, otherwise known as LLC.

Based on the above information, your Affiant and Co-Affiant believe there is probable cause to believe grounds for the issuance of a search warrant exists as set forth in sections 1524 PC. Your Affiant and Co-Affiant swear that the information contained within this affidavit is true, and therefore request this search warrant be issued to further your Affiant's and Co-Affiant's investigation.

Your Affiant and Co-Affiant believe if a search warrant is granted for the address of 34965 Sweetwater Drive, Agua Dulce, firearms will be recovered.

Based on the information in this warrant, your Affiant and Co-Affiant believe the person listed in this warrant reside at the residence located at 34965 Sweetwater Drive, Agua Dulce, CA. Your Affiant and Co-Affiant declare under the penalty of perjury that the aforementioned facts are true and that there is probable cause to believe the firearms are now in the described location (34965 Sweetwater Drive Agua Dulce, CA), including all rooms, buildings, RV's and structures used in connection with the premises.

I believe the crime of 29800P.C. (Felon with a Firearm) is being committed from within the location and property located at 34965 Sweetwater Drive Agua Dulce, CA.

Your Co-Affiant is requesting night service during the service of this search warrant due to the close proximity of multiple schools which are heavily populated. The neighborhood and surrounding area is heavily populated with school children walking to school and vehicle traffic taking children to school after 7am. Night service would eliminate the possibility of children being present in the area should an armed conflict occur. It will also allow us to approach the location under the cover of darkness to avoid detection which gives the deputies a tactical advantage while increasing the safety of not only them, but the occupants who may be inside of the residence at the time of the search warrant service.

DECLARATION OF DEPUTY WYATT WALDRON

I, WYATT WALDRON declare that if called and sworn, I would state the following under oath which is based on my personal knowledge;

- 1. I am over the age of 18 and am named as a defendant in this action.
- 2. At all times mentioned herein, I have been employed by the Los Angeles County Sheriff's Department as a Deputy Sheriff. In June 2018, I was the lead deputy in the investigation involved in the seizure of firearms, ammunition and other prohibited items from Manuel Fernandez.
- 3. In June 2018, I received a tip indicating that Manuel Fernandez was in possession of a large collection of firearms. I checked the Automated Firearms System (AFS) database and discovered that Manuel Fernandez had 42 firearms registered to him. I then began an investigation in order to obtain a warrant for the seizure of the firearms from Manuel Fernandez.
- 4. My investigation included researching Fernandez's criminal history; researching title to Fernandez's home; checking the DMV database for Fernandez's driver's license, then comparing that license to the AFS database to confirm that he was the correct person; reading historical court documents during Fernandez's 2009 conviction wherein Judge Carlos Chung admonished Miguel Fernandez that he was not to own or possess any firearms or dangerous weapons.
- 5. On June 11, 2018, I, along with Deputies Jonathan Livingston and Deputy

  Murray Jacob conducted surveillance of Manuel Fernandez's residence at 34710 Caprock

Road on order to verify that he still resided at the residence and to determine the number of other occupants in the residence in preparation for serving the warrant. During the surveillance, I was able to confirm that Manuel Fernandez resided at the location based on my observations and the DMV photos of Fernandez.

- 6. I then began the process of preparing the warrant affidavit and statement of probable cause. After preparing the required documents, I took them to the courthouse and presented them to the judge for signature.
- 7. The aforementioned actions took approximately fourteen (14) LASD manhours for sworn peace officer personnel.
- 8. The report of the June 14, 2018 search was drafted by Deputy Kyle Dingman. A true and correct copy of the report of the June 14, 2018-service of the warrant on Manuel Fernandez's residence at 34710 Caprock Road, in Agua Dulce, is attached hereto and incorporated by reference herein as Exhibit 6.
- 9. The search of the Caprock residence on June 14, 2018 began with the station briefing at 7:00 am. The search concluded on that day at 12:40 pm.
- 10. Prior to conducting the search of the Fernandez residence on Caprock the search team took video of the inside of the location. A true and correct copy of the video taken prior to the search of Manuel Fernandez's residence as it appeared on June 14, 2018 is attached hereto and incorporated by reference herein as Exhibit 18.
- 11. In the late afternoon of June 14, 2018, we served a warrant at the residence of Manuel Fernandez's business partner Carey Moisan, on Sweetwater Drive in Agua Dulce. That search took approximately two hours and involved the following ten (10) Deputy

On 06-14-16 members of the Summer Suppression Team responded to 34710 Caprock Road to assist Palmdale Sheriff's Station PAC (Partners Against Crimes) Deputies with a search warrant signed by the Honorable Judge Lisa Chung of the North Superior Court (see attached search warrant). Prior to the service of the warrant a records check showed the suspect had 42 pistols registered to him and has a prior felony conviction for grand theft.

Knock and notice was conducted by Deputy Waldron and Deputy Livingston. The front door to the residence was opened by Ana Fernandez (FW/022960) (S/Fernandez's wife). Once the front door to the residence was opened, Deputy Waldron had Ana, her daughter (Ana Sophia Fernandez FH/071488) and S/Fernandez exit the residence and remain outside the location with Deputy Personnel. Once the above mentioned individuals were outside the residence additional Deputy Personnel checked the residence to ensure there were no other people inside the location. No additional individuals were located inside the residence.

Upon completion of clearing the residence, Deputy Personnel escorted Ana Fernandez and Ana Sophia Fernandez to the living room of the location.

Deputy Vilanova contacted S/Fernandez outside the front door of the residence and advised him of his Miranda Rights per SH-AD 477. S/Fernandez stated he understood his rights and agreed to speak without an attorney present. Deputy Vilanova audio recorded the conversation and later uploaded the audio file into the Palmdale Sheriff's Station shared files.

S/Fernandez told Deputy Vilanova he spent 6 months in county jail for a civil dispute, but denied being convicted of any felony charges. Deputy Vilanova showed the suspect his Consolidated Criminal History Record (CCHRS) which showed he had a felony conviction for grand theft in 2009. S/Fernandez stated he never received any notification from either the judge (Judge Chung) or his attorney advising him he was

not allowed to own, possess, and/or have access to any firearms. He also denied having any knowledge and/or instruction on what to do with the firearms he currently owns.

When asked about the 42 firearms registered to him, S/Fernandez stated he did not know the current whereabouts of the firearms. He stated since he was diagnosed with cancer he lost interest in guns, because he was no longer able to shoot the weapons. S/Fernandez stated there were several firearms at the residence, however they all belonged to his son. He further stated his deceased father owned several firearms which were also present at the residence.

S/Fernandez stated he does not live at the residence and only stays there occasionally. He told us the residence is in his wife's name and because he is diagnosed with stage four cancer, he spends most of his time at the hospital. S/Fernandez later told us he does have personal property at the location and said it is located inside of the master bedroom. He additionally admitted he shares the master bedroom with his wife.

S/Fernandez stated the only firearms at the residence were located downstairs. He stated there were no firearms located in the upstairs bedrooms of the residence.

Deputy Vilanova later spoke to S/Fernandez' wife (Ana Fernandez FW/022960) who told him the following:

S/Fernandez has lived at the location with her since they purchased the residence in 2001. He has spent several days at the hospital when required for his cancer treatments, however he primarily stays at the residence. Deputy Vilanova asked Ana about the 42 firearms registered to S/Fernandez. Ana stated she is aware of some firearms being at the location, but further explained while S/Fernandez was incarcerated he asked her to take several firearms to his business partner's (Carey Moisan FW/040573) residence (34965 Sweetwater Drive, Auga Dulca). She stated she did not remember how many firearms she took to Carey Moisan's residence. Ana stated she brought the firearms to Carey's residence approximately one year ago (June 2017), but she has not attempted to retrieve the firearms or arrange for their sale/disposal.

It should be noted I was present and standing next to Deputy Vilanova while he was interviewing S/Fernandez.

After speaking to S/Fernandez he was escorted into the living room area of the residence while Deputy Personal searched the location.

During the search of the location we recovered over four hundred rifles, and handguns from the residence. The recovered rifles included numerous semi-automatic rifles, assault rifles, shotguns, lever action rifles, and bolt action rifles. Approximately sixty six pistols were recovered from the residence as well as several high capacity magazines and multiple boxes of bulk ammunition. Several boxes of ammunition appeared to be armor piercing and incendiary tipped rounds. The majority of the weapons were in plain view or located in an unsecure area of the residence.

Approximately 20 rifles, 5 handguns and several boxes of ammunition were recovered from the upstairs master bedroom and other unsecured areas (i.e. closets, additional guest rooms).

Approximately 10 handguns, 20 rifles, and several boxes of ammunition were recovered from the downstairs dining room.

Approximately 35 handguns, 30 rifles and several cases of ammunition were recovered from the downstairs hallway.

The rest of the rifles, handguns, and ammunition were recovered from the garage area of the residence, some of which were inside of an unlocked safe.

Based on the above information we arrested the suspect for the indicate charges. He was later transported to Palmdale Sheriff's Station and booked, with the approval of Watch Commander Lieutenant Sanchez.

Digital images were taken of the firearms, ammunition and magazines. The images were later uploaded into the Palmdale Sheriff's Station shared files.

The above mentioned deputies assisted in booking the firearms, ammunition and gun components into evidence at Palmdale Sheriff's Station.

Due to the large number of evidence recovered from the location, we have not yet processed the recovered evidence and a supplemental report will be written at a later time under the above file number. As a result I was unable to obtain the exact number of firearms, ammunition and magazines recovered from the location. I was also unable to determine who the registered owner of each firearm was at the time of this report.

#### STATEMENT OF PROBABLE CAUSE

Through department resources I identified two legal owners of the property located at 34710 Caprock Road, Agua Dulce, CA. One of the owners on the home is Manuel Fernandez who was placed on the title of the home April 2018. Utilizing CCHRS I checked the name Manuel Fernandez with a birthdate of 01-18-58. There was a criminal history with a booking photograph of Manuel Fernandez. His criminal history showed that he had been convicted of a felony in 2009 for 487P.C. 182 P.C. His CCHRS further showed that he had used the address of 34710 Caprock Road, Agua Dulce on multiple occasions.

I checked with the Automated Firearms System (AFS) to determine if firearms are owned by Manuel Fernandez with a birthdate of 01-18-58. I checked his driver's license number of N4341279 against the AFS database which returned with 42 handguns owned by Manuel Fernandez with a date of birth of 01-18-1958. The 42 handguns registered to Manuel Fernandez are listed and described on SW-2. A check of California Department of Motor Vehicles revealed the driver's license number listed is associated to Manuel Fernandez with a date of birth of 01-18-1958. According to AFS, the firearms were purchased on dates prior to his conviction in 2009. Reading historical court documents, during his 2009 conviction, Honorable Judge Carlos Chung admonished Manuel Fernandez that he was not to own or possess any firearms and or dangerous weapons.

On 06-11-18, my partner Deputy Livingston (#527888) and I conducted surveillance at 34710 Caprock Rd, Agua Dulce, CA. During the surveillance, we observed Manuel Fernandez exit the residence and get into a Hummer H2 (Lic#5EGE269) and drive southbound from the location. I was able to positively identify the person who exited the residence as Manuel Fernandez based on his CA DMV photo and previous booking photo. Deputy Jacob (513465) conducted a traffic stop on the vehicle for a traffic code violation. Deputy Jacob asked the driver of the vehicle for his Driver's License, at which time the driver handed him a California Driver's License with the name Manuel Fernandez and a Driver's License #N4341279.

Based on the above, I believe the crime of 29800(A)(1)P.C. is being committed at the location. I base my belief on the fact Manuel Fernandez has a proven felony conviction coupled with the 42 firearms registered to him. All 42 firearms are still currently registered to Manuel Fernandez N4341279 and have yet to be transferred legally according to California State Law.

Based on the facts articulated in this affidavit, I believe that grounds for the issuance of a search warrant exists as set forth in sections 1524 PC. I believe that if a search warrant is granted for the address of 34710 Caprock Road, Agua Dulce CA, evidence supporting the facts in this affidavit consistent with that of the above listed felony will be recovered.

On 06-14-18, at approximately 0800 hours, my partner (Deputy Dingman, Kyle #602363) and I assisted the Palmdale Sheriff's Station PAC team (Partners Against Crimes) in servicing a search warrant at 34710 Caprock Road, in the City of Agua Dulce, County of Los Angeles. At that location, a suspect by the name of Manuel Fernandez (male Hispanic, DOB 01-18-58) was arrested for being an ex-felon in possession of a firearm (29800(a)(1) PC). In addition, we recovered over 400 firearms, some of which were registered to Manuel. However, we did not recover all of the handguns registered to Manuel Fernandez (42 handguns, see attached Automated Firearm System attachment for further and see file #918-08710-2646-151 for further on above search warrant and arrest report).

While at the location, I had a conversation with Manuel Fernandez's wife (Ana Patricia Fernandez, female Hispanic, DOB 02-29-60, 661-268-7317) regarding the firearms inside of the residence, Manuel's current residence, and the whereabouts of the registered handguns which were not located at the residence (36 outstanding).

The initial conversation was audio recorded and she stated the following:

Ana visited Manuel in jail sometime in June of 2017. During the visit, she understood that Manuel wanted her to take an unknown amount of firearms to his business partner (later identified as S/Moisan). Ana did not specify how many firearms she took over to S/Moisan's residence (later identified as 34965 Sweetwater Drive Agua Dulce, County of Los Angeles). She further stated S/Moisan took possession of the firearms and stored them inside of a safe, located in the garage. In addition, she confirmed that S/Moisan was involved in the same criminal case as her husband in 2008-2009. I uploaded the audio recording to the Palmdale Station shared files.

I re-contacted Ana regarding the specifics of the firearms later that day and she stated the following:

Ana told me she did not know what firearms she took to S/Moisan because the firearms were in boxes, some larger than others. She believed there were rifles in the larger boxes, but did not inspect the contents of the boxes to verify. I asked her if the firearms were ever retrieved from S/Moisan and she told me she was not aware of it. Furthermore, she explained Manuel was released from jail earlier this year and has been battling stage four cancer (no further detail). Given his medical status, they have been pre-occupied with doctor appointments. As far as Ana is concerned, the firearms were never retrieved from S/Moisan and she believes the firearms are still at S/Moisan's residence. In addition, Ana told me she did not deem the retrieval of the firearms to be a priority because Manuel's health condition has been the priority. When I asked Ana to contact S/Moisan regarding the firearms and arrange for S/Moisan to contact me, Ana stated "She's not going to meet with you at her house".

I inquired further, but Ana assured me S/Moisan would not want to meet with law enforcement due to the current condition (implying Manuel's arrest). Ana provided me with S/Moisan's cellular phone number (661-993-0816).

Ana pointed out S/Moisan's residence on a map (through a Google maps cellular application) and explained we would find Manuel's vehicles along with company vehicles parked at the indicated residence (34965 Sweetwater Drive).

Through Departmental resources, I confirmed S/Moisan is in fact a convicted felon as of 2009, therefore she would have been in violation of 29800(a)(1) PC (Felon in possession of a firearm) when she took possession of the firearms from Ana, as Indicated above.

I responded to S/Moisan's residence and knocked on the door several times, announcing my presence as a Los Angeles County Sheriff's Department deputy. There was no answer at the door and when I called S/Moisan's cellular phone, she did not answer. I observed seven vehicles (California License plates: 6RJM906, 7XAV612, 5MXF441, 8APC831, 4MMU959, 8AYG291, and 7E39544) parked on the property and noticed the rear doors to the location were open, however the screen doors were locked.

I instructed my assisting unit (268A Deputy Nemeth, Joshua #531796) to park near the location and monitor any traffic in and out of the residence. Deputy Nemeth did not see anyone arrive/leave the location during his surveillance.

I authored a search warrant to the location which was approved by the Honorable Judge Rob Villeza at 1840 hours. (See attached copy of search warrant for further)

The following personnel were present and assisted with the search:

- -Unit 2685: Sergeant Grimes, Nathan #468754 and Deputy Morris, Christopher #527190
- -Unit 268A: Deputy Nemeth, Joshua #531796
- -Unit 268: Deputy Dingman, Kyle #602363 and myself
- -Unit 260K: Deputy Waldron, Wyatt #521031 and Deputy Livingston, Jonathon #527888
- -Sergeant Dollens, Allen #408547 and Sergeant Knott, Theodore #454251
- -Unit 266/P: Deputy Winter, Jacob #622105 and Deputy Grussing, Jeffrey #551802

We conducted a knock/notice at the location and there was no answer at the door. We did not make forced entry due to the fact the rear screen door was open. We entered/cleared the location and did not locate anyone inside.

Deputy Waldron, Deputy Livingston and Sergeant Grimes were tasked with searching the attached garage located on the south/east side of the house. The following evidence was recovered inside of an unlocked safe, located inside of the garage:

- -17 handguns (EV-1 through EV-15). We were unable to identify the make, model, and caliber of two handguns. I took a separate photograph of those two handguns and uploaded them to the Palmdale Station shared files. The two unidentifiable handguns were stored in the evidence locker at Palmdale Sheriff's Station, pending identification from the evidence custodian and a supplemental report will be written at a later time.
- -Magazines (EV-21 and EV-22), and ammunition (EV-24).

In addition, the above personnel also recovered the following inside of a trash can located approximately eight feet away from the above described safe:

-8 rifles (EV-16 through EV-19), 3 shotguns (EV-20). We were unable to identify the make, model, and caliber of four rifles and two shotguns. I took separate photographs of those firearms and uploaded them to the Palmdale Station shared files. The six unidentifiable firearms were stored in the evidence locker at Palmdale Sheriff's Station, pending identification from the evidence custodian and a supplemental report will be written at a later time.

-Firearm parts (EV-23)

Sergeant Grimes photographed the above evidence in its place, prior to the recovery.

Deputy Grussing and Deputy Winter searched the master bedroom of the residence which was located in the north/west side of the house. The bedroom contained a single king size bed, fully furnished and a connecting large master bathroom. In addition, the drawers contained woman's clothing, undergarments, and it appeared to be inhabited due to the condition of the bed and bathroom. The bed had full bedding, it was neither dirty nor clean, and the bathroom had woman's makeup, clothing, and toiletries.

In the above described bedroom, Deputy Winter recovered the following in a drawer which was attached to the bed frame: (9) live 9mm rounds (EV-26) which were next to an empty gun box.

Sergeant Grimes photographed the above recovered evidence, in place, prior to recovering it from its location.

Deputy Morris and I located several documents addressed to S/Moisan inside of an office (located in the south/east section of the house) and on the kitchen counter. The documents had her name and above indicated address. I photographed several documents and collected four pieces of mail (EV-25) as evidence.

We uploaded all photographs to the Palmdale Sheriff's Station shared files.

Based on the fact we located the above evidence in an unsecured safe, plain sight, and accessible to S/Moisan, coupled with Ana's statements as to S/Moisan taking possession of the firearms in 2017. We formed the opinion the crime of 29800(a)(1) PC was being committed by S/Moisan.

Furthermore, during the course of our investigation, S/Moisan contacted Deputy Waldron and admitted she in fact had several firearms at her residence, belonging to Manuel Fernandez. However, she stated Manuel Fernandez retrieved the firearms at an unknown date/time, between June 2017 and today. S/Moisan further stated she did not plan on being home for the rest of the day.

It should be noted, I also photographed several photographs of Manuel Fernandez located at S/Moisan's residence. In addition, I also photographed pieces of mail addressed to Manuel Fernandez and work orders addressed to Manuel Fernandez which were located on the kitchen counters. The vehicles (listed above) parked at S/Moisan's residence were registered to "Agua Dulce Ranch LLC or Manuel

Fernandez." Therefore, I formed the opinion that S/Moisan is in fact Manuel's business partner and based on the above, the resident of the indicated location.

We were unable to locate S/Moisan at the time of this report.

A search of the serial numbers, to the handguns recovered, through the Automated Firearm System (AFS) revealed that only one handgun (EV-12) was registered to Manuel Fernandez (DOB 01-18-58). Two other handguns (EV-11 and EV-13) were also registered to a Tony Lo (05-26-54, EV-11) and Manuel Garcia (01-18-54, EV-13). The rest of the handguns recovered were not registered. (See attached AFS printout)

I also attached a printout of the 42 handguns registered to Manuel Fernandez.

DECLARATION OF DEPUTY JOHN ROTH

I, JOHN ROTH declare that if called and sworn, I would state the following under oath which is based on my personal knowledge;

- 1. I am over the age of 18 and am named as a defendant in this action.
- 2. At all times mentioned herein, I have been employed by the Los Angeles County Sheriff's Department as a Deputy Sheriff. In June 2018, I was the lead detective in the investigation of Manuel Fernandez's unlawful possession of firearms by a convicted felon and the seizure of those firearms, ammunition and other prohibited items.
- 3. The Sheriff's Department conducted or participated in a total of four searches of real property connected to Mr. Fernandez and his firearms. There were three warrant searches of Mr. Fernandez's home on Caprock Lane. The first two were conducted by the Sheriff's Department on June 14, 2018 and June 20, 2018. There was a third search of the home of Manuel Fernandez's business partner Carey Moisan on June 14, 2018. There was a forth search conducted by the Department of Justice with the assistance of the Sheriff's Department on or about June 21, 2018.
- 4. I was present at the first search of Caprock Lane on June 14, 2018. I arrived in my capacity as the detective who would be assigned the case. To the best of my recollection, I was at the Caprock Lane search on June 14, 2018 for approximately two (2) hours.
  - 5. On or about June 15, 2018, I swore out the warrant affidavit for the second

search of Manuel Fernandez's residence on Caprock Lane, and obtained the warrant. To the best of my recollection, I spent approximately three (3) to prepare and obtain the warrant from the judge. On or about June 20, 2018, my team and I participated in the execution of the second search at Caprock Lane or about June 20, 2018. The search team consisted of the following nine (9) deputies: me, Eitner, Ames, Grimes, Morris, Nemeth, Bowes, Thompson and Mejia. To the best of my recollection, the search team took approximately four (4) hours to search and seize the items from the Caprock Lane residence and return them to the Palmdale Station for booking. 

please explain to me the process that LASD officers go through, in your experience, to obtain a search warrant? So I'm talking about start to finish, what 4 are the steps that it takes to obtain a search warrant? 5

Α To obtain a search warrant, the affiant is going to have to articulate probable cause to support the seizure of persons or property under protection of the Fourth Amendment, articulate that probable cause coupled with a declaration of your affiant's expertise and reasoning behind the authoring of the warrant, completion of that, and seek out a judge to autograph -- to sign the warrant and support the warrant.

Now, that could be, during daytime hours, going to the local superior court and finding a judge that signs search warrants or contact the command post or contact a district attorney that will do a review, then submit to a judge for signing. The judge at that point will sign or deny a warrant based on the affiant's declaration of probable cause to support the warrant.

Once that is done, the affiant has a certain amount of time to serve the warrant, and it is with the constraints of daytime hours or night service if

Q All right. Thank you. I want to go back to the discussion we were having about the service of search warrants.

Are you aware of any LASD policies about the service of search warrants?

A Okay. Upon seizure of a firearm, a firearm is immediately rendered safe, meaning any source of ammunition or any ammunition is removed from the firearm. Once that is done, the firearm is taken into custody and is to be placed in an area for safekeeping to transport to the station.

most of our seizures of firearms are handguns -- they
fit inside small envelopes or bags.

Once that is done, those are set aside inside the secured area of the police -- of the car or whatever the transport vehicle is. It gets back to the station. If it's a long gun, it may be placed in an area of the vehicle where it is not going to be bounced around, it's not going to be susceptible to damage or contamination, if you will. And then it will be transported back to the station.

Once the evidence gets back to the station, it's removed from the car and it's taken to the evidence processing area, whether it's an evidence room, evidence counter, or if it's in evidence -- whatever, it's taken there.

At that point, the evidence will be entered into PRELIMS, which is our evidence-keeping system, and it will be logged in as such. Then an AFS sheet will be completed -- automated firearm search sheet will be completed, and submitted with the firearm.

The firearm will be tagged with the evidence tag and fixed in a safe condition. And once entered into the prelim system, it will be placed in an area for the records custodian or evidence custodian to do

Q So you were making -- you and others were making requests that central property assist with the seizure and transport ostensibly?

Absolutely. There's -- upon arrival on the 14th, now that we're establishing the 14th as the day of the initial seizure, as soon as I showed up, I said this is something central property needs to be for. Absolutely. I would say that the adjustments were made in line with the circumstances, with the absence of malice or absence of mistreatment.

Have you ever had any formal training on the proper procedures for booking seized property?

A Yes, ma'am. We all go through PRELIMS

## STAI ÉMENT OF PROBABLE CAUSE

The affiant (hereafter referred to as I) was assigned a case of Felon in Possession of a Firearm, a violation of 29800(a)(1) PC, LASD# 918-08710-2646-151.

On the 14th of June 2018 at approximately 0800 hrs. Los Angeles County Sheriff Deputies from the Palmdale Sheriff Station Partners against Crime (PAC) Team served a search warrant at 34710 Caprock Rd in the unincorporated city of Agua Dulce. The warrant was based on information provided via informant that the suspect, Manuel Fernandez (CII # A05128956) was a convicted felon and was in possession of firearms. The warrant, written by Deputy Wyatt Waldron (#521031) was granted via the Honorable Lisa Chung, North Court District, Antelope Valley Superior Court of Los Angeles County Division A-19. Upon service of the warrant over 400 firearms were found and seized. The seizure included pistols, rifles, shotguns and modern sporting rifles (assault weapons), along with thousands of rounds of ammunition and firearm manufacturing components. The warrant scope did not include electronic devices (cell phone, computers, tablets or other modern means of communication. Upon looking at the gravity of the seizure and quantity of modern firearm components it appeared as if S/Fernandez is/was involved in the illegal trafficking, manufacturing and distribution of firearms. S/Fernandez refused to answer questions regarding the firearms inside the residence. I spoke to his wife, Anna Patricia Fernandez (FW/02-29-60) who advised me S/Fernandez is active on his computer at all hours yet she is unsure what he is involved in as she does not use or access his computer. I believe S/Fernandez is actively and knowingly using his computer to search, buy and facilitate the illegal purchase and transfer of firearms via the internet and or third party applications.

### **NARRATIVE**

The purpose of this supplemental report is to provide active, additional information in regards to the arrest and investigation of S/Fernandez.

On the 14th of June Palmdale Deputies served a search warrant at S/Fernandez' home. In regards to that warrant service 488 illegal firearms were seized from the suspect's location. I spoke to S/Fernandez' wife (Anna Patricia Fernandez "Patty" FH/02-29-60 (818) 809-9689) during the search of the residence, she told me the following;

S/Fernandez has been collecting firearms as long as she has known him. S/Fernandez has held a seat on the NRA (National Rifle Association) national board and has been involved with firearms all over the United States. I asked what purpose such a large collection served, she stated they (the guns) were S/Fernandez' retirement plans. I asked what plan, she stated S/Fernandez planned to sell or trade the firearms upon retirement.

I advised Patty that S/Fernandez was a convicted felon and his mere possession of the firearms was illegal let alone the further crime of illicit sales as he possessed no FFL (Federal Firearms License). Patty stated, as far as she knew S/Fernandez' felony had been cleared as a misunderstanding, however she ultimately had no control over S/Fernandez and his actions. I asked her what her opinion was as to why S/Fernandez amassed such a collection, she stated S/Fernandez was a "hoarder" as evidenced by the masses of random items (books, knives, watches, scopes) S/Fernandez had stacked up to several feet high in his office, garage and storage container. I asked if S/Fernandez was selling any firearms, she stated she did not know if he sold but packages containing firearm "items" arrived almost every day via FEDEX and UPS. I asked Patty if S/Fernandez was active on-line, social media or on-line forums for the sales of firearms, she stated she did not know but he used his computer quite frequently.

I spoke to the Search Warrant Affiant, (Deputy Wyatt Waldron) and asked him about the firearms and if they had seen any evidence of sales, trafficking or illegal sales. He advised me their warrant covered the seizure of firearms only. He was unaware of any illicit sales.

On the 14th of June, after Palmdale deputies returned to the station with the considerable seizure I began looking through the extensive collection. I found he had several "multiples" of the same firearm. Most firearms appeared to be mid century military arms that could be easily bought, sold or traded across the United States without drawing
