Appellees write to notify the Court of recent orders in *Boland v. Bonta*, Ninth Circuit Case No. 23-55276, and *Renna v. Bonta*, Ninth Circuit Case No. 23-55367, two Second Amendment challenges to California's roster of handguns certified for sale. Both cases were submitted after briefing and oral argument before Judges Berzon, Rawlinson, and Bress. On March 25, 2024, the panel vacated the submission of both cases pending the en banc decision in *Duncan v. Bonta*, No. 23-55805, which was heard on March 19, 2024.

Because the decision of the en banc panel in *Duncan* may bear directly on the central issues of this case, Appellees support likewise vacating the submission of this case pending the *Duncan* decision.
