MOTION TO TERMINATE APPEARANCES

- 1. The Attorneys entered appearances on behalf of amicus ISA (Dkt. 33, 34) and sought leave to file an amicus brief in support of Plaintiffs' Motion for Preliminary Injunction on February 27, 2023 (Dkt. 35). The Court granted leave to file the amicus brief (Dkt. 47), and the amicus brief was filed on March 15, 2023 (Dkt. 50). The Court subsequently granted Plaintiffs' Motion for Preliminary Injunction and entered the preliminary injunction (Dkt. 101), which was subsequently vacated by the Seventh Circuit Court of Appeals (Dkt. 145).
- 2. Following the filing of the amicus brief on behalf of amicus ISA, the Attorneys have had no further involvement with or participation in these proceedings, and they did not participate in the bench trial on the merits. Nonetheless, the Attorneys continue to receive

Attorney Katie J. Colopy has now retired from the practice of law. 3.

4. In addition, Harrison Law LLC is not continuing as an organization and,

therefore, Michael L. Rice will not continue to represent ISA.

5. Because ISA's role as amicus with respect to the motion for preliminary

injunction has long concluded, and to avoid confusion, the Attorneys move to have their

appearances in this matter terminated so that they no longer receive notices related to

proceedings in this matter.

CONCLUSION

For the foregoing reasons, the Attorneys respectfully request that this Court terminate

their appearances in this matter and strike them from the roll of attorneys receiving notice of

proceedings going forward.
