I, Anna M. Barvir, hereby declare as follows:

1. I am an attorney licensed to practice before all courts in the state of California. The law firm where I am employed, Michel & Associates, P.C., is counsel of record for Plaintiffs Franklin Armory, Inc., and California Rifle & Pistol Association, Incorporated (collectively, "Plaintiffs"), in the above-entitled matter. 
1           7.       On or about November 14, 2023, counsel for Defendants took the noticed deposition of

3 Q. Of course.

4 MR. LAKE: Okay. If we take a break?

5 MR. BRADY: Sure.

22 Those are -- those are all privileged and not  
23 appropriate grounds for questioning. Does that make  
24 sense? So I mean, if you -- if the question is  
25 discussing legislation that, perhaps, was eventually

1 made public, you -- you can ask the witness those  
2 questions. But anything that never made it that far, is  
3 privileged.

4 BY MR. BRADY:

5 Q. Would the communications that you had,  
6 Ms. Mendoza, with the office of legislative affairs,  
7 necessarily, include an attorney?

8 A. Yes.

9 Q. Okay. So going back to the question before we  
10 went on a break for you to consult with your counsel,  
11 and keeping in mind the admonitions about privilege that  
12 your counsel just laid out, can you describe the  
13 legislation that you worked on in your role as director  
14 of Bureau of Firearms?

15 MR. LAKE: Well, I just -- you know, I'm going  
16 to also add the objection in addition to the previously  
17 stated one. It's overbroad, and we're kind of casting  
18 an overly wide net here because if we're talking about  
19 just legislation, in general, that has nothing to do  
20 with this case, then it's not -- you know, it's not  
21 gonna lead to discovery of admissible information. But  
22 I --

23 But go ahead and answer it, if you can.

24 THE WITNESS: I can't think of a specific one  
25 right now to give you an example.

1 BY MR. BRADY:

2 Q. Did you work on any legislation if your role as  
3 assistant director of BOF?

4 A. Yes.

5 Q. Can you recall any specific legislation you  
6 worked on in your role as assistant director?

7 MR. LAKE: And again, the same admonition, only  
8 public -- publicly-disclosed legislation.

9 THE WITNESS: I -- I can't think of an example  
10 right now.

11 BY MR. BRADY:

12 Q. Are you familiar with the term "dealer record  
13 of entry system"?

14 A. The dealer record of sale entry system, yes.

15 Q. Can you describe what it is?

16 A. The DES is a -- I'm sorry, the DROS entry  
17 system, which we refer to as "DES," is a web-based  
18 system that California firearms dealers and ammunition  
19 vendors use to submit applications to the Bureau to  
20 conduct firearm eligibility, background checks,  
21 ammunition background checks, records -- initiates the  
22 process for transfers of purchases.

23 Q. You use the term "DES."

24 Is that short for DROS entry system?

25 A. Correct.



1 Q. So if we use that term, you will understand it  
2 to mean the DROS entry system?

3 A. Correct.

4 Q. Okay. Did you participate in designing DES in  
5 any way?

6 A. Yes, at a -- yes.

7 Q. What was your role in designing DES?

8 A. I believe at that time, I was the Department of  
9 Justice Administrator II. That was when we were  
10 bringing the -- or implementing the DROS entry system.  
11 There were staff that were more intimately involved in  
12 the creation of it, but I oversaw the team that was  
13 working on the project, making sure that the system was  
14 designed to fit the needs, reviewing business rules,  
15 timelines for implementation, those types of things.

16 Q. What are business rules?

17 A. Business rules are what the Bureau of Firearms  
18 and one of the other divisions within in the Department,  
19 the Criminal Justice information services division, we  
20 work collaboratively with them on any IT-specific  
21 projects.

22 It's what we in the Bureau prepare as far as  
23 type -- the types of needs the business rules, like how  
24 the functionality should work, how the system, you know,  
25 the flows of things, the type of information that we

1 might need to capture, those types of things.

2 Q. And are -- do those business rules sort of  
3 layout the design requirements for the particular  
4 system?

5 A. I would say it's apart of the system designs,  
6 yes. It's kind of like, I said kind, it lays out all of  
7 the things that we need to capture, the types of  
8 functionality, the things that, you know, mandatory  
9 fields versus fields that are not mandatory, you know,  
10 how reports should look, types of information we might  
11 need in a report, those types of things.

12 Q. And how is it determined what is mandatory and  
13 not mandatory?

14 A. Usually, we are looking at what might be in  
15 statute that might specify what the Department has to  
16 capture, what we have to record. We'll also utilize  
17 regulations, so if that specifically lays out what might  
18 be mandatory or the type of information that an  
19 applicant or a dealer might have to provide, those are  
20 things that would be mandatory.

21 Q. And -- and you said "we." Did that include you  
22 looking at the statutory and regulatory guidelines? Or  
23 are you using the collective "we," as in the DOJ did  
24 that?

25 A. I would collectively say there are numerous

1 Q. In your. Is it your under --  
2 Can a rifle be an assault weapon?

3 MR. LAKE: Same objections.

4 THE WITNESS: I am not sure.

5 BY MR. BRADY:

6 Q. So your counsel just mentioned Senate Bill 118  
7 from 2020. Are you familiar with -- with that piece of  
8 legislation?

9 A. I'm aware of it, yes.

10 Q. If I refer to it as "SB 118," will you  
11 understand that I'm referring to Senate Bill 118 from  
12 2020?

13 A. Yes.

14 Q. Okay. Do you recall whether SB 118 had any  
15 affect on the Franklin Armory Title 1?

16 A. My understanding is SB 118 is what classifies  
17 the Title 1 as an assault weapon.

18 Q. Did the Title 1 meet any assault weapon  
19 definition before SB 118, to your knowledge?

20 MR. LAKE: Object. Calls for speculation.  
21 Calls for a legal conclusion.

22 Go ahead.

23 THE WITNESS: I don't believe prior to SB 118,  
24 that that had been determined. I -- no, I don't believe  
25 that it did.

1 BY MR. BRADY:

2 Q. I'm sorry. You don't believe it did what?

3 A. That it -- that it was defined as an assault  
4 weapon prior to SB 118, that the Franklin Armory Title 1  
5 was.

6 Q. You were assistant director of the Bureau of  
7 Firearms at that point in time; correct?

8 A. Correct.

9 Q. Do you recall whether the Bureau of Firearms  
10 had any policy relating to the Franklin Armory Title 1  
11 being an assault weapon or not?

12 MR. LAKE: Vague as to time. And also vague  
13 and ambiguous as to the term "policy."

14 Go ahead.

15 THE WITNESS: I don't have a recollection of a  
16 policy related to the Franklin Armory Title 1.

17 BY MR. BRADY:

18 Q. Do you recall whether BOF ever took any  
19 position on whether the Franklin Armory Title 1 was an  
20 assault weapon prior to SB 118?

21 A. I do not recall.

22 Q. Would it be fair to describe SB 118 as a budget  
23 trailer bill?

24 A. That's my recollection, yes.

25 Q. Can you explain what a budget trailer bill is?

1           A.     I would explain it as -- well, how do I explain  
2     it? Another mechanism, typically, my understanding is  
3     toward the end of the fiscal year, where various items  
4     can be inserted into a budget trailer bill, a different  
5     route than maybe the normal legislative process.

6           Q.     To your knowledge, does the legislature  
7     commonly use budget trailer bills to make changes to  
8     firearm definitions?

9           A.     I'm unsure.

10          Q.     Have -- have you ever seen another example,  
11     other than SB 118, of a budget trailer bill changing the  
12     definition of a firearm?

13          A.     I don't have a recollection of one.

14          Q.     Do you know why the change -- the -- the making  
15     of the Franklin Armory Title 1 into an assault weapon  
16     was done via a budget trailer bill?

17                 MR. LAKE: Object to the extent it calls for  
18     speculation, and legal conclusion.

19                 Go ahead.

20                 THE WITNESS: I -- I do not know.

21     BY MR. BRADY:

22          Q.     Did anyone at DOJ participate in drafting  
23     SB 118?

24                 MR. LAKE: Same objection. Calls for  
25     speculation. Lacks foundation.

1           Go ahead, if you can.

2           THE WITNESS: I -- I am not sure. I don't  
3 know.

4 BY MR. BRADY:

5           Q. Did you participate in drafting SB 118?

6           A. Not to my recollection.

7           Q. So it's possible that you could have, you just  
8 don't recall?

9           A. I don't recall.

10          Q. Do you recall whether anybody at DOJ proposed  
11 making the Franklin Armory Title 1 an assault weapon via  
12 SB 118?

13          A. I do not recall.

14          Q. Are you aware of any communication between DOJ  
15 and any legislators or -- or their legislative staff  
16 concerning SB 118?

17          A. I -- no.

18          Q. Do you know whether DOJ initiated contact with  
19 the legislature about making the Franklin Armory Title 1  
20 an assault weapon via SB 118?

21          A. I do not know.

22          Q. So you don't know whether DOJ asked the  
23 legislature to make this change? Or if the legislature  
24 asked DOJ for assistance in making the change?

25          A. I do not know.

1 Q. Do you know whether DOJ assisted in any way in  
2 making the change to SB 118 that made the Franklin  
3 Armory Title 1 an assault weapon?

4 MR. LAKE: Vague and ambiguous as to the term  
5 "assisted."

6 Go ahead.

7 THE WITNESS: I -- I don't re- -- I don't know.

8 MR. BRADY: I'd like to mark Exhibit 42.

9  
10 (Whereupon Exhibit 42 was marked  
11 for identification and is attached  
12 hereto.)  
13

14 BY MR. BRADY:

15 Q. Can you see on your screen, Ms. Mendoza, a  
16 document where in the upper left-hand corner, it says,  
17 "State of California budget change proposal cover  
18 sheet"?

19 A. Yes.

20 Q. Do you know what a -- what this document is?

21 MR. LAKE: Give her a few minutes to take a  
22 look at it, just because it's a -- it looks like it's  
23 14 pages.

24 MR. BRADY: Sure. So before you go and look at  
25 all of it, I'm simply asking about whether you know what

1 MR. BRADY: Well, now, I'm asking, to be clear  
2 at a high level, was anything done. Then once, if there  
3 have -- if anything has been done, then we can go piece  
4 by piece what was -- what, if anything, was done. So my  
5 question was -- because I don't know what I don't know.

6 BY MR. BRADY:

7 Q. What I want to know is whether anything was  
8 being done by DOJ at this -- during this period of  
9 2000 -- late 2019, into early 2020, relating to adding  
10 the term "other" to the long gun list on DES?

11 A. Conversations were had, as I mentioned earlier,  
12 between CJIS, Bureau of Firearms, attorneys, about the  
13 potential for the change. You know, resources, you  
14 know, making changes in addition to what the Department  
15 was already mandated to make changes, based on  
16 legislation that had passed, different events that were  
17 already in play, projects that were already in play.

18 To that extent, yes, work was being done. No  
19 actual changes to the system, at that point, were being  
20 done.

21 Q. But was there any actions taken, not to  
22 actually change the system, but action taken to  
23 eventually change the system at that time?

24 MR. LAKE: I'll just object. It's vague and  
25 ambiguous. And partially, it was asked and answered.



1 But go ahead, if you understand the question.

2 THE WITNESS: The action taken was just the  
3 conversations and the collaborative efforts to talk  
4 about what those -- those changes could look like.

5 BY MR. BRADY:

6 Q. So beyond conversations about adding the term  
7 "other" to the dropdown list of long guns on the DES  
8 system, no other action or work took place in DOJ, other  
9 than conversations, during the period of late 2019 into  
10 early 2020?

11 A. That is my recollection, correct.

12 Q. So the term "other" was eventually added to the  
13 dropdown list in DES, the long gun dropdown list in DES;  
14 is that correct?

15 A. Correct.

16 Q. All right. Do you recall when that was?

17 A. I believe it was October of 2020.

18 Q. October of 2020?

19 A. I believe so.

20 Q. So these conversations that were happening in  
21 late 2019, early 2020, about potentially changing DES to  
22 add the term "other," who was involved in those?

23 A. Well, I think I mentioned already, bureau  
24 subject matter experts, CJIS staff, specifically, the  
25 application and development bureau staff, various legal

1 staff, likely, the director of the Bureau of Firearms.

2 Q. So why did those conversations not materialize  
3 into action at that time to make the change to DES to  
4 add the term "other"?

5 A. Well, there's competing priorities that have to  
6 be analyzed. There's resource needs. There's funding.  
7 And then when you get into 2020, there's COVID and  
8 things that had to all be kind of weighted and factored  
9 into the decision of when new projects could be added on  
10 to what is already at play.

11 Q. Do you know who made the decision not to move  
12 forward with the change to DES at that time in early  
13 2020?

14 MR. LAKE: Well, objection. It assumes facts  
15 not in evidence that any such decision occurred early in  
16 2020. It's also vague and ambiguous as to what you mean  
17 by "early." But there's been no testimony about the  
18 exact time of when such a decision was even made or when  
19 it was made.

20 But go ahead, if you can.

21 BY MR. BRADY:

22 Q. Was a decision made -- I'll rephrase.

23 Was a decision made to not move forward  
24 with a change to DES to add "other" to the long gun  
25 dropdown list in early 2020?

1 MR. LAKE: Again, same objection to the term  
2 "early 2020."

3 But go ahead.

4 THE WITNESS: Conversations were still ongoing.  
5 I don't recall a decision that it would not be done. It  
6 was still -- conversations were still ongoing and just  
7 managing all the different multiple priorities and the  
8 resource restraints.

9 BY MR. BRADY:

10 Q. Does DOJ assign levels of importance to changes  
11 that are being considered to DES?

12 A. Not sure what you mean by "levels of --

13 Q. Sure. So you said there are competing  
14 priorities. Is there somebody who assigns prioritize --  
15 priority to any given proposal, proposed change to DES?

16 A. Typically, priorities are set by management  
17 staff, leadership within the Department. Things that'll  
18 take priority that have, you know, new legislative  
19 mandated time frames for implementation. Things of that  
20 nature where we're -- where we're tied to a specific  
21 date.

22 Q. So there's no system whereby DOJ says this  
23 change, this JIRA is of high priority? Medium? Low?

24 A. There is a functionality in the JIRA system to  
25 select a -- I guess, we'll call it a "priority level."

1 I don't know if that's what it's called in the JIRA  
2 system specifically. Staff, as I mentioned, enter  
3 those, so that doesn't necessarily mean that that is the  
4 Department's priority in that specific JIRA.

5 And JIRAs get logged for all the various  
6 different systems. We have to prioritize all the  
7 different requests and all the different legislative  
8 changes that are taking place at that time.

9 Q. Was a priority level given to the proposed  
10 change to add "other" to DES?

11 MR. LAKE: Object. That it's vague as to time.

12 THE WITNESS: I'm not familiar with that  
13 specific JIRA.

14 BY MR. BRADY:

15 Q. You're not -- you're not -- I'm sorry.

16 What was your?

17 A. Are you asking about when we did, in fact, add  
18 the "other" to the dropdown?

19 Q. No, I was talking about when the conversations  
20 were occurring in late 2019, early '20 -- early 2020.

21 Was there -- was a priority given to those  
22 conversations about how -- how quickly DOJ should decide  
23 that issue?

24 MR. LAKE: I just want to interpose an  
25 objection because you're misstating the prior testimony

1 change to add other to DES was finished in October of  
2 2020; is that correct?

3 A. I did say that, but I believe I misstated, and  
4 it was October 2021.

5 Q. Okay. So you -- you were just misremembering  
6 the year; is that fair?

7 A. Yes.

8 Q. Okay. Now, does your -- does that change your  
9 testimony that conversations about making the change of  
10 adding other to the DES system, began in late 2019?

11 A. That does not change my testimony on that.

12 Q. Okay. So conversations began on whether to add  
13 other to the DES long gun dropdown list in 2000 -- the  
14 end of 2019, and a JIRA did not get created to begin  
15 that change until August 6, 2021; is that correct?

16 A. That's correct.

17 Q. Okay. Do you know who submitted this JIRA?

18 A. I am not sure if the reporter that is listed on  
19 the JIRA, is the person that submitted the JIRA. If  
20 that is the case, then it would be Christina  
21 Rosa-Robinson.

22 Q. Do you recall whether you played any role in  
23 submitting this JIRA?

24 A. No, I -- I would not have directed Christina to  
25 submit the JIRA. She works for CJIS.

1 Q. Okay. So if it was Christina who submitted  
2 this JIRA, does that mean that it would have -- the  
3 request would have been made by CJIS?

4 A. Not necessarily. Again, things are very  
5 situational sometimes, so it could have just been  
6 through the discussions, that she, you know, had the  
7 availability to submit the JIRA, based on the  
8 conversations that were taking place between the  
9 two bureaus. I don't --

10 Q. Do you recall? I'm sorry?

11 A. I don't recall who would have given her the  
12 direction, the explicit direction to log the JIRAs.

13 Q. Do you recall having conversations with her  
14 about this JIRA?

15 A. I do not recall.

16 Q. Would a request that somebody submit a JIRA,  
17 from higher up, would that generally be made, that  
18 request generally be made in writing?

19 A. Not necessarily, no.

20 Q. Are they ever made in writing?

21 A. Potentially, I -- I -- I'm not sure.

22 Q. You're not sure if you've ever seen a request  
23 for a JIRA made in writing?

24 A. It would be likely that there would be  
25 direction that, you know, please have so and so log a

1 JIRA for that, that type of communication.

2 Q. So on page 6 of Exhibit 45 in the comments, it  
3 says, "Other gun functionality is due to deploy on  
4 October 1st, 2021 with the second AWR registration and  
5 AWR other gun registration"; right?

6 A. Yes.

7 Q. So is it your understanding of that, that the  
8 update to the DES was happening simultaneously with the  
9 other gun assault weapon registration to be done to  
10 deploy by October 1st, 2021?

11 A. Yes.

12 Q. So going back to Exhibit 44, can you see  
13 Exhibit 44 on your screen now?

14 A. Yes, I can.

15 Q. Okay. Thank you.

16 On the very last page, there are three -- I'm  
17 sorry -- yeah, three headings; one is minimum viable  
18 product. Do you understand what that means?

19 A. Yes, I do.

20 Q. Can you explain, please?

21 A. Typically, it's used to reference, I'll say,  
22 the minimal amount of product to meet a specific mandate  
23 or expectation.

24 Q. Okay. Excuse me. So for the, like, specific  
25 task at hand, that's like the -- the bare minimum of

1     what needs to be done?  Is that basically what it means?

2           A.     Yes.

3           Q.     Okay.  So -- and then the next one down, it  
4     says, "requirement."  Do you know what that means?

5           A.     These are requirements of -- for the system,  
6     you know, what the system is required or what  
7     requirements should be included in the solution.

8           Q.     And then -- excuse me -- impact.

9                   Do you know what that means?

10          A.     Appears to be impacts to systems or impact to  
11     outcomes.

12          Q.     So under impact, the second item identified as  
13     D1.1, do you see that?

14          A.     I do.

15          Q.     It says, "Purpose code for other gun.  Purpose  
16     codes have been modified since the original other gun  
17     project and will need to be revisited."

18                   Do you see that?

19          A.     Yes.

20          Q.     Do you know what the original other gun project  
21     is that's being referenced there?

22          A.     I -- I'm not sure of what this is referencing.

23          Q.     Do you know who would know what that's  
24     referencing?

25          A.     Probably, the individual that created this



1 document.

2 Q. And that would be Ms. Rosa-Robinson?

3 A. Appears she included that in this attachment.  
4 I don't know if she's the person that created the  
5 document.

6 Q. Going down to D1.8 under impact, it says, "DES  
7 firearm" -- "firearm type other will model gun type  
8 rifle." Do you see that?

9 A. I do see that.

10 Q. Do you know what that means?

11 A. I would take it to mean that it will follow the  
12 same flow of a rifle transaction, likely, with the same  
13 types of fields.

14 Q. So going back to -- excuse me -- Exhibit 45,  
15 the JIRA, and it had a commencement date or a submission  
16 date of August 6, 2021; correct?

17 A. Correct.

18 Q. To your knowledge, had any actions been taken  
19 to add the term "other" to the long gun dropdown list on  
20 DES prior to that date? Meaning, actions meaning,  
21 other -- something beyond conversations?

22 MR. LAKE: Object that it's been asked and  
23 answered.

24 But go ahead.

25 THE WITNESS: Not to my recollection, no.

1 MR. LAKE: Well, I'm just gonna object that  
2 it's overbroad. I'm -- we're just talking about the  
3 Title 1; right?

4 MR. BRADY: Sure.

5 MR. LAKE: You said whether --  
6 BY MR. BRADY:

7 Q. Yeah, whether -- we can limit it to the Title  
8 1.

9 Was Franklin Armory's ability to sell the Title  
10 1 taken into account of these multiple factors?

11 A. We would have spoke to the Department's  
12 attorneys about those types of claims and that they're,  
13 in fact, there.

14 Q. So going to paragraph 9 of your declaration,  
15 Exhibit 46, it says, "ADB with CJIS undertook a review  
16 of what would be required to add the other option to the  
17 gun-type dropdown menu in the DES dealer long gun sale  
18 transaction type"; right? Do you see that?

19 I'm sorry. Did you respond, Ms. Mendoza?

20 A. I did, yes.

21 Q. Okay. Sorry. I didn't hear that.

22 When did ADB and CJIS undertake this review  
23 that you describe?

24 MR. LAKE: I'll just -- just to clarify, vague  
25 and ambiguous as to time.

1           Do you mean when they started? Or they  
2           completed it? Or just the entire time? Or something  
3           else?

4       BY MR. BRADY:

5           Q.     When -- when did they start it?

6           MR. LAKE:   Okay.

7           THE WITNESS: I can't speak to the exact date  
8           of when it started. It was somewhere in that late 2019,  
9           early 2020, timeframe.

10       BY MR. BRADY:

11          Q.     And do you recall how long that review took?

12          A.     I do not.

13          Q.     Do you recall what it entailed?

14          A.     What -- what the review entailed?

15          Q.     Yes.

16          A.     It would involve looking at what changes would  
17           be necessary, the length of work, the impact to  
18           projects, personnel, essentially, what's stated in that  
19           paragraph there.

20          Q.     Apologies for the delay. There was a siren  
21           going by very loud, right outside my window, so wanted  
22           to spare everybody the --

23           MR. LAKE: Oh, okay. You're good.

24           MR. BRADY: Yeah, I put it on mute so you  
25           couldn't hear it.

1 MR. LAKE: Oh, okay.

2 MR. BRADY: That's why it was delayed.

3 BY MR. BRADY:

4 Q. So it says in the next sentence, "At some point  
5 ADB reported back that it would take many months to  
6 implement this enhancement and would require well over a  
7 dozen personnel, many of whom would have to be diverted  
8 from other projects." Do you see that?

9 A. Yes.

10 Q. Do you agree with that statement?

11 A. I do.

12 Q. When did ADB make this report back?

13 A. I don't know the exact date.

14 Q. Do you recall who from ADB made the report  
15 back?

16 A. I do not know specifically, no.

17 Q. Do you recall whether it was in writing? Or --  
18 or verbal?

19 A. I do not.

20 Q. Do you know whether there are any documents  
21 documenting this report back?

22 A. Not to my recollection.

23 Q. So on what are you basing your statement in  
24 your declaration that ADB reported back?

25 A. My recollection of -- my recollection of events

1 of con- -- I don't wanna say "conversations," but I  
2 guess, my memory of the impacts to the -- to the  
3 workload to the potential project.

4 Q. So when you prepared this declaration, you were  
5 basing this statement about ADB saying it would take  
6 many months. That's based on your memory?

7 A. Correct.

8 Q. And the statement that ADB said it would  
9 require well over a dozen personnel, is there any  
10 written documentation supporting that statement?

11 MR. LAKE: Just going to interpose an objection  
12 as to time. I know we're talking about late 2019, 2020,  
13 but there's obviously testimony about the actual  
14 modification or enhancement that was done in 2021, and  
15 you -- you already have a lot of deposition testimony  
16 about how long that took. But it's -- not too get too  
17 far into it, but are you talking about all time? Or  
18 just specifically 2019, 2020?

19 MR. BRADY: I'm asking about in this statement  
20 in Ms. Mendoza's declaration --

21 MR. LAKE: Okay.

22 MR. BRADY: -- that says ADB reported back at  
23 some point, she doesn't recall when, that the  
24 enhancement would require over a dozen personnel.

25 MR. LAKE: Okay.

1 BY MR. BRADY:

2 Q. Was that statement made in writing? I'm sorry.

3 Did you answer --

4 A. If I had an opportunity to go back and look at  
5 some, I might be able to find something in writing, but  
6 my recollection is based on my memory of the events back  
7 then, that because of the various systems that it would  
8 impact, is why it takes numerous personnel. The time  
9 that it would take, it would be very burdensome.

10 Q. So in preparing this statement in your  
11 declaration in saying, "Well over a dozen personnel  
12 would be required, according to ADB."

13 You were relying on your memory?

14 A. Correct.

15 Q. You did not consult any writings or anything in  
16 confirming that statement; is that correct?

17 A. Correct.

18 Q. So going to paragraph 10, it says, "ADB  
19 additionally explored the possibility of doing a DES  
20 enhancement that was reduced in scope temporary and  
21 applicable to only the Title 1 firearm."

22 You see that?

23 A. Correct.

24 Q. How do you know that ADB explored this  
25 possibility?

1       A.    This is my recollection of what I mentioned  
2 earlier about potential of doing some sort of free-form  
3 field.  Again, I don't remember all the -- the details  
4 of that temporary fix, but I remember that it had  
5 something to do with a -- like, a free-form field.

6       Q.    You -- you mean, like, when you say "free-form  
7 field," you mean, in a dropdown menu of DES?

8       A.    No.  I -- and this -- I can't remember if it  
9 was part of, like, the comment field that is a free-form  
10 field within DES.  I remember it was specific to we  
11 would advise dealers maybe to type in something specific  
12 related to the Franklin Armory Title 1.

13            I just remember it had to do with the free-form  
14 field, but I don't know if it -- I can't remember if it  
15 was the existing comment field that's already a  
16 free-form field.

17       Q.    And -- and just to be clear, you're talking  
18 about a free-form field in DES; right?

19       A.    Correct.

20       Q.    Okay.  And you describe that DES enhancement as  
21 a temporary one; right?

22       A.    Correct.

23       Q.    Why would it be temporary?

24       A.    Temporary until they could implement the longer  
25 more permanent fix, which would be described in the

1 paragraph 9 of actually adding the other to the  
2 dropdown.

3 Q. Do you recall who in ADB was doing this  
4 analysis?

5 A. I believe, there's multiple people.

6 Q. Do you recall who any of them were? Or their  
7 titles?

8 A. I recall Rodney Smith, who's the director of  
9 the applicant development bureau. Cheryle Massaro, I  
10 don't know her exact title. Those are the two that are  
11 coming to mind on the ADB side.

12 Q. And you say that they were exploring a possible  
13 enhancement to DES applicable only to the Title 1  
14 firearm; is that correct?

15 A. Correct.

16 Q. And what prompted that? What prompted an  
17 exploration of changing DES to only address the Title 1  
18 firearm?

19 MR. LAKE: Just want to interpose an objection  
20 to the extent that it calls for attorney-client  
21 communications. And I'm, again, harkening back to my  
22 statement earlier in the deposition, of the timing if  
23 there was a government claim had been presented and a  
24 threat of a damages lawsuit in this timeframe.

25 Go ahead and answer, if you know.



1           THE WITNESS: I -- I'll refer to what Mr. Lake  
2 just explained, that the threat of lawsuit prompted us  
3 looking into whether there was possible solutions.

4 BY MR. BRADY:

5           Q. So DOJ was aware of Franklin Armory's issue  
6 with the Title 1 in DES when ADB was considering changes  
7 to the DES to account for other firearms; is that  
8 correct?

9           MR. LAKE: It's asked and answered.

10          But go ahead.

11          THE WITNESS: Let me make sure I understand  
12 your question. At the time that ADB was looking into  
13 these, we were aware of the potential or the threat  
14 of -- of lawsuit, which is correct, yes. So we were  
15 aware of the Franklin Armory Title 1.

16 BY MR. BRADY:

17          Q. Thank you.

18               Is this ADB potential option that it explored  
19 in writing anywhere, to your knowledge?

20          A. Potentially.

21          Q. Did you consult any writing about that in -- in  
22 drafting paragraph 10 of your declaration?

23          A. No, I did not.

24          Q. So you're basing that off memory, as well?

25          A. Correct.

1 Q. So in the next sentence, it says, "Under this  
2 proposal, a permanent enhancement would be implemented  
3 at a later date"; is that right?

4 A. Correct.

5 Q. What would be the difference between a  
6 temporary enhancement being proposed and the permanent  
7 enhancement?

8 MR. LAKE: Object. It's asked and answered.

9 Go ahead.

10 THE WITNESS: So the difference would be one  
11 used, utilizing fields that already exist in DES versus  
12 adding to the dropdown for the permanent fix. Scope of  
13 work is different. Time to implement is different.

14 BY MR. BRADY:

15 Q. Okay. ADB estimated such an enhancement would  
16 take a few months; is that right?

17 A. For the temporary fix, correct.

18 Q. Is that -- oh, that's with respect to the  
19 temporary fix, would take a few months?

20 A. Correct.

21 Q. Okay. Because it comes after -- okay. It  
22 comes after a discussion of permanent enhancement, but  
23 you're -- you're -- that was, like, the permanent  
24 enhancement discussion was sort of just a -- an  
25 explanation of the temporary fix, and then you're

1 continuing on your discussion in the next sentence about  
2 the temporary fix; is that right?

3 A. Yes, that statement was intended for the  
4 temporary fix.

5 Q. Got it. And are you basing that on your  
6 recollection as well?

7 A. Correct.

8 Q. So in the next sentence, it says, "ADB advised  
9 that this proposal would present operational  
10 difficulties in properly recording the sales and  
11 transfers of the Title 1 firearm in the DES until a  
12 permanent enhancement was implemented."

13 Do you see that?

14 A. Yes.

15 Q. Do you recall what operational difficulties ADB  
16 identified?

17 A. My recollection is, because the temporary fix  
18 was utilizing a free-form field where dealers could,  
19 essentially, type in anything, that it would make it  
20 very difficult for us to be able to track those firearms  
21 and identify those firearms in the systems.

22 Q. And that's your recollection again?

23 A. Correct.

24 Q. You didn't consult any writing in making this  
25 statement in your declaration?

1           A.     Correct.

2           Q.     Okay. And the next sentence, "Such operational  
3           difficulties would have raised significant public safety  
4           concerns." Do you see that?

5           A.     Yes.

6           Q.     What public safety concerns were there?

7           A.     Public safety concerns of not being able to  
8           identify these records in the system, to not be able to  
9           track them and go -- be able to research them after the  
10          fact. There's a potential for miss typings and errors  
11          and how we might direct dealers to enter the  
12          information, making it difficult.

13          Q.     So going back up to paragraph 4 of your  
14          declaration, in the penultimate sentence of paragraph 4.

15                 Sorry. I couldn't resist.

16                 It says --

17                 MR. LAKE: I have to Google that word.

18                 THE WITNESS: Yeah.

19                 MR. BRADY: I'm not making up words.

20                 I promise.

21                 MR. LAKE: Go ahead.

22          BY MR. BRADY:

23                 Q.     The -- the second to last sentence in  
24                 paragraph 4 of your declaration, it says, "In my  
25                 experience at any given time, there are numerous pending

1 requests for enhancements to be made total DES."

2 Do you see that?

3 A. Yes.

4 Q. Is there a chart or a log or some document that  
5 identifies the number of pending requests at any given  
6 time about pending requests to be made to the DES?

7 A. I believe, the JIRA system has the ability to  
8 track that information and filter that information.

9 Q. Are you aware of any other system, outside of  
10 JIRA, that would be able to track pending requests to  
11 change DES?

12 A. No, that would be the inclusive program that  
13 would track everything.

14 Q. So the next sentence, the last sentence of that  
15 paragraph, it says, "Such request can arise from, among  
16 other things, new or amended statutes, new or amended  
17 regulations, court decisions and technological  
18 advancements, to name a few."

19 Do you see that?

20 A. I do.

21 Q. Do you recall whether, during mid 2019 until  
22 May 2020, if there was any new or amended statutes that  
23 would affect DES?

24 MR. LAKE: I'll just object to the extent I  
25 think it's been asked and entered, at least partially.

1 But go ahead.

2 THE WITNESS: So my recollection is there were  
3 multiple legislative changes. One that comes to mind is  
4 related to the mental health and the two 5150s within a  
5 12-month period. That went into effect January 1, 2020.  
6 I think it's AB 1968, if I remember correctly.

7 Again, I think I stated earlier, I believe this  
8 was also a period of time in which we were working  
9 through the bullet button assault weapon challenges and  
10 the potential of opening -- reopening that registration  
11 period.

12 Did I complete your question? Sorry. Were  
13 you --

14 BY MR. BRADY:

15 Q. Yes. Yes. You -- assuming that's the --

16 A. Yes.

17 Q. -- extent of your recollection of what was --  
18 then, yes.

21 my role as assistant bureau chief, I may be involved in



## **Analysis of Problem**

### **A. Budget Request Summary**

The Department of Justice (DOJ) requests \$128,000 Dealers' Record of Sale Special Account in 2020-21, \$862,000 in 2021-22, and \$14,000 annually thereafter to regulate assault weapons that are currently not defined as a rifle, pistol, or shotgun. This proposal intends to fix current loopholes in statute that allow manufacturers to make weapons that circumvent the intention of assault weapon laws. The DOJ also requests trailer bill language necessary to implement this proposal.

### **B. Background/History**

Existing law generally prohibits the possession or transfer of assault weapons, except for the sale, purchase, importation, or possession of assault weapons by specified individuals, including law enforcement officers. Under existing law, "assault weapon" means, among other things, a semiautomatic centerfire rifle or a semiautomatic pistol that has the capacity to accept a detachable magazine and has any one of specified attributes, including, for rifles, a thumbhole stock, and for pistols, a second handgrip.

Existing law requires that, with specified exceptions, any person who, prior to December 31, 2016, lawfully possessed an assault weapon prior to the date it was defined as an assault weapon, and which was not specified as an assault weapon at the time of lawful possession, register the firearm with DOJ.

Chapter 48, Statutes of 2016 (SB 880) and Chapter 40, Statutes of 2016 (AB 1135) require any person who possessed an assault weapon that did not have a fixed magazine and an additional feature, as defined in Penal Code section 30515, from January 1, 2001 to December 31, 2016, to register the firearm with DOJ.

Under current law, it is possible to legally purchase and possess a firearm that has all of the features of a banned assault weapon, such as a forward pistol grip or grenade launcher, without registering it with DOJ, due to a loophole that requires assault weapons to be defined as either a rifle, pistol or shotgun. This represents a public safety risk as the Legislature has deemed such firearms as a danger to the state and have continually attempted to prevent the sale and possession of these kinds of firearms from the public.

Firearms that DOJ seeks to prohibit in the proposed trailer bill language are those with features of a banned assault weapon that are not legally defined as a rifle, pistol, or shotgun, and thus do not fall under the current definition of an assault weapon and registration requirements. This legislation seeks to address this loophole in the law by prohibiting the sale and possession of these firearms, commencing July 1, 2020, unless an individual registers the firearm with DOJ. The proposed trailer bill language also revises the definition of assault weapon to include any firearm that is not a rifle, pistol or shotgun, does not have a fixed magazine and an additional feature, as specified in Penal Code section 30515.

## C. State Level Consideration

The Bureau of Firearms serves the people of California through education, regulation, and enforcement actions regarding the manufacturing, sale, ownership, safety training, and transfer of firearms. Bureau of Firearms staff are leaders in providing firearms expertise and information to law enforcement, legislators, and the public in a comprehensive program to promote legitimate and responsible firearms possession and use by California residents. The proposed trailer bill language will require DOJ to implement and regulate a new registration program.

## D. Justification

The proposed trailer bill language will require individuals to register their firearms with assault weapon features with DOJ before January 1, 2022, but not before the effective date of the regulations prescribing the requirements of the registration period.

## **Analysis of Problem**

DOJ estimates that there will be roughly 10,000 to 15,000 firearms registered by approximately 3,000 to 5,000 applicants. It is estimated that these registrations will result in revenue of approximately \$100,000 to \$150,000, which will not be sufficient to cover the costs associated with administering the registration program, however, the Dealers' Record of Sale Special Account is anticipated to have sufficient revenue to support this proposal.

Implementation of this new program will require funding to allow DOJ to hire 7 limited-term positions (6 Crime Analyst Is, Range B and 1 Crime Analyst II), as well as overtime hours from a Special Agent Supervisor and Office Technician in the Bureau of Firearms to address the new workload. The positions and overtime hours are required beginning July 1, 2021 through June 30, 2022.

The scope of work for the 6 Crime Analyst Is includes processing of the assault weapon registrations which includes ensuring firearms meet the prescribed characteristics to qualify for the registration period, as well as conducting analyses of criminal history and background/clearance checks on applicants to determine if the applicant may possess a firearm. These functions involve inquiries into various database systems, the request and review of various files, and contact with other entities to verify any firearms prohibiting records.

The scope of work for the Crime Analyst II is primarily as a trainee and lead analyst. This would include training the Crime Analyst Is on how to analyze a criminal record and determine an applicant's eligibility to own or possess a firearm, and providing guidance on the more complex firearm eligibility background checks.

Overtime of 184 hours from a Special Agent Supervisor is required to train the Crime Analysts I on assault weapon identification and review any unusual or niche firearms for legality.

Overtime of 300 hours from an Office Technician is necessary to handle the payment processing of applications, including ensuring applicants have included a check for the correct amount and preparing the checks for deposit, and mailing applicable letters to the applicant, and maintaining workload statistics.

Implementation of this bill will also require temporary help hours in the Hawkins Data Center to address the information technology impacts of the statutory change. The staff hours are required beginning January 1, 2021 through July 1, 2021.

The scope of work for an Information Technology Specialist I (1,090 hours) includes developing the online web application and ensuring that the application runs correctly.

The scope of work for an Information Technology Specialist II (1,090 hours) includes developing the online web application and integrating the information with existing firearms applications, such as the assault weapon registration portal.

Additionally, ongoing funding is required for increased data storage costs beginning in 2020-21.

## **E. Outcomes and Accountability**

This proposal seeks to effectively close the current assault weapon registration loophole, resulting in increased public safety and the reduced risk of a prohibited person gaining possession of an assault weapon.

### **F. Analysis of All Feasible Alternatives**

Alternative One – Approve the requested Trailer Bill Language and Resources  
Approve \$128,000 Dealers' Record of Sale Special Account in 2020-21, \$862,000 in 2021-22, and \$14,000 annually thereafter to regulate assault weapons that are currently not defined as a rifle, pistol, or shotgun. In addition, approve the requested trailer bill language.

Alternative Two – Approve the requested Trailer Bill Language without the necessary funding  
Approving the requested language would allow DOJ to impose the necessary registration requirements for this type of firearm. However, without the requested resources necessary to process the registrations and modify the internet website, DOJ would be in a precarious position, and would need to redirect resources from other critical public safety programs. This option is not feasible and would pose public safety risks in other critical areas.

Alternative Three – Do not approve the requested Trailer Bill Language or resources  
Without the requested language and resources, the public will be at great risk of these assault-style weapons being sold and used in the commission of a crime or obtained by a prohibited person. This option is not in line with the mission of DOJ or the safety of the communities and individuals within this State.

### **G. Implementation Plan**

Upon approval, DOJ will immediately begin the necessary hiring processes.

**Penal Code section 30515 is amended to read:**

(a) Notwithstanding Section 30510, "assault weapon" also means any of the following:

(B) A thumbhole stock.

(C) A folding or telescoping stock.

(2) A semiautomatic, centerfire rifle that has a fixed magazine with the capacity to accept more than 10 rounds.

(A) A threaded barrel, capable of accepting a flash suppressor, forward handgrip, or silencer.

(B) A second handgrip.

(C) A shroud that is attached to, or partially or completely encircles, the barrel that allows the bearer to fire the weapon without burning the bearer's hand, except a slide that encloses the barrel.

(D) The capacity to accept a detachable magazine at some location outside of the pistol grip.

(5) A semiautomatic pistol with a fixed magazine that has the capacity to accept more than 10 rounds.

(6) A semiautomatic shotgun that has both of the following:

(A) A folding or telescoping stock.

(B) A pistol grip that protrudes conspicuously beneath the action of the weapon, thumbhole stock, or vertical handgrip.

(7) A semiautomatic shotgun that ~~has the ability to accept a detachable magazine~~ does not have a fixed magazine.

(8) Any shotgun with a revolving cylinder.

(9) A semiautomatic centerfire firearm that is not a rifle, pistol, or shotgun, that does not have a fixed magazine, but that has any one of the following:

(A) A pistol grip that protrudes conspicuously beneath the action of the weapon.

(B) A thumbhole stock.

(C) A folding or telescoping stock.

(10) A semiautomatic centerfire firearm that is not a rifle, pistol, or shotgun, that has a fixed magazine with the capacity to accept more than 10 rounds.

(11) A semiautomatic centerfire firearm that is not a rifle, pistol, or shotgun, that has an overall length of less than 30 inches.

(b) For purposes of this section, "fixed magazine" means an ammunition feeding device contained in, or permanently attached to, a firearm in such a manner that the device cannot be removed without disassembly of the firearm action.

(c) The Legislature finds a significant public purpose in exempting from the definition of "assault weapon" pistols that are designed expressly for use in Olympic target shooting events. Therefore, those pistols that are sanctioned by the International Olympic Committee and by USA Shooting, the national governing body for international shooting competition in the United States, and that were used for Olympic target shooting purposes as of January 1, 2001, and that would otherwise fall within the definition of "assault weapon" pursuant to this section are exempt, as provided in subdivision (d).

(d) "Assault weapon" does not include either of the following:

(1) Any antique firearm.

(2) Any of the following pistols, because they are consistent with the significant public purpose expressed in subdivision (c):

The fees shall be deposited into the Dealers' Record of Sale Special Account.

(b) (1) Any person who, from January 1, 2001, to December 31, 2016, inclusive, lawfully possessed an assault weapon that does not have a fixed magazine, as defined in Section 30515, including those weapons with an ammunition feeding device that can be readily removed from the firearm with the use of a tool, shall register the firearm before July 1, 2018, but not before the effective date of the regulations adopted pursuant to paragraph (5), with the department pursuant to those procedures that the department may establish by regulation pursuant to paragraph (5).

(2) Registrations shall be submitted electronically via the Internet utilizing a public-facing application made available by the department.

(3) The registration shall contain a description of the firearm that identifies it uniquely, including all identification marks, the date the firearm was acquired, the name and address of the individual from whom, or business from which, the firearm was acquired, as well as the registrant's full name, address, telephone number, date of birth, sex, height, weight, eye color, hair color, and California driver's license number or California identification card number.

(4) The department may charge a fee in an amount of up to fifteen dollars (\$15) per person but not to exceed the reasonable processing costs of the department. The fee shall be paid by debit or credit card at the time that the electronic registration is submitted to the department. The fee shall be deposited in the Dealers' Record of Sale Special Account to be used for purposes of this section.

(5) The department shall adopt regulations for the purpose of implementing this subdivision. These regulations are exempt from the Administrative Procedure Act (Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code).

(c) (1) Any person who, prior to July 1, 2020, lawfully possessed an assault weapon as defined by paragraphs (9), (10), or (11) of subdivision (a) of Section 30515, and is eligible to register an assault

(2) Registration applications shall be submitted in a manner and format to be specified by the department in regulations adopted pursuant to paragraph (5).

(3) The registration application shall contain a description of the firearm that identifies it uniquely, including all identification marks, the date the firearm was acquired, the name and address of the individual from whom, or business from which, the firearm was acquired, as well as the registrant's full name, address, telephone number, date of birth, sex, height, weight, eye color, hair color, and California driver's license number or California identification card number, and any other information that the department may deem appropriate. The registration application shall also contain photographs of the firearm, as specified by the department in regulations adopted pursuant to paragraph (5).

(4) For each registration application, the department may charge a fee that consists of (A) the amount the department is authorized to require a dealer to charge each firearm purchaser under subdivision (a) of Section 28233, not to exceed the reasonable processing costs of the department; and (B) the amount sufficient to cover the public education campaign costs of the department. For registration applications seeking to register multiple firearms, the fee shall increase by five dollars (\$5) for each additional firearm after the first. The fee shall be paid in a manner specified by the department in regulations adopted pursuant to paragraph (5) at the time the registration application is submitted to the department. The fee shall be deposited in the Dealers' Record of Sale Special Account to be used for purposes of this section.

(5) The department shall adopt regulations for the purpose of implementing this subdivision and paragraphs (9), (10), and (11) of subdivision (a) of Section 30515. These regulations are exempt from the Administrative Procedure Act (Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code).

**Penal Code section 30955 is amended to read:**

(a) Except as provided in subdivision (b),

the department's registration procedures shall provide the option of joint registration for any assault weapon or .50 BMG rifle owned by family members residing in the same household.

(b) For registration of assault weapons in accordance with subdivision (c) of Section 30900, joint registration is not permitted.

SEC. X.

No reimbursement is required by this act pursuant to Section 6 of Article XIII B of the California Constitution because the only costs that may be incurred by a local agency or school district will be incurred because this act creates a new crime or infraction, eliminates a crime or infraction, or changes the penalty for a crime or infraction, within the meaning of Section 17556 of the Government Code, or changes the definition of a crime within the meaning of Section 6 of Article XIII B of the California Constitution.

**- DOJ’S DEFACTO BAN OF NON-RIFLE / NON-SHOTGUN LONG GUNS**

Dear Attorney General Becerra,

I write on behalf of Franklin Armory, Inc. (“Franklin Armory®”) regarding their inability to process the transfer of firearms within the State of California due to design limitations of the California Department of Justice Dealer Record of Sale Entry System (“DES”).

As is detailed below, the limitations of the DES prevent the lawful acquisition, transfer, and/or sale of firearms that fall outside the bounds of pistol, rifle, and/or shotgun – a category of firearms that have a long history of use within the state. Such technological restrictions are preventing my client from selling, transferring, and/or delivering their lawful products, such as their recently announced Title 1™ firearm and firearms configured with their CSW® California Compliance Kit as well as violate their First, Second, and Fourteenth Amendments to the United States Constitution, and California State law, causing damages to Franklin Armory®.

#### **PROCEDURAL HISTORY**

California Penal Code section 26500 prohibits any person from selling a firearm within the State of California unless the person is licensed by the State to sell firearms, some exceptions apply. Penal Code section 26535 exempts transfers between manufacturers of firearms, such as Franklin Armory® and licensed California firearms dealers. Thus, California residents seeking to acquire firearms must do so through licensed California firearms dealers.

In part, the requirement that all firearm generally be processed through a licensed California firearms dealer is designed to mandate that the licensed dealers gather information necessary to perform background checks on the applicants and information relating to the firearm for firearm registration purposes. Regarding the latter, Penal Code section 28160 mandates that “for all firearms, the register or record of transfer shall include all of the following [information relating to the firearm]:

(2) The **make** of firearm.

(7) **Manufacturer's name** if stamped on the firearm.

(8) **Model** name or number, if stamped on the firearm.

(9) **Serial** number, if applicable.

(10) **Other number**, if more than one serial number is stamped on the firearm.

(11) **Any identification number or mark assigned** to the firearm pursuant to Section 23910.

(12) If the firearm is not a handgun and does not have a serial number, identification number, or mark assigned to it, a notation as to that fact.

(13) **Caliber**.

(14) **Type of firearm**.

(15) If the firearm is **new or used**.

(16) **Barrel length**.

(17) **Color** of the firearm.

Penal Code section 28155 mandates that the Department of Justice prescribe the form of the register and the record of electronic transfer pursuant to Section 28105. And, Penal Code section 28105 mandates that "the Department of Justice shall develop the standards for all appropriate electronic equipment and telephone numbers to effect the transfer of information to the department."

In response, the Department of Justice created the DES. In designing and developing the DES, however, the Department of Justice elected to implement a closed system that utilizes drop down lists instead of open field for certain data entries. As described in the DES User's Guide, the process for entering the sale of a long gun is, in part, as follows:

#### **Dealer Long Gun Sale**

Select the **Dealer Long Gun Sale** transaction type when a Long Gun is being purchased from a dealer.

#### **To submit a Dealer Long Gun Sale transaction:**

1) From the *Main Menu* page, select the **Submit DROS** link. The *Select Transaction Type* page will display.

2) Select the **Dealer Long Gun Sale** link. The *Submit Dealer Long Gun Sale* form will display.

3) Enter the Purchaser Information (see Entering Purchaser and Seller Information above).

4) Enter the Transaction and Firearm Information as follows:

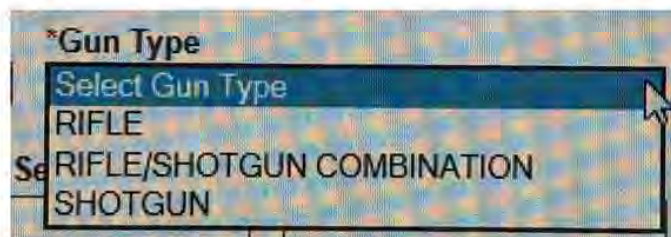

j. **Gun Type** – Select the type of long gun from the Gun Type drop down list.

Though the DES User's Guide is void of any information relating to the available Gun Types listed in the dropdown list, at the time of this writing the list consisted of the following options:

Unfortunately, this list is incomplete and fails to include options for the many long guns that are neither “Rifles” nor “Shotguns.”

This defect could have been prevented by including within the list the various types of other long guns, or simply including a single catch-all within the list such as “Other.”

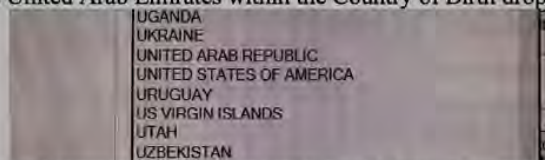
This defect, however, has severely impacted my client’s business and reputation. On or about October 15, 2019, Franklin Armory® announced their new product, Title 1™, which generated a substantial amount of interest. Soon after the announcement, Franklin Armory® was notified by licensed California firearm dealers that they would not be able to transfer the firearms due to technological limitations of the DES.

As a result, Franklin Armory® is unable to fulfill its orders, which continue to accrue daily. Franklin Armory® anticipates that even the delay of a few months in the correction of the system will result in the loss of approximately \$2,000,000 in profits, if not more.

As a result, Franklin Armory® President Jay Jacobson has been in contact and requested that the DES be corrected immediately to prevent the loss of sales and to preserve the reputation of Franklin Armory® within the industry and among its consumers. He has been advised that the Department of Justice is working on correcting the issue but was also informed that no timeline for the correction of the defect has been established. As such, this letter serves to both reiterate the importance of correcting the defect in the DES expediently, and to express and preserve legal and financial the impact that the defect has on Franklin Armory®.

**ADDITIONAL ETHNICITY BASED OMISSION DEFECTS IN THE DES**

It is important to note that the “gun type” omission is not the only defect relating to errors and omissions in the DES’s dropdown list. At the time of this writing, the DES’s technical limitations prevent any person born in the United Arab Emirates from purchasing firearms, even if they are United States Citizens who are not otherwise prohibited from possessing firearms. This defect and violation of rights based upon ethnicity occurs due to a similar failure to include the United Arab Emirates within the Country of Birth dropdown list in the DES:



This glaring omission has and will continue to violate the rights of those citizens until this defect is corrected.

## CONSTITUTIONAL VIOLATIONS

### *DUE PROCESS*

The Due Process Clause of the Fourteenth Amendment of the Constitution of the United States forbids the several States from depriving any person of life, liberty, or property without due process of law. Under color of state law, the Department of Justice is subjecting Franklin Armory®, its dealers, and its citizens to a deprivation of liberty and property without due process of law.

The defect within the DES essentially bans the sale, acquisition, transfer, delivery, and possession of lawful product in violation of the Due Process Clause doctrine. The ban forbids expression without giving fair notice of what is forbidden; as such, it is an unconstitutional deprivation of liberty and property without due process of law. This *defacto* ban violates the Due Process Clause doctrine regarding overbreadth. (See, e.g., *Coates v. City of Cincinnati*, 402 U.S. 611 (1971).) It also forbids a substantial amount of constitutionally protected speech; as such, it is an unconstitutional deprivation of liberty and property without due process of law. And, this ban violates the Due Process Clause doctrine regarding deprivations of property. (See, e.g., *Matthews v. Eldridge*, 424 U.S. 319 (1976).)

Finally, the ban deprives the local licensed firearms dealers of the complete and lawful use of their license issued by the Department of Justice and does so without supplying adequate pre-deprivation notice and an opportunity to be heard; as such, it is an unconstitutional deprivation of property without due process of law. In each of these respects, the defacto ban constitutes an unconstitutional abridgement of Due Process Clause rights both facially and as applied to these circumstances.

### *SECOND AMENDMENT VIOLATION*

Possession of lawful firearms in California is not a mere privilege. Fortunately, the Second Amendment protects a person's right to keep and bear firearms. The Second Amendment provides: "A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed." U.S. Const. amend. II. "As interpreted in recent years by the Supreme Court, the Second Amendment protects 'the right of law-abiding, responsible citizens to use arms in defense of hearth and home.'" *Teixeira v. Cty. Of Alameda*, 873 F.3d 670, 676–77 (9th Cir. 2017), cert. denied sub nom. *Teixeira v. Alameda Cty.*, 138 S. Ct. 1988 (2018) (quoting *District of Columbia v. Heller*, 554 U.S. 570, 635 (2008)). At the core of the Second Amendment is a citizen's right to have in his and her home for self-defense common firearms. *Heller*, 554 U.S. at 629. "[O]ur central holding in *Heller* [is] that the Second Amendment protects a personal right to keep and bear arms for lawful purposes, most notably for self-defense within the home." *McDonald v. City of Chicago*, 561 U.S. 742, 780 (2010).

As evidenced by California's own crime statistics, the need to protect one's self and family from criminals in one's home has not abated no matter how hard they try. Law enforcement cannot protect everyone. "A police force in a free state cannot provide everyone with bodyguards. Indeed, while some think guns cause violent crime, others think that wide-spread possession of guns on balance reduces violent crime. None of these policy arguments on either side affects what the Second Amendment says, that our Constitution protects 'the right of the people to keep and bear Arms.'"

*Silveira v. Lockyer*, 328 F.3d 567, 588 (9th Cir. 2003) (Kleinfeld, J., dissenting from denial of rehearing *en banc*). However, California citizens, like United States citizens everywhere, enjoy the right to defend themselves with a firearm, if they so choose.

Not because of any statute, regulation, rule, or law, but merely as a result of improper design, the DES prohibits the California citizens from enjoying the right to defend themselves with a lawful firearm of their choice.

#### *TORTIOUS INTERFERENCE WITH A PROSPECTIVE ECONOMIC ADVANTAGE*

Under California law, intentional interference with prospective economic advantage has five elements: (1) the existence, between the plaintiff and some third party, of an economic relationship that contains the probability of future economic benefit to the plaintiff; (2) the defendant's knowledge of the relationship; (3) intentionally wrongful acts designed to disrupt the relationship; (4) actual disruption of the relationship; and (5) economic harm proximately caused by the defendant's action. (*Korea Supply Co. v. Lockheed Martin Corp.* (2003) 29 Cal.4th 1134, 1164–1165.).

As referenced above, Franklin Armory® has announced the sale of their Title 1 product and has begun taking orders on the Title 1. The Department of Justice has been notified of these orders and the inability of Franklin Armory®, and/or any licensed California firearms dealer to process these orders due to defects in the implementation of the DES, and a breach of duty by the Department of Justice pursuant to Penal Code sections 28105 and 28155. In refusing or delaying any corrections to the DES to permit the sale of lawful firearms, the DES is intentionally engaging in wrongful acts designed to disrupt current and future business of Franklin Armory®.

#### **DEMAND**

Franklin Armory® has, always, sought to cooperate and work with the California Department of Justice. It was not, and is not, my client's desire to make caselaw. On the contrary, the extraordinary effort taken by Franklin Armory® demonstrates their desire to partner *with* law enforcement to limit liabilities on all sides, including the end-user. When, however, the Department of Justice exceeded its authority and implemented a defacto ban on the sale of lawful firearms via technological limitations of the State mandated, designed, implemented and maintained DES, it substantially interfered with the rights and business relationship of Franklin Armory® and its customers. As a result, it is reasonable to anticipate the need for litigation to ensure my client is made whole.

Due to the delete and destruction policies of the California Department of Justice, Bureau of Firearms, we are hereby informing you that the Department of Justice has a duty to preserve evidence and prevent the spoliation of any information that may be relevant to this matter, including but not limited to, any and all correspondence, writings, emails, logs, telephone records, texts, or other of communication or writings, as that term is defined in Evidence Code section 250, related to or referring to the DES "gun type" fields, changes to the DES, long guns that are neither rifles nor shotguns, Franklin Armory, Inc., Jay Jacobson, Jason Davis, or Title 1. "[A] litigant is under a duty to preserve evidence which it knows or reasonably should know is relevant to the action." (*In re Napster, Inc. Copyright Litig.*, 462 F. Supp. 2d 1060, 1067 (N.D. Cal. 2006)). The duty attaches "from the moment that litigation is reasonably anticipated." (*Apple Inc. v. Samsung Electronics Co.*,

*Ltd.*, 881 F. Supp. 2d 1132, 1136 (N.D. Cal. 2012).) “Once a party reasonably anticipates litigation, it must suspend its routine [evidence] retention/destruction policy and put in place a ‘litigation hold’ to ensure the preservation of relevant [evidence].” (*Zubulake v. UBS Warburg*, 220 FRD 212, 218 (S.D.N.Y. 2003).) Where a party has violated its duty to preserve evidence and engaged in spoliation, federal courts have the inherent power to impose sanctions. (*See Sherman v. Rinchem Co., Inc.*, 687 F.3d 996, 1006 (8th Cir. 2012) (citations omitted)). Sanctions may include monetary sanctions, an adverse inference jury instruction, striking claims or defenses, exclusion of evidence, and default or dismissal.

As such, and in order to mitigate past and future damages that have or could further result from action or inaction, Franklin Armory® now demands as follows:

1. That the Department of Justice immediately correct the defect in the DES by permitting the sale of long guns that are neither shotguns nor rifles, such as the Title 1.
2. That the Department of Justice pay any and all damages that are incurred due to the refusal and/or delay in the correction of defects in the DES.

26 1. I am the Director of the Bureau of Firearms (Bureau) in the California Department of  
27 Justice's (Department) Division of Law Enforcement (DLE). I have served in this capacity since  
28

1 March 2023. As the Director of the Bureau, I provide administrative direction, policy guidance,  
2 and control of enforcement and regulatory programs and projects. I act as a liaison with the  
3 firearms industry and members of law enforcement, and have appeared before California  
4 legislative committees concerning bills affecting the Bureau's operations. I have served in the  
5 Department since 1994 and the Bureau since 2009.

6 2. Prior to becoming the Director of the Bureau, I served as Assistant Bureau Chief from  
7 2015 until March 2023. At some point, the title of this position changed to Assistant Bureau  
8 Director. As the Assistant Bureau Chief/Director, I was responsible for managing all activities  
9 under the Regulatory Branch, including approximately 30 highly visible and sensitive state-  
10 mandated programs, and directing the work of technical, professional, and supervisory staff. I  
11 also served as the Department's Federal Bureau of Investigation (FBI) National Instant Criminal  
12 Background Check System (NICS) Point of Contact (POC).

13 3. In my role as Assistant Bureau Chief/Director, I had responsibility for management and  
14 oversight of the Dealer Record of Sale (DROS) Entry System ("DES"). The DES is a web-based  
15 application used by California firearms dealers to submit firearm background checks to the  
16 Department to determine if an individual is eligible to purchase, loan, or transfer a handgun, long  
17 gun, and ammunition, and subsequently receive background eligibility check determinations.

18 4. The Application Development Bureau (ADB) within the Department's California Justice  
19 Information Services Division (CJIS) supports the Department's information technology  
20 infrastructure. ADB is responsible for designing, implementing, and maintaining DLE's  
21 applications, which includes the DES. In my experience, at any given time, there are numerous  
22 pending requests for enhancements to be made to the DES. Such requests can arise from, among  
23 other things, new or amended statutes, new or amended regulations, court decisions, and  
24 technological advancements, to name a few.

25 5. In my role as Assistant Bureau Chief/Director, I may be involved in the discussions  
26 relating to DES enhancement requests. Such discussions, and the decision-making process as to  
27 whether to move forward with a DES enhancement, are often collaborative and often involve the  
28 Bureau, ADB, the Department's attorneys, and occasionally higher levels within the Department,

1 such as DLE, CJIS, and the Directorate Division. These discussions and the decision making  
2 process—which can include whether to move forward with the enhancement, the parameters of  
3 the enhancement, the timeline for completion and deployment of the enhancement—require the  
4 relevant parties within the Department to engage in a balancing of multiple factors and a  
5 weighing of competing priorities among multiple information technology projects pending at any  
6 given time. These discussions and the decision making process involve weighing enhancements  
7 mandated by statutes, regulations, or court orders; allocation of available resources for a  
8 particular enhancement (such as the required number of personnel it will take to complete the  
9 project); the available budget for such an enhancement; and the time it will take to complete said  
10 enhancement. In addition, considerations of public safety are very important. Thus, any  
11 proposed DES enhancement must be evaluated in terms of the certainty that it will not  
12 compromise the Department’s ability to meet its mandated obligations and its responsibility to  
13 ensure public safety.

14 6. The issue regarding the Franklin Armory Title 1 firearm was first brought to my  
15 attention in the latter part of 2019. My understanding is that Franklin Armory was asserting that,  
16 within the DES “Dealer Long Gun Sale” transaction type, this new Title 1 firearm did not fit any  
17 of the three options in the “Gun Type” drop-down menu, which were rifle, rifle/shotgun  
18 combination, or shotgun. It is my understanding that the three options in the “Gun Type” drop-  
19 down menu in the DES “Dealer Long Gun Sale” transaction type had remained the same since at  
20 least 2014, before I became Assistant Bureau Chief in 2015.

21 7. Franklin Armory asserted these three options in the “Gun Type” drop-down menu for  
22 the “Dealer Long Gun Sale” transaction type precluded dealers from processing a transfer of the  
23 Title I firearm in the DES. It was my understanding that Franklin Armory asserted that the  
24 addition of an “other” to the “Gun Type” drop-down menu in the DES “Dealer Long Gun Sale”  
25 transaction type was necessary.

26 8. At some point after the latter part of 2019, the Bureau initiated a review to evaluate the  
27 resources required for a potential DES enhancement to add an “other” option in the “Gun Type”  
28 drop-down menu in the “Dealer Long Gun Sale” transaction type. This review required the

1 leadership of the Bureau, in collaboration with ADB and the Department's attorneys, to engage in  
2 a balancing of multiple factors and a weighing of competing priorities among the multiple  
3 proposed DES enhancement requests pending at that time. We also evaluated and weighed the  
4 allocation of available resources to such an enhancement, such as the number of personnel  
5 required, budgeting of the enhancement, and the time it would take to complete said  
6 enhancement. The onset of the COVID-19 pandemic in March 2020 presented additional  
7 difficulties in being able to staff such a DES enhancement.

8 9. ADB, within CJIS, undertook a review of what would be required to add the "other"  
9 option to the "Gun Type" drop-down menu in the DES "Dealer Long Gun Sale" transaction type.  
10 At some point, ADB reported back that it would take many months to implement this  
11 enhancement, and would require well over a dozen personnel, many of whom would have to be  
12 diverted from other projects. Implementing this DES enhancement would have required changes  
13 to many other applications and databases in addition to the DES.

14 10. ADB additionally explored the possibility of doing a DES enhancement that was  
15 reduced in scope, temporary, and applicable to only the Title 1 firearm. Under this proposal, a  
16 permanent enhancement would be implemented at a later date. ADB estimated such an  
17 enhancement would take a few months. ADB also advised that this proposal would present  
18 operational difficulties in properly recording the sales and transfers of the Title 1 firearm in the  
19 DES until a permanent enhancement was implemented. Such operational difficulties would have  
20 raised significant public safety concerns. These factors, including the public safety concerns,  
21 were discussed within the Department, which ultimately decided to not immediately proceed with  
22 the temporary DES enhancement.

23 11. SB 118 was signed into law by the Governor on August 6, 2020, which rendered the  
24 Title 1 firearm a prohibited assault weapon under Penal Code section 30515. The Department  
25 thereafter decided, after weighing competing priorities among the multiple information  
26 technology projects pending at that time in the middle of the COVID-19 pandemic, to implement  
27 at a later date the DES enhancement that added an "other" option in the "Gun Type" drop-down  
28

1 menu in the "Dealer Long Gun Sale" transaction type. This enhancement was completed on  
2 October 1, 2021.

18 MS. BARVIR: Thank you.

19 THE WITNESS: To give you the right names for the  
20 right dates, I would have to research that.

21 Q BY MR. ADAMS: Just give me the names overall.  
22 For that time period, who were the firms you were working  
23 with? You said two to three?

24 A I believe -- my dates could be off a little  
25 because of the whole COVID thing and everything kind of

1 runs after that.

2 I believe one was Wild West Marketing. I would  
3 have to look the others up. I don't recall because it's  
4 not our current one.

5 Q Okay. Who is your current rep?

6 A Maschmedt and Associates. M-A-S-C-H-M-E-D-T.

7 Q Wild West Marketing, do you know where they were  
8 located?

9 A I'm not 100 percent sure. But if I had to guess,  
10 I would say Idaho.

11 Q In Boise?

12 A I think Idaho is as close as I can get without  
13 looking it up.

14 Q Okay. Wild West Marketing and there's probably  
15 one or two others, but you don't recall those names right  
16 now?

17 A Correct.

18 Q Okay. And where is Maschmedt and Associates,  
19 where are they out of?

20 A I want to say -- they just moved their office, so  
21 maybe Kansas City now. It was Washington state.

22 Q Okay. Does Maschmedt, do they have individual  
23 reps that have, like, a territory that they are assigned  
24 to?

25 A That's how the reps work, yes.

1           Q     Okay. How many specific individual reps do you  
2 have, or do they have?

3           A     They handle more than just our line, so I don't  
4 know how many total in their company.

5           Q     Okay. So if you have a problem with a dealer in  
6 Chico, you call the Maschmedt rep and then he goes and  
7 handles the problem with this dealer; is that the way it  
8 works?

9                     MS. BARVIR: I'm going to enter an objection for  
10 the trade secrets and invasion of privacy.

11                    Go ahead and answer to the extent you can, David.

12                   THE WITNESS: That's how it works in an ideal  
13 circumstance.

14           Q     BY MR. ADAMS: Okay. So right now if we had a  
15 problem like the CA7 problem that you were discussing  
16 before, if that happened with a dealer in Chico, would  
17 they call the rep or would they call you?

18           A     Either one of those things could happen.

19           Q     Okay. And you were offered here -- you can  
20 provide testimony on some deposits that were entered with  
21 Franklin Armory. When I say deposits, I'm talking about  
22 the five dollar deposits that were offered on this  
23 Title 1. Do you recall that process where you set up the  
24 deposits?

25           A     I recall those were sold over our website direct

1 to consumers.

2 Q Okay. So when you would sell a deposit directly  
3 to somebody on your website, is that a difference outside  
4 of your standard operating sales procedure?

5 A I would say it's not standard. We sell to  
6 consumers direct on our website with most of our products  
7 and always have. It's another sales channel.

8 Q Okay. Have you ever had that process --

9 A All firearms get transferred.

10 Q I'm sorry. I interrupted you. Please go ahead.

11 A All firearms, of course, sold through our website  
12 are legally and properly transferred through a dealer.

13 Q What does that mean? If I want to go on your  
14 website, I can buy a weapon, but I have to have it shipped  
15 to a dealer and then the dealer records that transfer?

16 A Yes. So we comply with federal law and state  
17 laws. And we only ship items legally to where they're  
18 going, to a dealer to then process all the state and  
19 federal paperwork to transfer it to the customer.

20 Q Is that different than if I am -- I mean,  
21 obviously, there is a different set of state laws. But  
22 can I buy something direct from your website if I live in  
23 Idaho?

24 A All firearms have to be transferred through a  
25 dealer.



1 Q Okay. And that's a federal rule?

2 A Yes.

3 Q Okay. So when you were taking these deposits on  
4 the Title 1, did you assign a dealer to each of those  
5 transactions?

6 A Customers generally send in an FFL for their  
7 dealer or contact info when their item is ready to ship.

8 Q Okay. So you -- so the answer is no, then. You  
9 only have an FFL when the item is ready to ship?

10 A That's generally how we like it.

11 Q Okay. So when they -- when somebody goes on your  
12 website and they submit a five dollar deposit, they don't  
13 have to assign an FFL at that point?

14 A Only before the item ships.

15 Q Okay. And to your knowledge, did any of the  
16 Title 1 firearms ever ship?

17 MS. BARVIR: Objection. Vagueness as to which  
18 Title 1 firearms you are referring to.

19 MR. ADAMS: Let me rephrase that.

20 Q BY MR. ADAMS: Any of the Title 1s that a deposit  
21 was put down on, did you ever fulfill any of these orders  
22 and ship to the dealer?

23 A I don't recall. I don't believe we shipped any  
24 to California.

25 Q Okay. Do you think you shipped some to other



1 states, though?

2 A I think we did, but I'm not sure.

3 Q Okay. And if you had done that, then you would  
4 have -- that purchaser would have had to assign an FFL to  
5 that Title 1 to receive it, correct?

6 A Correct.

7 Q Was there another time that you are aware of that  
8 Franklin Armory accepted deposits on a weapon?

9 A I believe we've accepted preorders on other  
10 items.

11 Q Okay. And do all preorders, do they have a  
12 deposit that's required?

13 A I believe we've done it that way. Not all of  
14 them.

15 Q Okay. And you are the PMQ. You were designated  
16 as the person who can testify as to the deposits. And my  
17 question was not just on preorders, but has Franklin  
18 Armory ever accepted deposits for a purchase in the past?

19 A Yes.

20 Q Okay. And which weapons were those that you  
21 accepted deposits on?

22 A I don't recall, off the top of my head.

23 Q Was it multiple times that you have accepted  
24 deposits?

25 A We have accepted deposits multiple times.

1 part of your job -- right? -- dealing directly with  
2 customers, right? You just deal with the dealers and  
3 distributors, right?

4 A It's my department, but I don't handle that  
5 e-mail account.

6 Q Okay. So you can see somebody saying -- this  
7 person here -- I'm going to zoom in so you can see it  
8 better.

9 All right. This person says: "In 2019 or 2020,  
10 while I was living in California, I put deposits on four  
11 Title 1 firearms to join a class action suit against the  
12 California Department of Justice regarding their inaction  
13 in adding the 'other' category for the Franklin Armory  
14 title," I'm sorry, "rifle to the California gun roster."  
15 And then, "As of July 2020, I no longer live in California  
16 and do not fulfill the requirements of class in this legal  
17 action." And then the person asks for a refund.

18 Is this the -- this is the person who would have  
19 signed -- they would have gotten your e-mail and they  
20 would have signed up and submitted a deposit to join what  
21 they call a class action suit, or is this the person you  
22 said would buy a California engineered firearm just for  
23 curiosity, if you know?

24 A As far as I can tell, it seems like somebody  
25 bought four of them, wanted four of them, couldn't get

1     them, so they joined the class action suit. And then  
2     moved out of state so they no longer needed them because  
3     they can buy guns they can't have in California.

4             MS. BARVIR: I needed to interject on objection  
5     on speculation about what that third person had in mind  
6     when they wanted to buy a gun. Sorry I didn't put that in  
7     advance.

8             But your answer is fine.

9             MR. ADAMS: Right. And when I am asking you a  
10    question like that, I don't want you to speculate. If you  
11    don't know the reason that somebody has done something,  
12    I'm just asking you questions about your own personal  
13    knowledge.

14            Q     BY MR. ADAMS: And did you talk to anybody that  
15    was asking for refunds on their deposit? Did you ever  
16    interact with somebody that was requesting their money  
17    back?

18            A     No, I don't believe so.

19            Q     Okay. You had said before, you don't recall --  
20    there was a Sacramento declaratory relief action. Do you  
21    recall -- were you involved at all with that?

22            A     I don't recall that. I mean, I may or may not  
23    have been involved in it, but I really don't remember  
24    anything, really, about it.

25            Q     Okay. Did you submit a declaration or offer any

1 testimony in advance of that declaratory relief action?

2 A Not that I recall.

3 Q Would you speak with any of the dealers or your  
4 reps about that declaratory relief action?

5 A Not that I recall.

6 Q You said before that Mr. Jacobson had referenced  
7 you were sitting in a dealership, you got word that one of  
8 the dealers was worried about the lack of the "other"  
9 option. And this was something called -- you had said  
10 this was called a surplus, right? Dom's Surplus?

11 A Are we discussing the thing we discussed earlier?

12 Q Yeah. So this is -- you were in the store called  
13 Dom's Surplus when one of the dealers told you they had  
14 trouble with the "other" option?

15 A They didn't tell me they had trouble with the  
16 "other" option; they told me it didn't exist.

17 Q Okay. And there is somebody working there by the  
18 name of Josh, but you don't recall his last name?

19 A Correct.

20 Q Okay. And was there any other dealers that you  
21 spoke to that had complained of the same problem?

22 A Like I said, I received more than ten calls, as  
23 we discussed earlier, about not being able to get an  
24 "other" option to transfer. And I don't recall who all of  
25 those people were.

1 Q Okay.

2 A Some of those calls could have even come from  
3 reps on behalf of the dealer.

4 Q So it may have been from a dealer; it may have  
5 been from a rep. You don't remember.

6 A Correct.

7 Q Okay. And if I asked you to name who those  
8 dealers or those reps were, you would be speculating if  
9 you had to give those names, right?

10 A Yeah, I do not remember, to give you the correct  
11 information.

12 Q Okay. And you said now there's ten -- you said  
13 before there was less than that, I believe. Do you have  
14 an approximate estimate for how many phone calls you got  
15 like this?

16 A I thought we established that, but I would have  
17 to go back and check. But I thought when we discussed it  
18 earlier that it was at least ten.

19 Q Okay. Well, regardless of what you said before,  
20 as you are as you sitting here now, do you recall how many  
21 phone calls you think you got about this missing "other"  
22 option?

23 A I would have to refer to whatever I gave you in  
24 my previous answer.

25 Q Okay. You don't recall as you sit here now?

1       A     I believe what I gave you the number before was  
2 accurate, as best of my ability.

3       Q     We had talked earlier about something called a  
4 Mossberg Cruiser. Are you familiar with that firearm?

5       A     We have not talked about that at all.

6       Q     I'm sorry. The royal "we." The -- in this  
7 litigation, Mr. Jacobson mentioned --

8       A     Oh.

9       Q     -- the Mossberg Cruiser. Are you familiar with a  
10 Mossberg Cruiser?

11      A     I think I am picturing that in my head.

12      Q     Okay. Is that a shotgun?

13      A     I don't know what the legal classification is for  
14 that in the State of California.

15      Q     Does a Mossberg Cruiser have a stock, if you  
16 know?

17      A     I do not believe it does.

18      Q     A stockless shotgun, is that something that can  
19 exist?

20            MS. BARVIR: I'm going to object on the status  
21 that this is outside -- is irrelevant to the subject  
22 matter of this deposition.

23      Q     BY MR. ADAMS: Fine. If you don't know the  
24 answer, you just tell me that. But I'm trying to figure  
25 out if you have the same understanding that Mr. Jacobson,



1 Q Okay. Did you -- you said that you dealt with  
2 the dealers much more directly in 2019 but then by the end  
3 of 2019, you had kind of phased out of dealing with the  
4 dealers; is that right?

5 A I still deal with a fair amount of dealers. But,  
6 yes, less nowadays than it used to be.

7 MS. BARVIR: I want to object that it was  
8 misstating his testimony from earlier. But go ahead.

9 Q BY MR. ADAMS: So in 2019 you dealt directly with  
10 the dealers more than you do now, but you still deal with  
11 them somewhat now, right?

12 A That sounds accurate.

13 Q Okay. And what were the dealers telling you --  
14 when somebody like Josh at Dom's Surplus, when he had  
15 trouble finding a definition for a rifle when he was going  
16 to purchase it, how do they process that transfer in 2019?

17 A I'm confused because you just described a  
18 scenario that we haven't discussed nor happened.

19 Q Okay. Well, the reason I brought up this  
20 Mossberg Cruiser, it's a shotgun, I guess without a stock  
21 or I -- I don't know. And I don't know the terminology.  
22 That's why I'm having to rely on you for it.

23 But if you are going to process this  
24 Mossberg Cruiser on some online system and you have a  
25 question about it, I'm trying to figure out how the dealer

1     dealt with that prior to 2019.

2           A     I would guess that they would call Cal DOJ or  
3     Mossberg.

4           Q     To ask about how to process something like that?

5           A     I mean, I'm speculating. But I believe that's  
6     Cal DOJ's responsibility.

7           Q     Is what? To provide that feedback? What do you  
8     mean by that?

9           A     To provide the classification for the firearm and  
10    how to transfer it, since it's their computer system.

11          Q     So using that Mossberg Cruiser as an example,  
12    this is what Jay Jacobson -- the only reason I'm using  
13    this Cruiser as an example --

14                MS. BARVIR: Andrew, we can't hear you.

15                MR. ADAMS: Sorry.

16          Q     BY MR. ADAMS: Jay Jacobson was talking about  
17    this Mossberg Cruiser and how you process it, so I'm using  
18    that as an example. So if you were talking to a dealer in  
19    2019, how would you expect them to process a Mossberg  
20    Cruiser in the system?

21          A     Is that the question for me -- I'm sorry -- or is  
22    that a statement that Jay said?

23                MS. BARVIR: Yeah. I'm going to object that this  
24    is all speculative. We don't -- Franklin Armory doesn't  
25    sell Mossberg Cruisers.



1           So if you can answer it, Dave, go ahead, without  
2 speculation.

3           THE WITNESS: Without speculating, I can't answer  
4 it.

5           Q     BY MR. ADAMS: Okay. Did you hear any reports  
6 from the dealer that you were interacting with in 2019 or  
7 prior, how did they process weapons that they had  
8 questions on? Did they ever tell you how they dealt with  
9 that?

10          A     No, I don't recall any specific conversations  
11 about other manufacturers' guns.

12          Q     Okay. What about a Franklin Armory gun that was  
13 hard to classify? Did you ever talk to a dealer who had a  
14 question about that?

15          A     The only other gun I have talked to California  
16 dealers about that had issues with how to transfer was,  
17 like we discussed earlier, the CA7. And, again, it was an  
18 issue with the Cal DOJ website. But, miraculously, that  
19 issue was cured quickly, unlike the Title 1 issue.

20          Q     So using that CA7 as an example, what did the  
21 dealer tell you that they were having trouble with?

22          A     I don't recall the specifics, but it was  
23 something with a drop-down menu in your -- it's either  
24 DROS or DES. I don't know. I don't know what you guys  
25 call it. But there was a menu problem in your software.

1 And then that got fixed within days.

2 Q What did they tell you, the dealers?

3 A That they couldn't select a certain something in  
4 the menu. I don't remember the specific wording.

5 Q Okay. So did that cause them anxiety? Did they  
6 express frustration? What did they tell you?

7 A They weren't happy because they couldn't complete  
8 the transfers until it was fixed.

9 Q Okay. Were they concerned about getting arrested  
10 or being sued or did anyone express that concern to you?

11 A Not that I'm aware of.

12 Q Okay. So then what about this on the Title 1?  
13 Did any of these dealers express to you they were worried  
14 about being arrested or being sued?

15 A Not that I'm aware of.

16 Q Okay. Were you ever meeting in person with any  
17 one of these dealers and they told you they were concerned  
18 about legal consequences?

19 MS. BARVIR: Objection to this line of  
20 questioning being asked and answered.

21 Go ahead and answer, David.

22 THE WITNESS: Okay. I don't recall anything like  
23 that.

24 Q BY MR. ADAMS: Okay.

25 A It could have happened, but I don't remember it.

1           Q     Okay. This guy Josh at Dom's Surplus, Did he  
2     ever express to you a concern that -- of legal  
3     consequences if he wasn't able to process the Title 1  
4     correctly?

5           A     I don't remember discussing legal consequences.  
6     I remember him being frustrated because it would stop the  
7     sale.

8           Q     What do you mean by that? Frustrated -- so he  
9     was unable to process the sale? Is that what he was  
10    expressing frustration on?

11          A     Yes, if the Cal DOJ or DES or DROS, whatever we  
12    are calling it, system doesn't have an option to process  
13    the sale, then he can't make a sale. So, therefore, he  
14    can't order from me, even though he has customers that  
15    want to buy the thing.

16          Q     Okay. And so how would he have processed that if  
17    he wanted to process the sale? Did he tell you that?

18          A     I guess I'm unclear, but I'm going to try and  
19    answer that the best I can. He can't process it until  
20    the -- your system would allow them to do it legally. So  
21    the other option, I guess, would be for him to break the  
22    law, which he wasn't going to do, nor would anyone.

23          Q     So did he tell you that? He said "I'm not going  
24    to break the law and that's why I'm not going to process  
25    this transfer"?

1           A     I don't recall having those specific words with  
2     him because people in our line of work just don't break  
3     the law.

4           Q     So Josh never told you that he -- that the only  
5     way for him to process a sale would, in fact, break the  
6     law.

7                     Did he ever tell you that?

8           A     He just told me until it said "other," he  
9     couldn't make the sales.

10          Q     Okay. And was there anyone else besides Josh at  
11     Dom's Surplus that told you the same thing, that he was  
12     unable to make the sales?

13          A     Only the same things we discussed earlier with  
14     those approximate ten-plus calls. So I'll have to fall  
15     back on that.

16          Q     Okay. Did any of these people ever discuss that  
17     they were worried about losing their license if they had  
18     processed such a sale?

19          A     Not directly with me, as far as I can remember.

20          Q     Okay. Mr. Jacobson said that -- he was asked if  
21     you were the only person that would know or have discussed  
22     it with any of the dealers, and he said other folks as  
23     well. Do you know who else at Franklin Armory would have  
24     discussed this with the dealers?

25          A     I would assume whoever was working customer

2           Q.     And if there's not an author's name, is it  
3     correct that if there is no author's name, that the DOJ  
4     lege office generated that language?

5           MR. LAKE: I'll object. It calls for  
6     speculation.

7           Go ahead, if you can.

9     language, they may or may not tell us where it came

4 about the language or the activity.

5 Q. Sure. So then the Bureau of Firearms would  
6 generate language for a proposed bill to the  
7 Legislature?

8 A. Sometimes.

9 Q. And the legislative office would be the liaison  
10 between the Bureau of Firearms and the Legislature.

11 Is that fair to say?

12 A. Yeah, that's correct.

13 Q. Do you recall -- other than the precursor law  
14 language that you drafted, do you recall drafting any  
15 other language for a proposed bill to send to the  
16 Legislature?

17 A. I could have done two or three per year, as far  
18 as I know. But I don't remember any specific bit of  
19 language, I guess, other than the precursor one.

20 Q. Are you familiar with the term "dealer record  
21 of entry system"?

22 A. Not really. I think -- you might be referring  
23 to dealer record of sale, DROS.

24 Q. Are you --

25 A. Dealer entry system, DES?

1 MR. LAKE: You didn't have the word "sale" in  
2 that description. It was close, but --

3 BY MR. BRADY:

4 Q. Dealer record of sale entry system?

5 A. Yeah. So the -- the DROS document, the dealer  
6 record of sale document, is sort of created inside DES,  
7 dealer entry system. I'm not sure if those are getting  
8 kind of --

9 Q. So it's called the "dealer entry system"?

10 A. That's what I understand it to be.

11 Q. Okay. Can you describe what the -- and you  
12 referred to the dealer entry system as "DES," correct?

13 A. That's the way I've always heard it talked  
14 about.

15 Q. Okay. Can you describe what DES is?

16 A. Okay. So first off, I'm not an IT person, so I  
17 will do my best.

18 So DES is a system by which the California  
19 firearms dealers can transmit data to the bureau for  
20 background check purposes, payment of the background  
21 check. I'm trying to think what else would be -- there  
22 may be some other things. But, again, this is not my  
23 area of expertise. This is more of a program side.

24 The bureau is sort of split into two. There's  
25 an enforcement side, that I was a part of, and then

1     there's the program side of the bureau that has, I don't  
2     know, a couple hundred employees. And they handle most  
3     of the background check analysis, all that type of  
4     stuff. And they're more IT heavy than the agents are.

5           Q.     You did enforcement of laws as to licensed  
6     firearm dealers, correct, in your career at DOJ?

7           A.     Yeah. We would investigate the dealers  
8     occasionally, when there was an issue.

9           Q.     And is it your understanding that firearm  
10    dealers -- licensed firearm dealers -- "FFLs," as they  
11    call them -- are required to use the DES in making  
12    firearm transactions?

13           MR. LAKE: I'm just going to object. It's  
14    vague as to time. It's also overbroad and vague as to  
15    the subject matter.

16                   Go ahead, if you can.

17           A.     Since I've been at the department, there's been  
18    various changes to DES. But it -- towards the latter  
19    half of my career, my understanding, DES has been the  
20    one system that they're supposed to use. I know  
21    probably earlier in my career, there may have still been  
22    paper forms that were being generated that the gun  
23    stores mailed in, et cetera. So just know that there  
24    was sort of an evolution of the process while I was  
25    here.

1 BY MR. BRADY:

2 Q. Understood.

3 But at some point, FFLs were required to use  
4 DES to make firearm transactions during your career; is  
5 that correct?

6 A. Yes.

7 Q. Have you ever heard of the plaintiff in this  
8 matter, Franklin Armory?

9 A. Yes.

10 Q. And where did you first hear of Franklin  
11 Armory?

12 A. I don't know the exact year. I'm trying to  
13 think. It would have been -- I can at least tell you  
14 that it would have been after 2008, but I don't  
15 remember --

16 Q. And why do you say -- why do you say that year?

17 A. That's when I took over as sort of an acting  
18 supervisor in the role that I had for -- I was an acting  
19 supervisor for about two years. And then in 2010, I was  
20 promoted. And so from 2008, I had a lot of interactions  
21 with the California handgun roster, and I don't know  
22 when Franklin Armory started sending in submissions. So  
23 I can just kind of put a rough estimate. It would have  
24 been after 2008.

25 Q. And can you describe the context in which you

1 learned about Franklin Armory? Was it because it was  
2 submitting firearms to the DOJ for review?

3 A. I think that was the -- probably the first  
4 reason I would have known about Franklin Armory. If I  
5 say "Franklin" or "Franklin Armory," it's the same thing  
6 to me. Just for the court reporter. We -- at the  
7 bureau, a small group of us, anyway, had interactions  
8 with various manufacturers that wanted to get their guns  
9 for -- into market, so to speak, into -- in California.  
10 So one of my employees would interact with various  
11 manufacturers on a daily basis. And, occasionally, I  
12 would have a reason to interact with some of them too.

13 BY MR. BRADY:

14 Q. And did you ever interact with anybody at  
15 Franklin Armory?

16 A. Yes. I think Mr. Jay Jacobson.

17 Q. Do you recall what those interactions involved?

18 MR. LAKE: Just vague as to time.

19 But go ahead.

20 A. Yeah, I think some of his products that he was  
21 trying to get on the handgun roster, which were  
22 single-shot pistols that, in general, visually, they  
23 look like an AR-15 pistol. I'll just kind of keep it  
24 high level at that point.

1 BY MR. BRADY:

2 Q. And so you were discussing with Mr. Jacobson  
3 what? Whether his product could be included on the  
4 California roster of handguns?

5 A. Yeah. Some of it was about the -- and this is  
6 going way back, but some of it dealt with if his product  
7 was a single shot. Some of the discussions, I think,  
8 had to deal with a specific magazine that he had  
9 developed that would probably -- and way -- a way the  
10 magazine was -- call it "retained" inside the magazine  
11 well. So we had, I think, some discussions over that.

12 Q. Have you heard of the Franklin Armory Title 1  
13 firearm?

14 A. Yes.

15 Q. Can you explain what your understanding of that  
16 firearm is?

17 A. Sure. My understanding is that -- and again,  
18 I've not seen one, that I know of, in person. But my  
19 understanding is that it's an AR-15-style firearm, but  
20 it does not have a traditional stock attached to it.  
21 More of like a pistol buffer tube but a rifle barrel  
22 length. So maybe, like, a -- I'll call it a "hybrid,"  
23 if you will.

24 Q. Could you explain what you mean by "hybrid"?

25 MR. LAKE: Mr. Brady, if I could just inject.



(2) A semiautomatic, centerfire rifle that has a fixed magazine with the capacity to accept more than 10 rounds.

(3) A semiautomatic, centerfire rifle that has an overall length of less than 30 inches.

(4) A semiautomatic pistol that does not have a fixed magazine but has any one of the following:

(A) A threaded barrel, capable of accepting a flash suppressor, forward handgrip, or silencer.

(B) A second handgrip.

(C) A shroud that is attached to, or partially or completely encircles, the barrel that allows the bearer to fire the weapon without burning the bearer’s hand, except a slide that encloses the barrel.

(D) The capacity to accept a detachable magazine at some location outside of the pistol grip.

(5) A semiautomatic pistol with a fixed magazine that has the capacity to accept more than 10 rounds.

(6) A semiautomatic shotgun that has both of the following:

(A) A folding or telescoping stock.

(B) A pistol grip that protrudes conspicuously beneath the action of the weapon, thumbhole stock, or vertical handgrip.

(7) A semiautomatic shotgun that does not have a fixed magazine.

(8) Any shotgun with a revolving cylinder.

(9) A semiautomatic centerfire firearm that is not a rifle, pistol, or shotgun, that does not have a fixed magazine, but that has any one of the following:

(A) A pistol grip that protrudes conspicuously beneath the action of the weapon.

(B) A thumbhole stock.

- (c) The Legislature finds a significant public purpose in exempting from the definition of "assault weapon" pistols that are designed expressly for use in Olympic target shooting events. Therefore, those pistols that are sanctioned by the International Olympic Committee and by USA Shooting, the national governing body for international shooting competition in the United States, and that were used for Olympic target shooting purposes as of January 1, 2001, and that would otherwise fall within the definition of "assault weapon" pursuant to this section are exempt, as provided in subdivision (d).
- (d) "Assault weapon" does not include either of the following:
  - (1) Any antique firearm.
  - (2) Any of the following pistols, because they are consistent with the significant public purpose expressed in subdivision (c):


