2 A So budget proposals that are related to
3 specific departments that are considered public safety
4 are heard through our subcommittee. And the
5 Department of Justice, if they have budget proposals
6 that are introduced through the governor's budget,
7 they come through our subcommittee for review and
8 analysis.

9 Q Okay. So perhaps there's some sort of policy
10 or something that the DOJ is working on and it needs
11 money to do so. It might bring a proposal to --
12 that's a budgetary proposal that would go through
13 public safety, committee number six; is that right?

14 A It has to go through a process through the
15 Department of Finance, and it has to be a part of the
16 governor's budget, typically, in order to get --

17 Q It can't go straight to subcommittee six.
18 There's a process by which it's introduced, but
19 eventually would it end up in the subcommittee six for
20 consideration by the legislature?

21 A Generally, yes.

22 Q Have you ever been employed in any other
23 capacity with the California state assembly?

24 A No.

25 Q Have you ever been employed in any other

1 capacity with the California state government, more
2 broadly?

3 A Yes.

4 Q What was your most recent role with the
5 California state government?

6 A The judicial counsel.

7 Q What was your job title?

8 A Supervising analyst.

9 Q What did you analyze?

10 A Language access issues in the courts.

11 Q Did your responsibility as an analyst for the
12 office of judicial council ever involve firearms
13 issues?

14 A No.

15 Q Before your position with the office of
16 judicial council as an analyst, did you have any other
17 position with the State of California government?

18 A No.

19 Q Before taking your position with the
20 California state government, what was your job before
21 that?

22 A I worked at a nonprofit organization.

23 Q Which nonprofit?

24 A The Ella Baker Center for Human Rights.

25 Q Where is the Ella Baker Center?

1 A Oakland, California.

2 Q And what does the Ella Baker Center do?

3 A I'm not sure what they do now, but when I
4 worked there, we worked on policies related to
5 juvenile and criminal justice.

6 Q In your position -- what was your title at
7 the Ella Baker Center for Human Rights?

8 A The director of programs.

9 Q As director of programs, as a director of
10 programs for the Ella Baker Center, did your work --
11 did your responsibilities include working on issues
12 related to firearms?

13 A No.

14 Q Have you ever worked for the California
15 Department of Justice?

16 A No.

17 MS. BARVIR-BOONE: I'm going to reveal the
18 next document. I'm going to mark it as Exhibit 2.

19 (Exhibit 2 was marked for identification
20 and is attached hereto.)

21 MS. BARVIR-BOONE: For some reason, I'm not
22 seeing if it's revealed. Can you guys let me know if
23 you see it?

24 MR. HERZBERGER: Yes.

25 MS. BARVIR-BOONE: Did Exhibit 1 go away?

1 MR. HERZBERGER: It did, yeah.

2 MS. BARVIR-BOONE: Okay. Good. Thank you.

3 BY MS. BARVIR-BOONE:

4 Q Please take a moment to review the document
5 on your screen.

6 MR. HERZBERGER: We need to scroll on our
7 end, I assume?

8 MS. BARVIR-BOONE: Yes, you should be able to
9 scroll on your end. If not, let me know.

10 MR. HERZBERGER: Okay. So we're looking at
11 five pages here.

12 BY MS. BARVIR-BOONE:

13 Q Yes. It looks like an email on the first
14 page.

15 Have you had enough time to look at the
16 document?

17 A Yes.

18 Q All right. Do you know what this document
19 is?

20 A Yes.

21 Q Can you describe it for me?

22 A It's a summary and background document on
23 the -- on AB 88 as it relates to sections 40 through
24 43.

25 Q Have you seen this document before today?

1 A Yes.

2 Q Does it look different from when you saw it
3 before?

4 A I don't think so.

5 Q Just look at the first page, if you can. It
6 should be an email.

7 For the record and just so we're making sure
8 that we are on the same page, can you state the date
9 of the email and the subject for me?

10 A Thursday, June 25, 2020. Subject is
11 "Forward:PIFL."

12 Q Thank you. That's what I have, too. It says
13 it's from a Bosler Keely.

14 Do you know who Keely Bosler is?

15 A Yes.

16 Q Who is she or they?

17 A The former director of finance.

18 Q You said former. Do you know where
19 Keely Bosler -- where they're working today?

20 A No.

21 Q How about Jason Sisney?

22 A I'm not quite sure about his title. Are you
23 asking for his title?

24 Q So do you know who Jason Sisney is?

25 A Yes.

1 Q And do you know -- and you don't know his
2 title?

3 A I believe it's budget director.

4 Q Maybe this will work better. Do you know
5 what department Mr. Sisney works in?

6 A Yes.

7 Q What is that?

8 A He works for the assembly office of the
9 speaker.

10 MR. ADAMS: I'm looking to interject, but I'm
11 looking at these emails and it looks like they're
12 prepared by Laura Palmerin. When I look at the
13 Outlook, I know that's your secretary. I don't get
14 this. Maybe I'm showing my age here.

15 MS. BARVIR-BOONE: Laura Palmerin is my
16 secretary. These were received as a public records
17 act request response from the Department of Finance,
18 and they sent us to them in their native format as
19 these emails, and that's the only way they will come
20 out.

21 Does that make sense?

22 MR. ADAMS: Yes.

23 MS. BARVIR-BOONE: Thank you for bringing
24 that up. I think that is helpful.

25 ///

1 BY MS. BARVIR-BOONE:

2 Q All right. Okay. Mr. Sisney is currently
3 with the assembly office of the speaker?

4 A Yes.

5 Q Do you know, was Mr. Sisney with that office
6 around -- in the year 2020?

7 A Yes.

8 Q Okay. Do you know who Aaron Edwards is?

9 A Yes.

10 Q Who is Mr. Aaron Edwards?

11 A He works for the Department of Finance.

12 Q The Department of Finance. And do you know
13 his position?

14 A I don't.

15 Q Okay. And Amy Jarvis, do you know who
16 Amy Jarvis is?

17 A Yes.

18 Q Who is Amy Jarvis?

19 A She also works for the Department of Finance.

20 Q Do you know her position?

21 A I don't know her position title.

22 Q Okay. And then do you know who Vivek
23 Viswanathan is?

24 A Vivek was also with the Department of
25 Finance.

1 Q Was?

2 A Was.

3 Q He's no longer -- they're no longer with the
4 Department of Finance?

5 A No longer.

6 Q Looking at the email, Ms. Bosler's June 25
7 email refers to, quote, "The pifle discussion." I
8 assume I'm saying that correctly.

9 Do you know what a pifle is?

10 A Yes.

11 Q Could you please describe your understanding
12 of what a pifle is?

13 A My understanding of a pifle is a combination
14 of a pistol and a rifle.

15 Q A combination of a pistol and a rifle?

16 A Yes.

17 Q When you -- when would you say you first
18 heard of the term "pifle"?

19 A In 2020.

20 Q Who did you first hear that term from?

21 A I don't think I heard it from a person.

22 Q Did you read about pifles?

23 A Yes.

24 Q Where did you --

25 A As part of the governor's budget.

1 Q In what year?
2 A I believe it was in 2020.
3 Q Can you describe the circumstances under
4 which you would have read about the term "pifle" in
5 the governor's budget?

6 A As part of the introduction of one of the
7 trailer bills.

8 Q What's a trailer bill?

9 A A trailer bill is legislation that
10 accompanies the state budget to enact the budget.

11 Q Okay. Is it given a number like other bills?

12 A Yes.

13 Q Do you know which -- what number was assigned
14 to the trailer bill where you learned of the term
15 "pifle"?

16 A The trailer bill is an omnibus bill, so it
17 includes various different subjects that fall under
18 public safety. So the bill number is AB 88. I can't
19 remember the -- AB 88, and whatever senate bill,
20 corresponding senate bill it was.

21 Q So AB 88 means Assembly Bill 88?

22 A Correct.

23 Q In the year 2020?

24 A Yes.

25 Q Okay. You said it's an omnibus bill. So it

1 addresses many topics that are budgetary related to
2 your subcommittee public safety?

3 A It covers various subjects related to public
4 safety.

5 Q Thank you.

6 What, if you can recall, did Assembly Bill 88
7 do with regard to firearms in 2020?

8 A I just remember there were maybe two
9 different pieces related to firearms, one of them
10 addressing pifles.

11 Q What did it do with regard to pifles?

12 A Provided clarification in the law.

13 Q What clarification did it provide?

14 A To effectuate the legislative intent. The
15 legislative intent in the law that already existed.

16 Q And what law was that?

17 A Related to assault weapons.

18 Q So what did it clarify with regard to assault
19 weapons and pifles?

20 A So my recollection was that it clarified the
21 definition of assault weapons so that pifles would
22 fall under that definition.

23 Q Okay. Do you recall what happened to AB 88?

24 A It was enacted.

25 Q It was enacted?

1 A Correct. I can't remember if it was the AB
2 or the SB. One of the versions gets enacted. They're
3 identical.

4 Q Mm-hmm.

5 A I don't remember which of the two got
6 enacted.

7 Q Okay. Going back to the term "pifle," is
8 that a legal term? Is that something that's in
9 statute or regulation somewhere?

10 A I don't remember.

11 Q Okay. Do you know whether pifle, p-i-f-l-e,
12 as stated in this email that we have in front of us,
13 is the same as pifl p-i-f-l in the subject? Would
14 they be referring to the same thing?

15 A Yes.

16 Q In your experience, do people go back and
17 forth calling it a pifle with an E or pifl without an
18 E, or maybe that's a typo?

19 A I don't remember the back and forth.

20 Q When you speak or write about pifles, do you
21 spell it with an E, p-i-f-l-e?

22 A I'd have to refer to the emails that I wrote
23 because it was some time ago.

24 Q To your knowledge, has a pifle ever been used
25 in a crime?

1 A I don't know.

2 Q On page 5, the last page of this exhibit --
3 actually, I might -- I'm so sorry. Could you go back
4 to the first page? Are you there?

5 A Yes.

6 Q All right. In Keely Bosler's email, the
7 second sentence says, "We put together this
8 one-pager."

9 Do you see that?

10 A Yes.

11 Q All right. And on -- back down to page 5,
12 the top of this page reads, "Summary and Background of
13 AB 88 Sections 40 through 43."

14 Do you see that?

15 A Yes.

16 Q And you've seen this particular document
17 before?

18 A Yes.

19 Q Do you know whether this summary and
20 background of AB 88 sections 40 to 43 is the one-pager
21 referred to in Ms. Bosler's June 25 email?

22 A That is my understanding.

23 Q Okay. Do you know who drafted this summary
24 and background of AB 88 sections 40 to 43?

25 A I don't know.

1 Q So you did not participate in preparing this
2 one-page summary and background?

3 A No.

4 Q Do you know who else this document was shared
5 with?

6 A I don't know who else it was shared with
7 outside of who's listed in the email.

8 Q That's fair. What was -- do you know what
9 this one-pager summary and background of AB 88 was
10 used for?

11 A To provide additional information related to
12 the introduced trailer bill.

13 Q Assembly Bill 88?

14 A So Assembly Bill 88 wasn't -- the bill number
15 gets assigned later. It's just a trailer bill, its
16 own kind of standalone trailer bill that was
17 introduced.

18 Q Okay. Is this something that would have been
19 distributed to the members of the assembly or the
20 legislature?

21 A I don't know.

22 Q You don't know. Okay.

23 What role did you play in the consideration
24 of AB 88?

25 A So I read the trailer bill. I asked

1 questions related to the trailer bill to provide
2 information and background to the members I work for.

3 Q Did you help draft any part of it?

4 A No.

5 Q Okay. Did you create talking parts or
6 otherwise help prepare for the debate or discussion of
7 AB 88?

8 A I created one -- I believe maybe one bullet
9 point that just described what it was.

10 Q Okay. Do you remember what that bullet point
11 was?

12 A No.

13 Q It was a long time ago. I understand.
14 That's fair.

15 Did you do any research with regard to your
16 role in the consideration of AB 88?

17 A So as it relates to this specific section of
18 AB 88. I had conversations with the Department of
19 Finance and the Department of Justice to get
20 additional background.

21 Q Who in the Department of Finance, if you can
22 recall, did you speak to about this pifle assault
23 weapon section of AB 88?

24 A Aaron Edwards. And I don't remember who else
25 I may have spoken with.

1 Q Do you recall when you might have had these
2 discussions with Mr. Edwards at the Department of
3 Finance about AB 88 pifles and assault weapons?

4 A I can give you a range.

5 Q That's fair.

6 A It would probably have been between February
7 and June of 2020, possibly also July, August. Just
8 that kind of range.

9 Q While the bill was being considered in 2020?

10 A (Witness nods head.)

11 Q Do you recall what you discussed with
12 Mr. Edwards at the Bureau of Finance about AB 88
13 assault weapons and pifles?

14 A I don't remember specifically what was
15 discussed.

16 Q Okay. You said also that you had
17 conversations with the Department of Justice about
18 AB 88 and this particular part of it; is that correct?

19 A That's correct.

20 Q Do you recall who you spoke with at the
21 Department of Justice about AB 88 assault weapons,
22 pifles?

23 A I recall one name. Ashley Ayres, A-y-r-e-s.

24 Q Do you know what Ms. Ayres' position with the
25 Department of Justice was?

1 A Mister.
2 Q Thank you.
3 A I don't.
4 Q Okay. Do you recall when it was that you
5 might have had these conversations or this
6 conversation with Mr. Ayres about AB 88 pifles,
7 assault weapons?

8 A That same time frame.

9 Q Which was February to June 2020, perhaps
10 July, August 2020?

11 A Correct.

12 Q Thank you. You had explained to me that the
13 summary and background of AB 88 sections 40 to 43 was
14 more about just generically the trailer bill, so maybe
15 not specific to AB 88.

16 Is that a correct understanding of what you
17 were explaining to me?

18 A Could you repeat that?

19 Q Earlier you had stated that this one-pager,
20 this summary and background of AB 88 was more about
21 the trailer bill more generally, not just -- it could
22 have been other bills.

23 Is that a correct understanding?

24 A So AB 88, this one-pager refers to a specific
25 section within AB 88.

1 Q So this was -- was this one-pager summary and
2 background only used for AB 88, or was it used for --
3 with regard to other legislation?

4 A To my understanding, only for AB 88 or
5 sections 40 through 43.

6 Q Thank you.

7 Are you familiar with Assembly Bill 118 from
8 2020?

9 A Assembly Bill 118?

10 MR. HERZBERGER: Or Senate Bill 118?

11 MS. BARVIR-BOONE: No, it's Assembly Bill
12 118. Let me think. Let me go back here.

13 BY MS. BARVIR-BOONE:

14 Q Do you recall whether or not AB 88 ultimately
15 died in committee and a similar or identical bill
16 known as Assembly Bill 118 was later introduced?

17 A There wouldn't have been two ABs. There
18 would have been one assembly bill and one senate bill.
19 So between the two, one of them -- and they're
20 identical.

21 Q Right. But if AB 88 died in committee and a
22 different bill like AB 118 was actually adopted, is
23 that your recollection?

24 A I don't know AB 118. I'm not familiar with
25 that.

1 Q So your recollection is that AB 88 passed and
2 was enacted?

3 A No.

4 (Simultaneous speakers.)

5 THE WITNESS: What I said was AB 88 and the
6 corresponding senate bill. I just don't remember the
7 number. They are identical. And only one of the
8 bills went through and was enacted, which is the
9 typical process.

10 MR. HERZBERGER: In the deposition notice, it
11 does refer to an AB 88 and an SB 118, if that's what
12 we're getting at.

13 MS. BARVIR-BOONE: It's not SB 118. I'm not
14 sure why it says -- well, perhaps maybe I do have it
15 wrong. Let me double-check. All right. I need to
16 get the bill uploaded to Agile, so I need to go off
17 record and take a 10-minute break.

18 Is that okay with you guys?

19 MR. HERZBERGER: That's fine.

20 MS. BARVIR-BOONE: All right. Thank you.

21 (Recess.)

22 MS. BARVIR-BOONE: Thank you for that moment.
23 Correct, it was a typo in my notes. It is Senate Bill
24 118 that I was referring to.

25 Let me reveal this document and mark it

1 Exhibit 3.

2 (Exhibit 3 was marked for identification
3 and is attached hereto.)

4 MS. BARVIR-BOONE: Let me know when you can
5 see it.

6 MR. HERZBERGER: We can see it.

7 MS. BARVIR-BOONE: Fantastic.

8 BY MS. BARVIR-BOONE:

9 Q Ms. Kim, could you please take a moment to
10 review this document? It's a long one, so take your
11 time.

12 A Okay.

13 Q Have you had sufficient time to review it?

14 A Yes.

15 Q Do you know what this document is?

16 A Yes.

17 Q Have you seen this document before today?

18 A Yes.

19 Q Can you tell me what this document is?

20 A It's Senate Bill 118.

21 Q From 2020; is that correct?

22 A Correct.

23 Q All right. So can we agree to call it
24 SB 118?

25 A Yes.

1 Q All right. Let's look at page -- I think
2 it's seven. At least seven is the number at the top.

3 A Okay.

4 Q In the subsection 15, the second paragraph of
5 that, it says, "This bill would expand the definition
6 of assault weapon to include a semiautomatic firearm."

7 Do you see that sentence?

8 A Yes.

9 Q Okay. So it says, "This bill would expand
10 the definition of assault weapon to include a
11 semiautomatic firearm that is not a rifle, pistol or
12 shotgun that either does not have a fixed magazine but
13 has one of these attributes."

14 Do you see that?

15 A Yes.

16 Q So this language in SB 118, is this similar
17 or identical to what AB 88 was attempting to do?

18 A Yes.

19 Q Okay. So this is -- is SB 118 another
20 trailer bill?

21 A Yes.

22 Q Okay. If you go to page 60, again, it's the
23 60 at the top. Oh, goodness. There we go.

24 A Okay.

25 Q Did you get there?

1 A Yes.

2 Q What does -- can you tell me what page 60

3 shows us?

4 A It shows the sections that were amended for

5 the purposes of this trailer bill.

6 Q Okay. So is that at the top there, the

7 number 30515?

8 A Correct.

9 Q Did this trailer bill add all of this

10 language or just some of it?

11 A Just some of it.

12 Q The clarification you were talking about?

13 A Yes.

14 Q Okay. Is it -- do you recall which sections

15 or section it added?

16 A I don't.

17 Q Okay. If you scroll down to -- in that page,

18 it looks like a subsection 9 talks about a

19 semiautomatic centerfire firearm that is not a rifle,

20 pistol or shotgun without affixed magazine.

21 Is that talking about what this bill would

22 have expanded?

23 A Not having reviewed this since 2020, I don't

24 know for sure.

25 Q Okay. No need to apologize. That's okay.

1 I'm just trying to make sure we're all on the same
2 page.

3 Okay. Do you remember what happened to
4 SB 118?

5 A It was enacted.

6 Q And does that mean that AB 88 was also
7 enacted, or was it not enacted?

8 A Only one trailer bill gets enacted.

9 Q Okay. But they're the same or they're
10 similar --

11 A They're identical.

12 Q Okay. They're identical.

13 So you're with the assembly budget committee.
14 The assembly budget committee sees AB 88, though,
15 correct?

16 A Yes.

17 Q Did you have any role in the consideration or
18 adoption of SB 118?

19 A Yes.

20 Q Can you describe that role?

21 A So I put together the senate bill version.
22 It sounds strange. And the senate puts together the
23 assembly bill version.

24 Q Oh. Can you explain why that is?

25 A It's just -- I don't know. It's just a

1 process. But the components are identical. So it's
2 just a process thing.

3 Q So when you say you put together the senate
4 bill version, what do you mean by that?

5 A So the trailer bills that get introduced and
6 there is agreement to put in the trailer bill with the
7 senate and the assembly, those get assigned to a bill.
8 And so SB 118 was where all of the different
9 components of the public safety trailer bill were
10 added.

11 Q So are you saying that you drafted SB 118
12 or --

13 A I did not draft SB 118. So trailer bill,
14 when it gets introduced as part of the governor's
15 budget, they're introduced as different pieces. So
16 there may be a trailer bill on subject A, a trailer
17 bill on subject B, a trailer bill on subject C.

18 Q Okay.

19 A And so if it falls within the purview of
20 public safety, they get bundled together, and later
21 they're put in one trailer bill vehicle. So each
22 vehicle does not get its own AB or SB number.

23 Q Okay. So you bundle --

24 A Yes.

25 Q You didn't draft each of those trailer bills?

1 A No, I did not.

2 Q Got it.

3 A I apologize.

4 Q No, do not. I don't understand this, but I'm
5 just trying to understand the process. It's very
6 helpful. Thank you.

7 Did you create talking points or otherwise
8 prepare legislatures to discuss SB 118?

9 A Yes.

10 Q Can you explain what it was that you did to
11 help legislatures to prepare to discuss SB 118?

12 A A simple summary of what the trailer bill
13 includes.

14 Q You drafted a summary of what the trailer
15 bill includes?

16 A Yes.

17 Q Okay. And you did -- are you referring to --
18 when you talk about a summary, I want to make sure
19 we're referring to the same thing.

20 Did you do it -- do you have to create lots
21 of summaries for each of the different subjects or --
22 or is it one about the entire bill?

23 A Typically, one bullet point for each -- it's
24 a very -- it's a broad summary for each of the
25 components in the trailer bill.

1 Q So specifically, through the assault weapons
2 definition pifles, you created maybe one bullet point
3 within a larger summary of the trailer bill?

4 A Correct.

5 Q For SB 118?

6 A Correct.

7 Q Okay. I just want to make sure that I'm
8 getting -- so SB 118 isn't considered the trailer
9 bill? It's a bundle of trailer bills?

10 A No. SB 118 is the trailer bill.

11 Q Mm-hmm.

12 A The components, the various policies that are
13 in the trailer bill are also separate trailer bills,
14 and then they become this mega trailer bill.

15 Q Okay. Thank you. I just want to make sure
16 that when I say things like trailer bills, if I'm
17 referring to SB 118 or AB 88, that I'm using the
18 proper language that you can understand. So thank you
19 for clarifying.

20 Did you do any research with regard to your
21 role in the adoption of SB 118?

22 A Yes.

23 Q Can you describe that, please?

24 A As I described before, they're typically
25 conversations that I have with whichever department

1 and the Department of Finance that's introducing the
2 piece of trailer bill.

3 Q So generally, that's what you would do. Did
4 you do that with regard to SB 118?

5 A Yes.

6 Q Yes. Do you recall who those -- who you had
7 those conversations with?

8 A So just for the component related to the
9 assault weapons?

10 Q Correct. Thank you.

11 A I already mentioned the individuals at the
12 Department of Finance and the Department of Justice.

13 Q So Aaron Edwards from the Department of
14 Finance and Ashley Ayres from the Department of
15 Justice?

16 A Those are the names I remember.

17 Q Okay. There may have been others?

18 A There may have been others.

19 Q Okay. So are these -- are these separate
20 communications or correspondence about SB 118 and
21 AB 88, or would they have been the -- are you
22 referring to the same conversations?

23 A Same conversations.

24 Q Okay. I'm going to re-reveal Exhibit 2, the
25 one-pager. Let me know when you see it.

1 A I see it.

2 Q All right. If you go down to paragraph 3,
3 about the middle of the paragraph, it refers to a
4 loophole.

5 Do you see where it references a loophole?

6 A Yes.

7 Q Can you explain what loophole this document
8 is referring to?

9 A The loophole is related to the definition of
10 assault weapon.

11 Q Can you explain further why that is a
12 loophole? What makes it a loophole?

13 A My understanding is that the definition of an
14 assault weapon is a rifle, pistol or shotgun. And
15 loophole refers to something that does not squarely
16 fit under that label.

17 Q Of a rifle, pistol or shotgun?

18 A Yes.

19 Q Okay. How did you -- you said this was your
20 understanding. Do you recall how you came to
21 understand about that loophole?

22 A Yes.

23 Q Can you describe that?

24 A Sure. So the conversations I had with the
25 Department of Justice, Department of Finance as well

1 as a document like this to provide the summary
2 background.

3 Q Do you recall when you -- when you received
4 this document or you saw this document?

5 A I believe it was dated in June, so that must
6 have been when I saw it.

7 Q 2020?

8 A Yes.

9 Q The first sentence of paragraph 4 --

10 A Yes.

11 Q Sorry. It reads, quote, "We know that
12 firearm manufacturers are actively working to exploit
13 this loophole," end quote.

14 Do you see that?

15 A Yes.

16 Q Do you know which manufacturers were working
17 to exploit this so-called loophole?

18 A I don't remember.

19 Q Do you know of any evidence that
20 manufacturers were working to exploit this so-called
21 loophole?

22 A Besides the information I receive from the
23 Department of Finance and DOJ, no.

24 Q And when you say besides the information you
25 receive from the Department of Finance and the DOJ,

1 are you referring to those conversations or other --

2 A Yes. Yes.

3 Q Did you first learn of this loophole --
4 exploitation of loophole through this document of
5 June 2020, or was it earlier than that?

6 A I believe it was earlier.

7 Q Do you recall when about that would have
8 been?

9 A No.

10 Q Okay. Earlier you said you had these
11 conversations probably between February and June 2020.
12 Is that probably around that same time frame?

13 A Yes.

14 Q Yes. Okay. Thank you.

15 Paragraph 4 of this summary and background of
16 AB 88 goes on to give an example of manufacturers
17 exploiting the loophole. It describes Franklin
18 Armory's construction of a firearm marketed under the
19 name Title 1.

20 Have you ever heard of the name Title 1
21 firearm?

22 A No.

23 Q No. Paragraph 4 of the summary and
24 background of AB 88 next claims that, quote,
25 "Manufacturers are currently selling parts that allow

1 people to assemble these sorts of firearms themselves
2 and are pushing to sell fully assembled firearms,
3 too."

4 Do you see that?

5 A Yes.

6 Q Do you know which manufacturers this is
7 referring to?

8 A No.

9 Q Okay. Are you aware of any evidence that
10 supports that claim?

11 A Besides conversations, no.

12 Q The conversations you had with members of the
13 Department of Finance and Department of Justice
14 between February 2020 and June or August 2020?

15 A Yes.

16 Q Okay. And at the end of paragraph 4 of the
17 summary and background of AB 88 states that, quote,
18 "Firearm vendors in California have not sold these
19 guns out of concern for liability issues."

20 Do you see that?

21 A Yes.

22 Q Do you know what liability issues that
23 references?

24 A I'm assuming it's related to the prohibition
25 of selling prohibited firearms. Assault weapons.

1 Q So you assume that firearm vendors were
2 afraid of liability for selling banned assault
3 weapons. Is that what you're saying?

4 A Yes.

5 Q Why -- where did you -- why did -- where did
6 you get that understanding?

7 A From the conversations and background from
8 the DOJ and the Department of Finance.

9 Q Okay. The same conversations between
10 February --

11 A Yes.

12 Q Okay. Finally, paragraph 4 states that
13 Franklin Armory is suing the Department of Justice to
14 compel them to clarify that it is allowable to sell
15 these weapons.

16 Do you see that?

17 A Yes.

18 Q Did you have any conversations with anyone in
19 the Department of Justice about that lawsuit?

20 A No.

21 Q Okay. Did you have conversations about that
22 lawsuit with anyone else?

23 A No.

24 Q Are you familiar with that lawsuit aside from
25 what I just told you?

1 A I am not.

2 MS. BARVIR-BOONE: All right. I'm going to
3 reveal and mark as Exhibit 4 another document.

4 (Exhibit 4 was marked for identification
5 and is attached hereto.)

6 MS. BARVIR-BOONE: Let me know when you can
7 see it.

8 MR. HERZBERGER: We can see it.

9 MS. BARVIR-BOONE: Fantastic. It's similar
10 to the last email thing that we have. It has
11 Laura Palmerin's name at the top because this was
12 received as a response to a public records act request
13 sent to our office in its native format as an email.

14 BY MS. BARVIR-BOONE:

15 Q But other than that, take a moment to review
16 the document on your screen. We're going to focus on
17 page 2, if that helps.

18 A Okay.

19 Q Okay. Have you had sufficient time to review
20 this document?

21 A Yes.

22 Q Do you know what this document is?

23 A Yes.

24 Q Have you seen this document before today?

25 A Yes.

1 Q At the top there, is that -- or was that
2 email jennifer.kim@asm.ca.gov associated with you?

3 A Yes.

4 Q That's your email address?

5 A Yes.

6 Q Okay. So you drafted this email?

7 A Correct.

8 Q Okay. This one with the subject Assault
9 Weapon TBL, dash, dash, additional Info FYI?

10 A Correct.

11 Q Does this email look different from when you
12 drafted it?

13 A I don't think so.

14 Q Looking at the subject line again, it reads,
15 "Assault weapon TBL additional info FYI."

16 What did you mean by assault weapon TBL?

17 A This is related to the trailer bill that
18 we've been addressing.

19 Q So what does TBL mean?

20 A Trailer bill language.

21 Q Trailer bill language. That makes sense.

22 And so it would have been in reference to
23 AB 88 and/or SB 118; is that correct?

24 A To those specific --

25 Q Specifically?

1 A Correct.

2 (Simultaneous speakers.)

3 Q Sorry. Yes. We talked a little bit about
4 what a trailer bill is and what it does.

5 How does a trailer bill differ from other
6 sorts of bills? What makes it a trailer bill as
7 opposed to -- like, why is there a difference?

8 A It's just a different process in which the
9 bill moves through the legislature. The trailer bill
10 accompanies the budget bill. And so the reason why
11 it's called a trailer bill is because it trails the
12 budget. But it's just a different process in which
13 legislation can be enacted.

14 Q Can you explain that different process? How
15 is it different from -- I don't know, what we learned
16 about Schoolhouse Rock about how a bill becomes a law?

17 A Sure. So a trailer bill can be introduced,
18 you know, for consideration by the governor or the
19 legislature. It may or may not be discussed in a
20 committee in one of the budget committees.

21 And it typically -- the policies typically do
22 not tend to be a standalone bill. They get bundled
23 together under, like, a general subject, whereas kind
24 of the Schoolhouse Rock example you gave, they tend to
25 be a specific policy in one bill, so you're not going

1 to see a general, like, 10 different kinds of, you
2 know, issues related to public safety in one policy
3 bill, whereas in the trailer bill, because it's
4 related to the budget, under public safety you can
5 have subjects that fall within public safety but that
6 are not directly related to each other within the
7 bill.

8 Q Okay. How does a decision get made that
9 something goes through a policy bill or it goes to a
10 trailer bill instead of a policy bill?

11 A It depends on how it's introduced. So
12 trailer bills typically are introduced at the
13 beginning of -- like the first quarter along with the
14 governor's budget and they get posted on the website.
15 Sometimes trailer bills come later. Sometimes trailer
16 bills are introduced by the legislature and they get
17 included and bundled up in the budget process.

18 Q Who makes that decision to bundle it or not?

19 A The initial -- I guess, technically, if the
20 legislature -- we put together the trailer bills. So
21 I process which kind of provision goes into the
22 trailer bill. And then once that's posted on the
23 website, then it goes through the budget hearings and
24 gets voted on, and it goes to the governor's office if
25 it makes it through the floor votes.

1 Q Can anything be passed as part of a trailer
2 bill, or are there requirements for something to be a
3 trailer bill?

4 A I don't know of any specific requirements.

5 It depends. It depends on the issue that's being
6 raised and whether the legislature and the governor's
7 office wants to use the trailer bill process or the
8 policy or the other process.

9 Q Okay. So sometimes trailer bills include
10 policy changes?

11 A Trailer bills and the budget to me are all
12 policy, so yes. I mean, trailer bills are all
13 statutory changes, so yes.

14 Q Does it have to have a relation to the budget
15 to be part of a trailer bill?

16 A It trails the budget. And so there may be
17 some type of nexus related to it, but I don't know
18 that it's -- I don't know if it's a legal requirement
19 that would be a question for someone above my
20 paygrade.

21 Q Like who? Who might know that?

22 A Legislative counsel.

23 MR. HERZBERGER: I'm not a witness here.

24 MS. BARVIR-BOONE: Right.

25 ///

1 BY MS. BARVIR-BOONE:

2 Q All right. Is the process -- so earlier you
3 had said -- I believe you had said that a trailer bill
4 may or may not go through committee; is that correct?

5 A A trailer bill -- so the subcommittee -- the
6 subcommittee I'm in, we hear various budget proposals.
7 They're called budget change proposals, and that's
8 kind of more strictly money. And then there's trailer
9 bills. So trailer bills do often get taken up in the
10 full budget committee, but they may or may not appear
11 at a subcommittee agenda. There's no requirement to.

12 Q Okay. But --

13 (Simultaneous speakers.)

14 THE WITNESS: Yes. Because there are no
15 votes -- so the trailer bills are typically heard in
16 the full budget committee, yeah.

17 BY MS. BARVIR-BOONE:

18 Q Okay. With the process we've talked about
19 for the adoption of trailer bills, would you agree
20 that in practice, trailer bills are more quickly
21 enacted than policy bills?

22 A Trailer bills -- it depends, because the
23 budget process typically can go to like early
24 September. So even though the budget is required to
25 be passed constitutionally by June 15, the trailer

1 bills can be worked on after, so into July and August.
2 Much like policy bills. So it's not necessarily a
3 quicker route.

4 Q Would you say -- no, excuse me.

5 Do trailer bills have the same level of
6 exposure to the public as policy bills? Does the
7 public get involved in the consideration of trailer
8 bills?

9 A I know with this trailer bill, I believe it
10 was posted early in the year, maybe February or so, so
11 that's -- that was made public. Typically, policy
12 bills are introduced in February as well. So it's a
13 similar introduction to the public, I would say. I
14 think it was posted in February.

15 Q Would you say, though, the bundling of these
16 multiple issues, does that make a trailer bill -- does
17 that make a trailer bill easier to semi-secretly do
18 things that might be difficult for the legislature to
19 do otherwise as a policy bill for instance?

20 A No.

21 Q No?

22 A No.

23 Q Why would you think so?

24 A Because the information is posted publicly
25 under the legal requirements and they are heard in

1 full budget committee. They're heard on the floor
2 vote during the floor session. So it's just a
3 different process.

4 Q How simple is it for the legislators who
5 would oppose one portion of the bundle in a trailer
6 bill to excise a portion that they oppose and allow
7 the rest of the trailer bill to go through? Is it
8 possible? Is it simple?

9 A It's possible.

10 Q Is it -- does that happen regularly?

11 A What do you mean by regularly?

12 Q Do legislators often exercise their ability
13 to excise portions of the trailer bill from the
14 trailer bill so that the rest can get passed?

15 A I don't know how often it occurs, but --
16 because I only cover public safety, but it is
17 definitely possible.

18 Q In the public safety -- would members of the
19 public safety committee be able to excise, or is it
20 something simply that they can ask --

21 (Reporter clarification.)

22 Does the public safety committee --
23 subcommittee of the budget have the ability to amend
24 the trailer bill itself?

25 A Not without agreement because -- we're a

1 subcommittee of a full budget committee. So there is
2 a process to decide, you know, what goes in and what
3 doesn't.

4 Q So the public safety subcommittee of the
5 budget -- the assembly budget committee, it cannot
6 just vote to make an amendment to the trailer bill; is
7 that correct?

8 A The votes that happen to move a trailer bill
9 or the budget, though, happen in the full budget
10 committee. The votes that happen in the subcommittee
11 are the recommendations of the subcommittee to the
12 full budget committee.

13 Q So the full budget committee can make
14 amendments to the trailer bill?

15 A Yes.

16 Q Okay. And then that amended language then
17 goes to the assembly floor; is that correct?

18 A If -- if there is agreement, yes.

19 Q Agreement with who?

20 A If there is agreement by the leadership of
21 the assembly, the budget chair.

22 We also work with the other house. We work
23 with the governor. It's kind of a negotiation
24 process.

25 Q Okay. So would it be fair to say, then, that

1 the use of bundling for policy issues through the
2 trailer bill process makes it a little more difficult
3 for opponents of a policy matter brought through the
4 trailer bill to have that policy voted down?

5 A Not necessarily.

6 Q Why do you say that?

7 A Because I don't -- I guess I don't agree that
8 it's easier or more difficult. I think it's just a
9 different process.

10 Q Okay. Paragraph 2 of your email states,
11 quote, "Franklin Armory has constructed guns that
12 don't qualify as a pistol, rifle, shotgun, the legal
13 category of guns that vendors use when they sell
14 guns."

15 Do you see that there?

16 A Yes.

17 Q The first sentence of the second paragraph.

18 A Yes.

19 Q When did you first hear that Franklin Armory
20 had constructed such a gun?

21 A During that time period, the February
22 through -- sometime between February and June of 2020.

23 Q Do you recall how you heard that Franklin
24 Armory had constructed such a gun?

25 A Through those conversations with the

1 Department of Finance and the Department of Justice.

2 Q And, again, that would have been
3 conversations with Aaron Edwards, Ashley Ayres and
4 potentially other folks that you can't recall at the
5 moment?

6 A Correct.

7 Q Okay. Do you recall the context for having
8 those discussions? Like, what was the reason you were
9 having those conversations?

10 A To get additional background on what the
11 trailer bill was seeking to accomplish.

12 Q So they were -- these conversations were had
13 after the legislation was prepared or in preparation
14 to draft the legislation?

15 A This was after the legislation was
16 introduced. Not by the legislature, but as part of
17 the governor's budget.

18 Q During your conversations with
19 Aaron Edwards -- no, during your conversations with
20 Ashley Ayres, do you recall talking about wanting to
21 stop the sale of Franklin Armory's firearms that don't
22 qualify as a pistol, rifle or shotgun?

23 A I don't remember having a specific
24 conversation. I think Franklin Armory was an example.
25 I had never heard of the company before, but I think

1 it was just generally the conversation about this
2 loophole that was mentioned in the other document, in
3 the existing law.

4 Q The loophole being pifles, which are not
5 legally pistols, rifles or shotguns?

6 A Yes.

7 Q Okay. And so Franklin Armory was an example.
8 The discussion was more broad than that.

9 Is that what you're saying?

10 A Yes.

11 Q And so not just speaking of Franklin Armory,
12 then, speaking of pifles more generally or these
13 firearms that don't qualify as pistols, rifles or
14 shotguns, did your conversations with Ashley Ayres
15 involve discussions about stopping the sale of those
16 types of firearms?

17 A Stopping the sales of pifles -- yes.

18 Q Okay. Do you know why we wanted to stop the
19 sale of pifles?

20 A So my understanding is that the pifles had
21 the attributes of a banned assault weapon, and so
22 that's a clarification needed.

23 Q And the clarification needed where?

24 A In the law.

25 Q In the law. Okay.

1 Going back to your statement from your
2 June 24 email, you refer to, quote, "The legal
3 category of guns that vendors use when they sell
4 guns."

5 Do you remember what you meant by that?

6 A The pistol, rifle and shotgun categories.
7 Yes, that's what was meant. Like, what was in the
8 statute.

9 Q Okay. What was in statute. You mean words
10 that are defined by California law?

11 A Correct.

12 Q If a firearm was not a pistol, rifle or a
13 shotgun at the time your email was written, was that
14 firearm illegal to possess? Was a pifle illegal to
15 possess?

16 MR. HERZBERGER: I'm just going to object.
17 To the extent that you know, I mean, this calls for
18 some expert understanding and -- I mean, this calls
19 for speculation to some extent. To the extent you
20 know, you can answer the question.

21 THE WITNESS: Do you mind repeating it one
22 more time?

23 BY MS. BARVIR-BOONE:

24 Q Yes. No, I don't mind.

25 If a firearm was not a pistol, rifle or a

1 shotgun at the time you wrote your email, was that
2 firearm illegal to possess?

3 A My understanding is that there was some
4 ambiguity.

5 Q There was some ambiguity as to whether it was
6 illegal to possess?

7 A I mean, based on the previous document, it
8 showed -- I mean, the previous document -- I'm just
9 interpreting the thing right now because I can't
10 remember. But the previous document mentioned -- I
11 can't remember the -- so all the attributes of an
12 assault weapon, I think -- you know, the argument was
13 made that because these pifles exhibited all the
14 attributes of an assault weapon, that they should fall
15 under whatever restriction was in the statute.

16 Q But when you wrote this email, did they fall
17 under the definition of assault weapon?

18 A I don't know.

19 Q At the time you wrote this email, do you know
20 if Franklin Armory's Title 1 was illegal to own?

21 A I don't know.

22 Q Earlier you had said that you hadn't really
23 heard of the Title 1?

24 A Mm-hmm.

25 Q The end of the second paragraph of your

1 June 20 email states, quote, "They wanted the DOJ and
2 California CA to allow the selling of these
3 assault-type weapons."

4 Do you see that?

5 A Yes.

6 Q All right. "They" in your email, does that
7 refer to Franklin Armory?

8 A I believe I used Franklin Armory as an
9 example, but they would probably refer to a broader
10 category of companies.

11 Q Like weapon?

12 A Excuse me?

13 Q What is an assault-type weapon? You used
14 that phrase.

15 A However it's defined in statute.

16 Q Is assault-type weapon defined in statute?

17 A I don't know. Yeah, I don't know.

18 Q Did you perhaps mean assault weapon?

19 MR. HERZBERGER: I'll just object again.
20 This calls for speculation. You're asking about --
21 and lacks foundation. You're asking about what she
22 thought she meant more than -- in June of 2020.

23 So, again, of course you can ask the
24 question, you can answer, but I'll object on those
25 grounds.

1 THE WITNESS: I don't know. I mean -- I
2 think because pifle -- my understanding was pifle did
3 not exist in statute at the time. Maybe that's why.
4 Because the term "pifle" specifically -- I don't know
5 that it existed in the statute at the time. That may
6 have been why I referred to it as assault-type, but
7 I'm not sure.

8 BY MS. BARVIR-BOONE:

9 Q So pifles were not -- what you're saying is
10 that pifles, because they were not in statute when you
11 wrote this email, were not assault weapons, but
12 because they had the characteristics of assault
13 weapons, they were assault-type weapons?

14 A I'm not saying they were assault or not
15 assault weapons. I'm trying to just remember why I
16 put "assault" and not "assault type," and I can't
17 remember. I'm just kind of guessing, which probably
18 isn't helpful.

19 Q So you don't recall why you didn't just call
20 pifles assault weapons?

21 A No.

22 Q Were they assault weapons when you wrote this
23 email?

24 MR. HERZBERGER: Objection. This calls for a
25 legal conclusion about the -- among other things,

1 about the status of the statute at that time. So you
2 can go ahead and answer.

3 THE WITNESS: I don't know.

4 BY MS. BARVIR-BOONE:

5 Q So you don't recall why you called pifles
6 assault-type weapons and not assault weapons?

7 A Yeah, I don't.

8 Q Do you know who initiated -- sorry. I got a
9 little feedback.

10 Do you know who initiated the attempt to
11 categorize pifles as assault weapons?

12 A I don't know specifically who. I know that
13 it was introduced as part of the governor's budget.

14 Q How do you know that it was introduced as
15 part of the governor's budget?

16 A Because it was posted on the Department of
17 Finance's website.

18 Q On the Department of Finance's website. What
19 was posted, the governor's budget?

20 A The language, the statutory changes related
21 to this subject.

22 Q So that's when you first heard about it, was
23 in the posting of the language, not the conversations
24 we've been talking about?

25 A That's my recollection.

1 Q Okay. You end the second paragraph by
2 stating that Franklin Armory, quote, wanted or --
3 they. I'm sorry. Perhaps a broader thing of
4 "they" -- wanted the DOJ and California to allow the
5 selling of these assault-type weapons by clarifying
6 this allowing in statute because gun vendors wouldn't
7 sell them due to liability issues.

8 Do you see that?

9 A Yes.

10 Q Once again, this is referencing liability
11 issues. Do you recall what liability issues you were
12 referencing in this email?

13 A Selling prohibited firearms.

14 Q They were afraid -- the gun vendors were
15 fearful that they would be liable for selling
16 prohibited firearms?

17 A Yes.

18 Q Okay. What evidence of those liability
19 issues did you have to make that statement?

20 A Just those same conversations with the
21 Department of Finance and Department of Justice.

22 Q Mr. Edwards, Mr. Ayres in February to
23 June 2020?

24 A Correct.

25 Q Take a look at paragraph 3 of your June 24

1 email. You state that Franklin Armory is trying to
2 get around the technical statutory definition of the
3 assault weapon ban by creating something that's
4 modified.

5 Do you see that?

6 A Yes.

7 Q All right. How did you come to know that
8 Franklin Armory's Title 1 was modified?

9 A From those conversations with the Department
10 of Finance and the Department of Justice.

11 Q Mr. Edwards, Mr. Ayres and that time period
12 of February to June 2020?

13 A Correct.

14 Q Thank you.

15 Do you recall specifically what was
16 communicated about Franklin Armory's firearm?

17 A That it had the attributes of an assault
18 weapon and that individual parts were sold. That's
19 what I remember.

20 Q Okay. But you said that it was -- the email
21 says that Franklin Armory had created something that's
22 modified. Do you know how it was modified?

23 A I don't know how it was modified.

24 Q Okay. Do you have any evidence that
25 Franklin Armory created something that was modified?

1 A Just again those same conversations from the
2 Department of Finance and the Department of Justice.

3 Q Okay. You also stated, quote, "They wanted
4 to be able to sell the fully assembled modified gun."

5 Do you know what gun you were referring to?

6 A I don't know what specific gun I was
7 referring to at the time.

8 Q Okay. How did you learn this information
9 that they wanted to be able to sell the fully
10 assembled modified gun?

11 A The Department of Finance and Department of
12 Justice.

13 Q So the same communications you had --

14 A Correct.

15 (Simultaneous speakers.)

16 BY MS. BARVIR-BOONE:

17 Q All right. Do you know what firearm was
18 modified in order to create the Franklin Armory
19 Title 1?

20 A I don't.

21 Q Okay. So the Title 1 may not have been a
22 modified gun but an original design configuration?

23 A I don't know.

24 Q You don't know. Okay.

25 The next paragraph, you state, "They are

1 shorter, lighter and more compact making them more
2 attractive to gun enthusiasts."

3 Do you see that?

4 A Yes.

5 Q Do you know what they are, like what guns --
6 what gun you were referring to as being shorter,
7 lighter and more compact?

8 A I believe I was referring to the pifles.

9 Q In general, not a specific type of firearm?

10 A Yes.

11 Q Got it. Okay. Where did you obtain that
12 information?

13 A The same conversations with the Department of
14 Finance and the Department of Justice.

15 Q Mr. Edwards and Mr. Ayres and/or others that
16 you may not recall?

17 (Simultaneous speakers.)

18 THE WITNESS: Correct.

19 BY MS. BARVIR-BOONE:

20 Q Moving to that last paragraph of your email
21 from June 24, you state that, quote -- that first
22 sentence -- "Originally, the DOJ thought this policy
23 might go through the policy bill process with
24 Portantino as the author."

25 Did I read that right?

1 A Yes.

2 Q Are you referring to California State Senator

3 Anthony Portantino?

4 A Yes.

5 Q By this policy, what were you referring to?

6 A The trailer bill.

7 Q The trailer bill meaning --

8 (Simultaneous speakers.)

9 BY MS. BARVIR-BOONE:

10 Q That section about pifles?

11 A SB 118, yes.

12 Q Okay. SB 118, the section about pifles to

13 include -- to clarify the statutory definition of

14 assault weapons?

15 A Correct.

16 Q Do you know who wrote that portion of that

17 trailer bill?

18 A No.

19 Q No. Okay. How did you know that the DOJ

20 originally thought this policy might go through the

21 policy bill process with Senator Portatino as the

22 author?

23 A Through those conversations with the

24 Department of Finance and the Department of Justice.

25 But I'm not sure which of the parties told me.

1 Q Okay. That was my next question. Thank you.

2 Do you know how early you learned that the

3 DOJ's office policy might go through the policy bill

4 process with Portatino as the author?

5 A Sometime between that February to June.

6 Q Sometime before you wrote this email, I

7 suspect?

8 A Yes.

9 Q Okay. You then state, quote, "The DOJ wanted

10 to avoid a rapid large fire sale of these assault

11 modification gun parts by the people who see the

12 update to the ban coming."

13 Do you see that?

14 A Yes.

15 Q What did you mean by that?

16 A I provided the information that I got from

17 the DOJ and the Department of Finance as to why they

18 believe the trailer bill process should be used.

19 Q Your statement refers to the large fire sale

20 of these assault modification gun parts?

21 A Mm-hmm.

22 Q What is assault modification gun part?

23 A My recollection is that they are the pieces

24 of -- I don't know. I don't know what the right

25 terminology is, but the pieces of a gun that you put

1 together to make an assault weapon.

2 Q Is it something that you got from statute?

3 A This is information that I received in those
4 conversations with the Department of Justice and the
5 Department of Finance.

6 Q I know this feels repetitive.

7 A Of course.

8 Q How did you come to learn that DOJ wanted to
9 avoid a rapid large fire sale of assault modification
10 gun parts by the people who saw the update to the ban
11 coming?

12 A Through the conversations with the people
13 with the Department of Finance and the Department of
14 Justice.

15 Q Do you recall whether it was your
16 conversations with Ayres at the Department of Justice
17 or Edwards at the Department of Finance?

18 A I don't remember.

19 Q Okay. It could have been either or both?

20 A Yes.

21 Q Do you know whether the statement that DOJ
22 wanted to avoid a rapid large fire sale of these
23 assault modification gun parts by the people who saw
24 the update to the ban coming, do you know whether that
25 statement is true?


