I, Jason A. Davis, declare as follows:

1. I am an attorney licensed to practice law in the state of California. I am Of Counsel for the law firm Michel & Associates, P.C. (“MAPC”), attorneys of record for Plaintiffs-Appellants in this action. I have personal knowledge of the facts set forth herein and, if called and sworn as a witness, could and would testify competently thereto.

2. This declaration is submitted in support of Appellants’ Request for Judicial Notice, or Alternatively, Motion to Take Evidence, pursuant to California Rules of Court, rules 8.252(a) and 8.252(c), concerning documents obtained through a Public Records Act (PRA) request from the California Department of Justice (DOJ).

3. On July 1, 2024, I submitted a Public Records Act (PRA) request (DOJ No. 2024-01755) to the California Department of Justice, seeking records related to modifications or enhancements to the Dealer Record of Sale Entry System (DES). The request sought writings, as defined by Evidence Code section 250, including but not limited to: (a) enhancements to the DES to add a field for firearms that are neither rifles, shotguns, nor handguns, including those defined as “Other”; (b) notices to licensed California dealers about DES changes for such firearms; (c) notices to law enforcement about such firearms; and (d) the DES JIRA Log, all from October 1, 2019, to December 31, 2020.

4. The complete response, including the documents at issue in this motion, was not provided until April 15, 2025, well after the entry of judgment in the underlying action and just weeks before Appellants' brief in this appeal was due.

5. Attached as **Exhibit A** is a true and correct copy of the DOJ's response to PRA Request No. 2024-01755, dated April 15, 2025, issued by the Department of Justice Bureau of Firearms, signed by Sidney Villareal, Staff Services Manager I, on behalf of Attorney General Rob Bonta.

6. Attached as **Exhibit B** is a true and correct copy of a DES JIRA Log, dated April 15, 2025, covering entries created from October 1, 2019, to December 31, 2020, attached to and provided as part of the DOJ's April 15, 2025, response.

7. On October 11, 2022, during discovery in the underlying action, Appellants expressly requested from Respondent DOJ all documents related to DES enhancements from Respondents, including any and all entries into the JIRA database for DES field modifications dated or prepared on or after January 1, 2014, including but not limited to time logs, time estimates, or time billed.

8. Appellants similarly requested all documents dated or prepared on or after January 1, 2019, related to any entry into the JIRA database regarding "undefined firearm subtypes," a phrase regularly used by the parties in this litigation to refer to the

firearms at the heart of this dispute and which were defined as “any firearm that is neither a rifle, nor a shotgun, nor a handgun”

9. Despite these requests and the clearly defined dates covered by Appellants’ requests, Respondents failed to produce the documents now attached as Exhibit B, or any substantially similar records, depriving Appellants of critical evidence before trial.

10. Respondents did, however, respond to the above requests in May 2023, producing 26 pages of JIRA entries created in August and September 2021. These 26 pages did not include the pages received in response to PRA Request No. 2024-01755 (and marked as Exhibit B) or the relevant JIRA entries created in January and February 2020.

11. On June 19, 2024, in response to Appellants’ request that Respondents supplement their discovery responses pursuant to Code of Civil Procedure section 2031.050, Respondents provided boilerplate objections to the requests but nonetheless produced the same 26 pages of JIRA entries created in August and September 2021.


12. The withheld documents are relevant to this appeal because their existence demonstrates that the Respondents withheld evidence that could have altered the course of the litigation. Specifically, the DES JIRA Log (Ex. B) includes entries (e.g., DES-1577, DES-1580, DES-1585) indicating modifications to the DES to accommodate an “Other” gun type, which may

contradict Respondents' representations to the trial court about when they began to implement the needed DES changes.

13. The withholding of these documents unfairly prejudiced Appellants, preventing them from conducting further discovery on issues central to the case and from identifying potential witnesses, such as DOJ personnel directly responsible for work related to the relevant DES enhancement project(s).

14. The DOJ either inadvertently failed to produce these highly relevant documents in discovery, or worse, intentionally withheld them. Regardless, either scenario constitutes an exceptional circumstance justifying the Court's consideration of these documents on appeal, either through judicial notice of their existence under Evidence Code section 452, subdivisions (c) and (h), or as additional evidence under Code of Civil Procedure section 909.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct. Executed on May 21, 2025, at Mission Viejo, California.

Dear Jason Davis:

This letter is in response to your correspondence received by the California Department of Justice (Department) on July 1, 2024, requesting records under the Public Records Act. (Gov. Code, § 7920.000 et seq.) Specifically, you requested the following:

- 1. Any and all writings, as that term is defined in Evidence Code 250, that constitute, refer or relate to JIRA files on the Following topics:*
 - a. Any enhancement to the Dealer Record of Sale Entry System (DES) to add a field for firearms that are neither rifles, shotguns, nor handguns.*
 - b. Any enhancement to the Dealer Record of Sale Entry System (DES) to add a field for longguns that are neither rifles, shotguns, nor handguns.*
 - c. Any enhancement to the Dealer Record of Sale Entry System (DES) to add a field defined as "others".*
- 2. Any and all writings, as that term is defined in Evidence Code 250, that constitute, refer or relate to notices to licensed California dealers about changes in the Dealer Record of Sale Entry System (DES) for:*
 - a. Firearms that are neither rifles, shotguns, nor handguns*
 - b. Firearms that are neither rifles, shotguns, nor handguns.*

- c. Firearms that constitute an "other" type firearm.*
- 3. Any and all writings, as that term is defined in Evidence Code 250, that constitute, refer or relate to notices to law enforcement about:*
 - a. Firearms that are neither rifles, shotguns, nor handguns*
 - b. Firearms that are neither rifles, shotguns, nor handguns.*
 - c. Firearms that constitute an "other" type firearm.*
- 4. Any and all writings, as that term is defined in Evidence Code 250, that constitute, refer or relate to a copy of the Dealer Record of Sale Entry System JIRA Log.*

All four of these requests are limited to those responsive writings, as that term is defined in Evidence Code 250, from October 1, 2019 through December 31, 2020.

On August 16, 2024, the Department provided you a first installment of responsive records. With this letter, we are providing you with a second and final installment. The enclosed record has been redacted of information that is exempt through provisions of law that are expressly incorporated into the PRA. (Gov. Code, § 7927.705.)

The attorney work product exception protects the confidentiality of any writing that reflects an attorney's impressions, conclusions, opinions, legal research or legal theories that are maintained as confidential. (Code Civ. Proc., § 2018.030.) This confidentiality provision is incorporated into the PRA as an exemption from disclosure. (Gov. Code, § 7927.705; *County of Los Angeles v. Superior Court* (2000) 82 Cal.App.4th 819, 833.) Specifically, information that would disclose time and resources dedicated to active litigation is protected attorney work product that was redacted from the attached record. (*Los Angeles County Board of Supervisors v. Superior Court* (2016) 2 Cal.5th, 282, 297.)

Information that identifies specific firearms dealers has also been redacted. The Department keeps data regarding firearms sales and transfers as part of its general duty "to assist in the investigation of crime, the prosecution of civil actions by city attorneys . . . , the arrest and prosecution of criminals, and the recovery of lost, stolen, or found property." (Pen. Code, § 11106, subd. (a)(1).) California law limits with whom the Department can share much of this data to "officers referred to in [Penal Code section] 11105" and others for law

enforcement purposes as well as to researchers as detailed in Penal Code section 11106, subdivision (d.) By mandating disclosure under these specific circumstances, the Legislature has confirmed that the information maintained by the Department is confidential and not subject to disclosure to the public through the Public Records Act.

This completes our response to your request.




