**JOINT STIPULATION RE: VOLUNTARY
DISMISSAL WITHOUT PREJUDICE**

20 Plaintiffs and Defendants Ryan Beezley and Bob Beezley, JSD Supply, and Thunder
21 Guns, LLC, by and through their respective counsel of record, hereby stipulate as follows:

22 WHEREAS, Plaintiffs filed a complaint in the above-captioned action on June 17, 2021
23 naming multiple defendants, including Ryan Beezley and Bob Beezley, JSD Supply, and Thunder
24 Guns, LLC;

25 WHEREAS, Plaintiffs’ claims arise from a shooting that occurred on June 19, 2019,
26 alleging that Defendants are liable as possible manufacturers of the relevant firearm product(s);

27 WHEREAS, this action has been largely stayed pending resolution of a related criminal
28 matter due to the parties’ inability to access certain critical evidence;

WHEREAS, the undersigned parties have conferred and Defendants Ryan Beezley and

1 Bob Beezley, JSD Supply, and Thunder Guns, LLC have represented to Plaintiffs via sworn
2 declarations that prior to June 19, 2019, Ryan Beezley and Bob Beezley, JSD Supply, and
3 Thunder Guns, LLC never manufactured for sale any of firearm products relevant in this action to
4 the public;

5 WHEREAS, the undersigned parties have agreed to voluntary dismissal of all claims
6 against Defendants Ryan Beezley and Bob Beezley, JSD Supply, and Thunder Guns, LLC
7 without prejudice, with each side to bear its own costs, and with limited tolling of all relevant
8 statutes of limitation;

9 IT IS THEREFORE STIPULATED AND AGREED by the undersigned parties, subject to
10 the Court's approval, as follows:

11 All claims brought in this action against Defendants Ryan Beezley and Bob Beezley, JSD
12 Supply, and Thunder Guns, LLC are dismissed without prejudice, with each party to bear its own
13 costs. All statutes of limitation for all claims, cross-claims, or counterclaims which have been or
14 could have been brought in this action against Defendants Ryan Beezley and Bob Beezley, JSD
15 Supply, and Thunder Guns, LLC are tolled for one (1) year as of the date of this Order.

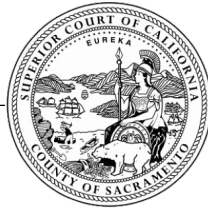
PROPOSED ORDER
