The Court, having read and considered the Parties’ joint stipulation regarding the briefing schedule and hearing date for the Parties’ Motions for Summary Judgment, ORDERS as follows:

1. The hearing on Defendants’ demurrer shall remain on June 9, 2026 at 9:00 a.m.
2. The Parties’ Motion for Summary Judgment briefing schedule is stayed until fourteen (14) days after the Court’s final ruling on the demurrer.
3. Defendants’ Combined Cross-Motion for Summary Judgment and Opposition to Plaintiffs’ Motion for Summary Judgment shall be due fourteen (14) days after the Court’s final

1 ruling on the demurrer.

2 4. Plaintiffs' Combined Opposition to Defendants' Cross-Motion for Summary
3 Judgment and Reply to Defendants' Opposition to Summary Judgment shall be due sixty (60)
4 days after the Court's final ruling on the demurrer.

5 5. Defendants' Reply to Plaintiffs' Opposition to Defendants' Cross-Motion for
6 Summary Judgment shall be due eighty-four (84) days after the Court's final ruling on the
7 demurrer.

8 6. The hearing on Plaintiffs' Motion for Summary Judgment and Defendants' Cross-
9 Motion for Summary Judgment that was scheduled for September 8, 2026 shall be taken off the
10 calendar.

11 7. The hearing on Plaintiffs' Motion for Summary Judgment and Defendants' Cross-
12 Motion for Summary Judgment shall be scheduled for the soonest available date at least ninety-
13 five (95) days after the Court's final ruling on the demurrer.
